Introduction

The State of Illinois provides local governments with both technical services and cash assistance through programs administered by many state agencies. More than 200 financial assistance programs administered by the state include grants for many purposes, such as: public library services for the blind and physically handicapped, soil and water conservation, housing, fire protection, museums, and drug enforcement. The state also shares revenue with local jurisdictions, which is used for a variety of programs at the discretion of the local governments. The state provides salary subsidies and bonuses to many local officials, including state's attorneys, assessment officers, county clerks, police officers, and probation officers.

In addition to financial aid, state agencies also provide various kinds of technical assistance. This includes training for local officials, answering inquiries, and providing services such as computerized data, group health insurance information, or provision of surplus property. This *Catalog* is a summary of more than 250 state financial and technical assistance programs provided to local governments in Illinois. It is intended to provide legislators and their staffs, community organizations, and local officials with the most comprehensive information on state assistance to local governments. This is the seventeenth edition of the *Catalog*.

FISCAL RESPONSIBILITY REPORT CARD/DATA COLLECTION

The Comptroller then uses the financial information and compiles data on annual revenue, expenditures, fund balances, and debt. The financial condition of local governments is annually summarized in the Fiscal Responsibility Report Card and Individual Data Summaries. ILLINOIS WIRELESS INFORMATION NETWORK (IWIN)

Objective: IWIN is one of the essential services that must be maintained at all times because it has direct public safety implications. IWIN is a wireless wide-area data network using Code Division Multiple Access (CDMA) technology (in a partnership between the State of Illinois, Verizon Wireless, and Motorola) to provide real-time, full-duplex mobile connectivity to its users who are members of state and local governments and law enforcement communities. Law enforcement officers have mobile units in their squad cars that allow instant access to a variety of mission-critical database applications from virtually anywhere in Illinois. The Illinois law enforcement community uses IWIN to gain access to the Law Enforcement Agency Data Service (LEADS), NCIC, NLETS, and Secretary of State databases. The network also provides users with car-to-car messaging, bar code and image capture and transfer, GPS mapping, and in-car paging capabilities. Agencies can also connect their users to their Computer Aided Dispatch (CAD) and Record Management Systems (RMS). IWIN is the largest statewide, public safety mobile data network in the country.

JOINT PURCHASING PROGRAM

SURPLUS PROPERTY DISTRIBUTION

Objective: Surplus property is comprised of three program sections: State Surplus, Federal Surplus (GSA), and Law Enforcement Support Office (LESO). These programs are charged with the administration and disposal of all surplus personal property generated by state agencies, boards, commissions, universities, and constitutional officeholders, and excess and surplus property no longer needed by the U.S. government. State surplus property, such as office equipment, computers, vehicles, and other equipment, is made available by priority to state government entities and units of local government at Surplus Property's Springfield warehouse. Units of local government may also use iBid, the state's online auction site, to dispose of their unneeded vehicles, equipment, etc., for a nominal fee.

Surplus Property also administers the distribution of federal surplus property under rules promulgated by the U.S. General Services Administration (GSA). Federal surplus property generally includes equipment such as vehicles, electronics, food service equipment, hand tools, outdoor equipment, etc. Federal surplus property is made available to units of local government at Surplus Property's Springfield warehouse, and is typically transferred to units of local government, communitybased health or human services organizations, etc., that are enrolled with Surplus Property.

Illinois law enforcement agencies (LEAs) are eligible for enrollment in a special equipment program, LESO, administered by Surplus Property. The U.S. Secretary of Defense is authorized by LESO to transfer personal property to federal and state agencies that is excess to the needs of the DoD and suitable for use by such agencies in law enforcement activities.

Eligibility: State agencies, boards, commissions, universities, and units of local government, including counties, townships, municipalities, nonprofit organizations, and schools.

ALL OUR KIDS EARLY CHILDHOOD NETWORK INITIATIVE

Objective: The provider will work with the Department to develop a local comprehensive early childhood service and support system to meet the needs of pregnant woman, children from birth to five years old, and their parents/caregivers. Our theory of change suggests that by working together across sectors we can improve the service system and this can result in greater synergistic outcomes for children and families. At the core of the work is the realization that program approaches to changing child and family outcomes alone will never be sufficient to create the population-level changes we most want. The objective is to focus on system change efforts. The purpose of the initiative is to improve the service delivery system so that families have greater access to highquality, well-coordinated, easily assessable and equitable services. This implies the majority of the work should focus on creating changes in the system (system outcomes), which in turn will lead to child and family outcomes rather than developing more programs or services that are directly targeting child and family outcomes. Historically, local health departments were designated (and funded to serve) as the lead agency for the AOK Network in its jurisdiction. Local health departments have a unique responsibility to assess needs, develop policy to address community problems, and assure that services are delivered to address those problems. Local health departments are certified by the Illinois Department of Public Health on the basis of their demonstrated ability to perform these core functions. Local health departments are also uniquely accountable to the public for the health of the entire community. Consequently, local health departments are best positioned to carry out this leadership role.

FAMILY CASE MANAGEMENT

CRIME SCENE SERVICES COMMAND

Objective: The Crime Scene Services Command (CSSC) provides crime scene services to state, county, and municipal law enforcement agencies throughout Illinois. ISP crime scene investigators (CSIs) respond to requests for assistance on crimes against persons 24 hours a day, 7 days a week. Agencies may request assistance with property crime scenes from 8:00 a.m. to 4:00 p.m., 7 days a week.

CSIs are trained and equipped to document crime scenes with digital photographs, video, digital surveying equipment, unmanned aerial vehicles, and terrestrial laser scanners. CSIs also identify, process, collect, and transport evidence to ISP forensic laboratories for analysis. Beyond scene documentation, blood stain pattern analysis and bullet trajectory reconstruction services are also provided by CSIs.

The CSSC also provides polygraph services. Currently, two examiners provide polygraph examinations for employment, administrative, and criminal investigations.

Seminars, workshops, and certified courses are offered on topics and subjects related to patrol and traffic functions, criminal investigation techniques, legal issues, management skills, drug and alcohol law enforcement and abuse prevention, community crime prevention, child safety strategies, officer safety, motor vehicle theft, and tactical responses. Programs are presented at both the Academy facility and at regional sites in cooperation with the Law Enforcement Training and Standards Board and its Mobile Training Units. RUSE BURGLARY TASK FORCE

Objective: The Ruse Burglary Task Force was started on September 1, 2012. It was created to address the growing number of ruse burglaries, aggravated home repair fraud scams, fortune-telling scams, home invasions, confidence crimes, and insurance scams being perpetrated by the Gypsy population against Illinois senior citizens. Gypsy criminal groups almost exclusively target the elderly, one of the most vulnerable classes in our society. They are usually found in their homes, making them very accessible targets. Social isolation is common with the elderly and they are eager to speak with people who approach them. They are willing to comply with "authority" figures, such as a person who alleges he is from the power company and needs to get into their houses. Because of their declining physical and mental condition, they are often not able to make proper identification or remember important details. Finally, many elderly persons have cash and other valuables in their homes readily available. The task force uses intelligence and proactive aggressive enforcement techniques with the goal of arrest and prosecution of Gypsy criminal groups, rather than obtaining

restitution. The task force maintains an automated Gypsy intelligence database, accessible to law enforcement agencies, of all known Gypsy names, photographs, and identifiers. The task force sponsors meetings of law enforcement officers to exchange information and keep abreast of current Gypsy criminal group activity. It also presents educational material to elderly citizens and other community groups designed to prevent them from becoming targets of Gypsy criminal groups.

All 2017 State-Local Program projects are funded at 75% state assistance for primary airports and 90% state assistance for general aviation airports (non-primary airports). Projects are then selected based on certain criteria and a formulated score, factoring in existing pavement conditions, increased local share contributions, staff engineering judgment of need, potential phasing of this project, and any additional mandates attached to the appropriation.

COMMERCE COMMISSION (ICC)

GRADE CROSSING PROTECTION

Objective: This program provides funding assistance for local jurisdictions to pay for safety improvements at highway-rail crossings. This includes the installation of automatic warning devices at highway-rail grade crossings and the construction/reconstruction of grade separation structures that reduce train/vehicle collisions, fatalities, and injuries at crossings. Each month, \$3.5 million in state motor fuel tax receipts is transferred from the Motor Fuel Tax (MFT) fund to the Grade Crossing Protection Fund (GCPF). This amount provides the GCPF with \$39 million annually to be used for safety improvements at highway-rail crossings on local roads and streets.

Money in the GCPF is administered by the ICC but appropriated to the Department of Transportation to assist local jurisdictions (counties, townships, and municipalities) in paying for safety improvements at highway-rail grade crossings, pedestrian-rail grade crossings, highway-rail bridges, and pedestrian-rail bridges, on local roads and streets only. In carrying out its mandated responsibility, the ICC orders improvements at public highway-rail grade crossings, pedestrian-rail grade crossings, highway-rail grade crossings, highway-rail bridges, and pedestrian-rail bridges that it determines to be in the interest of public safety.

The GCPF is typically used to help pay for the following types of projects:

- Warning Device Upgrades: Installation of automatic flashing light signals and gates at public grade crossings currently not equipped with automatic warning devices; installation of automatic flashing light signals and gates at public grade crossings currently equipped only with automatic flashing light signals; and signal circuitry improvements at public grade crossings currently equipped only with automatic warning devices.
- **Grade Separations**—New and Reconstructed: Construction, reconstruction, or repair of bridges carrying a local road or street over railroad tracks (overpass); and construction, reconstruction, or repair of bridges carrying railroad tracks over a local road or street (subway).
- **Grade Separations—Vertical Clearance Improvements:** Lowering the existing highway pavement surface under a railroad bridge to improve vertical clearance for motor vehicles.
- **Pedestrian Grade Separations:** Construction of a bridge to carry pedestrian/bicycle traffic over or under railroad tracks.
- **Interconnects:** Upgrading the circuitry at grade crossings where warning signals are connected to the adjacent traffic signals so that the two systems operate in a synchronized manner.

- **Highway Approaches:** Improvements to the portion of the public roadway directly adjacent to the crossing surface.
- **Connecting Roads:** Construction of a roadway between a closed crossing and an adjacent open, improved crossing.
- **Remote Monitoring Devices:** Sensor devices in the circuitry of grade crossing warning devices that immediately alert the railroad to any failures in warning device operations.
- **Crossing Closures:** Provide an incentive payment to local agencies for the voluntary closure of public highway-rail grade crossings.
- **Crossing Surface Renewals:** Up to \$2 million in assistance annually can be allocated for crossing surface improvements.

The cost of railroad crossing safety improvements varies substantially depending on the nature of the work undertaken. A standard installation of gates with automatic flashing light signals on a twolane road typically costs approximately \$200,000-\$300,000. Additional costs for road improvements could typically range from \$2,000 to \$100,000 depending on the road type and location. Grade separation structures are very costly. The GCPF has made contributions to pavement lowering (vertical clearance improvements) projects costing between \$35,000-\$4 million, and new underpass structures costing more than \$50 million. Bridges over railroads can cost from \$600,000 for a rural structure to \$40 million for a multi-lane, multi-railroad urban structure. Typically, the ICC authorizes contributions from GCPF that pay up to 60% of the cost for grade separation projects and 85% to 95% for grade crossing improvements, although ICC policy is to allocate no more than \$12 million from the GCPF to any individual project unless unusual circumstances warrant otherwise. When the numbers of crossing locations needing improvement are multiplied by project costs, the problem of allocating sufficient assistance from the GCPF becomes apparent.

HAZARDOUS MATERIALS SAFETY/RAIL

Objective: The Commission provides information to local governments on the proper response to hazardous material rail incidents or accidents. It also helps to reduce the number of these incidents by monitoring the operations of railroads in the state for the safe movement of hazardous materials. The Commission performs professional inspections of rail carrier equipment and records, and loading and unloading operations, for compliance with federal railroad hazardous materials regulations to provide safety for citizens, rail employees, and property by ensuring safe rail transportation of hazardous materials. It also conducts inspections at railroad yards, sidings, and interchange tracks; roll-by inspections at railroad terminals; and waybill inspections at railroad terminals and freight offices; and follows up on violations as required. The Commission investigates incidents/accidents involving derailed and/or leaking hazardous materials cars; acts as a liaison between railroad and emergency response personnel; advises local governments on the proper response to hazardous materials rail incidents/accidents; determines probable cause and investigates for hazardous materials violations; and coordinates with Illinois Emergency Management Agency inspectors in connection with radioactive materials inspection/escort procedures of shipments moving into or through Illinois.

NATURAL GAS PIPELINE SAFETY

Objective: The Commission's Pipeline Safety Section conducts on-site inspections of the 106 gas system operators (65 of which are municipal systems) in the state to determine compliance with all applicable federal and/or state pipeline safety regulations. The inspectors monitor the operator's records concerning inspection, operation, maintenance, emergency procedures, and construction. Inspectors conduct field inspections of the operator's facilities to verify compliance with regulations covering design, construction, operation, and maintenance of the pipeline facilities. Pipeline safety personnel conduct training seminars for small gas system operators. These seminars have resulted in more responsive compliance with safety requirements. Municipalities that operate a natural gas pipeline system are under the jurisdiction of the Commission's Pipeline Safety Program for safety-related issues. Pipeline safety personnel follow a schedule for the inspection of municipal systems, periodically provide training to municipal system personnel, and are always available to answer questions and provide assistance when needed.

OPERATION LIFE SAVER

RAILROAD OPERATING PRACTICES

Objective: The Commission performs complex inspections of railroad operating rules and practices to determine compliance with Federal Railroad Administration and State of Illinois safety standards; investigates the administration of federal alcohol and drug control programs, hours of service for railroad employees involved with the movement of trains, federal locomotive engineer certification standards, occupational safety conditions and reporting, and employee training and qualification; investigates railroad incidents/accidents; examine carrier records to determine that all reportable personal injuries and accidents have been properly reported; and investigates complaints from railroad employees or the general public regarding unsafe practices involving train operations. Local governments may obtain special inspections or investigations of complaints on signal conditions by written request.

RAILROAD SIGNAL SAFETY

ILLINOIS BOND BANK POOL

Objective: The Authority's Bond Bank Program combines the borrowing needs of multiple units of local government in its Pooled Bond Program. The Authority, operating as a conduit, purchases the local government securities (bonds) of the various units of local government and, in turn, issues its own obligations (tax-exempt revenue bonds) on the financial markets.

The pooling process allows local governments to realize savings that are achieved by sharing fixed costs and achieving economies of scale. These savings are both in terms of costs as well as through the streamlining of various procedures and related documents.

In addition, Authority pooled bond issues may be supported by the moral obligation of the state. Interest earned on the bonds is exempt from both state and federal income taxes. Both the state's moral obligation backing and the double tax-exempt status of the Authority's bonds serve to lower the overall borrowing rates of the local government participants.

Eligibility: Counties, municipalities, townships, and special districts: aviation authorities, fire protection, libraries, parks, sewer, and water.

LOCAL GOVERNMENT BOND PROGRAM

Objective: This program assists units of local government, including school districts, in financing capital improvement projects. Local government and school district bonds issued through the Authority are exempt from both federal and state income taxes. The Authority's approval process for local government bond projects is streamlined, requiring just one meeting for approval. The Authority state aid intercept enables the local government borrower to consent to the intercept of state aid payments to cover shortfalls in debt service payments, assuring that bondholders are paid in a timely manner.

This program also provides local government units with the opportunity to achieve interest cost savings, as the Authority state aid intercept acts as a credit enhancement. Furthermore, local government units have the ability to structure flexible loan repayment terms, e.g., fixed- or variable-rate financing, through the Authority.
