The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 96

Offered by Representative Gong-Gershowitz:

WHEREAS, The Illinois dentist community has over 300 endodontists; due to their unique skills, endodontists are considered dental experts; and

WHEREAS, In addition to diagnosing and treating tooth pain, endodontists perform root canals and handle dental emergencies with precision; despite the COVID-19 pandemic, they continued to work, thereby helping patients avoid emergency rooms and urgent care centers for dental care; to become endodontists, they have completed three years of specialized training beyond dental school; and

WHEREAS, In some cases, endodontists can save a decayed tooth by performing root canal treatment, diagnosing tooth pain, and performing other dental procedures; and

WHEREAS, Endodontists have exceptional hand-eye coordination and can perform complex dental treatments with incredible precision; they employ the most advanced technology to save patients' teeth and relieve their pain; no one can save a patient's natural teeth like endodontists; and

WHEREAS, Endodontists aim to preserve the natural teeth of their patients whenever possible; however, they will consider all treatment options to determine what is best for the patient's particular case; and

WHEREAS, An endodontist performs 25 root canal treatments per week on average; specialized treatment results in a faster healing rate and the best outcome for patients; therefore, dentists and endodontists often collaborate in order to ensure that each patient's issue with their teeth is handled by the best member of the dental team; and

WHEREAS, Among the most important aspects of a person's health are their teeth, which provide access to nutrition, provide a sign of good health, and are used to express emotions; poor oral hygiene can lead to other health issues; it is important to keep one's gums, teeth, and mouth in good health by visiting the dentist regularly, flossing, brushing thoroughly twice a day, and avoiding foods and habits that can lead to cavities; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare May 2023 as Save Your Tooth Month, recognize the endodontists who are dedicated to saving patients' natural teeth, and encourage citizens of Illinois to practice good oral hygiene to save their natural teeth.

HOUSE RESOLUTION 103

Offered by Representative Lilly:

WHEREAS, The substance use and opioid use crises in Illinois are responsible for historically high rates of overdoses and overdose-related fatalities; and

WHEREAS, According to the State's own opioid data, use and misuse of opioids in Illinois also continues to have substantial associated public health consequences, including increased rates of infectious diseases such as hepatitis C and HIV, lost productivity in the workplace, crime, neonatal abstinence syndrome, and homelessness; and

WHEREAS, Substance use and opioid use are often detrimental to a person's mental health; access to innovative and evidence-based treatments that address substance use and opioid use can improve a patient's overall mental health; and

WHEREAS, Historically disadvantaged groups face additional barriers to treatment for substance use and opioid use disorders, such as a lack of affordable therapy, stigma, and unequal access to mental health treatment; mental health equity should focus on access to quality and appropriate healthcare services; and

WHEREAS, The purpose of many federal programs is to provide resources to states for increasing access to FDA-approved medications for the treatment of substance use and opioid use disorder and for supporting the continuum of prevention, harm reduction, treatment, and recovery support services for opioid use disorder and other substance use disorders; and

WHEREAS, A prescription digital therapeutic, which utilizes both cognitive behavioral therapy and contingency management in the product to treat substance use disorder or opioid use disorder, is approved, cleared, or classified by the Food and Drug Administration under section 510(k), 513(f), or 515 of the Federal Food, Drug, and Cosmetic Act and requires a prescription under section 801.109 of title 21 of the Code of Federal Regulations (or any successor regulation); and

WHEREAS, Prescription digital therapeutics have the potential to significantly improve health care delivery to underserved populations because they transcend care access limitations due to geography, socioeconomic status, trust of traditional institutions, and more; and

WHEREAS, Clinical studies have shown significantly greater odds of stimulant and opioid abstinence during treatment if treatment as usual is combined with an FDA-authorized PDT that has both cognitive behavioral therapy and contingency management; and

WHEREAS, A 2018 study demonstrated that when a Community Reinforcement Approach and Contingency Management are administered together then a patient is 2.84 times more likely to remain abstinent at the end of the treatment than those in other programs; and

WHEREAS, The White House's Office of National Drug Control Policy recently released its 2022 National Drug Control Strategy document; specifically, the document points to prescription digital therapeutics and how these tools could help increase services for a wide array of patients; and

WHEREAS, Federally-funded programs help many states to fund access to FDA-authorized PDTs for patients and providers; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Department of Human Services and the Governor's Opioid Overdose Prevention and Recovery Steering Committee to closely consider funding FDA-authorized PDTs to help patients who are struggling with substance use and opioid use disorders; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Secretary of the Illinois Department of Human Services.

WHEREAS, It is appropriate to remember the many sacrifices and contributions to the cause of freedom made by the outstanding men and women who served in the United States Armed Forces; and

WHEREAS, The freedom we enjoy in the United States of America and the State of Illinois is owed to those who made the ultimate sacrifice for our nation and State; and

WHEREAS, Cpl. Tommy Neal Miller was born on July 19, 1949 and was raised in Meadowbrook near Bethalto in Madison County; and

WHEREAS, Cpl. Miller enlisted in the United States Marine Corps and served during the Vietnam War; he began his tour of duty on June 10, 1968; his military specialty was mortarman, and he was attached to Echo Company, Second Battalion, Fourth Marines, Third Marine Division; and

WHEREAS, While serving as a radio operator on the morning of February 25, 1969 at Fire Support Base Russell in Quang Tri Province in South Vietnam, under assault by a large North Vietnamese Army sappers unit, Cpl. Miller unhesitatingly maneuvered across the fire-swept terrain in search of an undamaged radio; after locating operable equipment, he again exposed himself to hostile fire to assist the commanding officer with restoring communications; he then went to the aid of his fellow Marines to free them from

entrapment in debris; as he attempted to free his comrades, he was mortally wounded by fragments from an enemy grenade; and

WHEREAS, Cpl. Miller's heroic and timely actions inspired all who observed him and contributed greatly to repelling the enemy's assault; and

WHEREAS, Cpl. Miller's commendations include the Bronze Star Medal with Combat "V", the Purple Heart, the Combat Action Ribbon, the National Defense Service Medal, the Vietnam Campaign Medal, the Vietnam Service Medal, the Marine Corps Presidential Unit Citation, the Vietnam Gallantry Cross, the Marine Corps Good Conduct Medal, and the Marine Corps Expeditionary Medal; and

WHEREAS, Cpl. Miller is honored on the Vietnam Veterans Memorial in Washington, DC; his name is inscribed at VVM Wall, Panel 31w, Line 53; and

WHEREAS, Like so many who gave the ultimate sacrifice and gave up many years of their lives, Cpl. Miller will forever be 19; and

WHEREAS, Cpl. Miller is loved and missed by his family, friends, and Marine brothers; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we designate Illinois Route 140 as it travels through Meadowbrook as the "Cpl. Tommy N. Miller Memorial Highway"; and be it further
