Response - The Loves Park Police Department received 14 WatchGuard Video 4RE squad car cameras

(2) The number of cameras actually installed in the Law Enforcement Agency vehicles;

Response - All 14 cameras were installed in our patrol vehicles

(3) A brief description of the review process used by supervisors within the Law Enforcement Agency;

Response - by our policy the supervisors are the only people authorized to review video. They review any reponse to resistance (use of force) or vehicle pursuit for compliance with our standard operating proecedures. They may also review any video where they are handling an informal inquiry into an officer, as assigned by the deputy chiefs or chief.

(4) A list of any cases in which in-car video recordings were used;

Response - see attached spreadsheet. We do not have an automated system to retrieve dispositions from the courts, so we are unable to provide that data.

(5) Any other information relevant to the adminstration of the program;

Response - this has been a very successful grant for us. We were able to purchase and install cameras in every one of our front line patrol vehicles. All incidents are now on video and have helped with many criminal cases.
