In accordance with the provisions of 38 CFR Section 59.70, the Illinois Department of Veterans' Affairs respectfully requests conditional approval of grant application **FAI 17-051** in the amount of \$197,047,500 (estimated total project costs \$230,000,000), for Renovation: Emergency Campus Reconstruction, at the Illinois Veterans' Home, Quincy, Illinois. The State will meet all requirements for this grant not later than 180 calendar days after the date of conditional approval. We understand that if a State that has obtained conditional approval for a project does not meet all of the requirements within 180 calendar days after the date of conditional approval, the Secretary will rescind the conditional approval and the project will be ineligible for a grant for the rest of that fiscal year.


