HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 91

Offered by Representative Stava-Murray:

WHEREAS, International Women's Day commemorates the global, centuries-long struggle of women to participate fully and equitably in society; and

WHEREAS, Women's Day first emerged as the result of various labor and suffrage movements in North America and Europe in the early 20th century; and

WHEREAS, The United Nations celebrated its first official International Women's Day on March 8, 1975 during International Women's Year; and

WHEREAS, Gender equality is a fundamental human right, and women's full empowerment and participation is integral to solving society's most threatening social, economic, and political problems; and

WHEREAS, International Women's Day is intended to focus the global community's attention on accelerating gender parity; and

WHEREAS, The theme of this year's International Women's Day, Embrace Equity, seeks to get the world talking about why equal opportunities are no longer enough and can in fact be exclusionary, rather than inclusive; and

WHEREAS, The health disparities that women face have been exacerbated by the COVID-19 pandemic; and

WHEREAS, Healthy women are the backbone of a thriving, stable, and resilient society; and

WHEREAS, International Women's Day is an opportune time to raise awareness of the inequity in women's health and begin efforts to improve such inequities while encouraging all women to prioritize their health; and

WHEREAS, March 8th of each year is recognized as International Women's Day by countries around the world to celebrate the past, present, and future achievements of women as well as the obstacles that women continue to face in their struggle for equal rights and gender equality; and

WHEREAS, International Women's Day is a time to reflect on the progress we have made in the economic, social, and political achievements of women and to reaffirm our commitment to pursue strategies that guarantee the basic human rights of women and girls both statewide and globally, to promote meaningful and significant participation of women in all facets of our society, to encourage equitable access to and healthcare for all women and girls, and to support policy initiatives that seek to achieve gender parity and empower all women; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare March 8, 2023 as "International Women's Day" in the State of Illinois in order to reflect on the progress made thus far in women's rights; and be it further

RESOLVED, That we reaffirm the State's commitment to pursue strategies that guarantee the basic human rights of women and girls, to promote meaningful and significant participation of women in all aspects of our society, to encourage equitable access to and healthcare for all women and girls, and to support policy initiatives that seek to achieve gender parity and empower all women.

HOUSE RESOLUTION 92

Offered by Representative Keicher:

WHEREAS, Prescribed fire provides multiple ecological, economic, and cultural benefits to the State of Illinois; and

WHEREAS, Prescribed fire has been practiced for thousands of years and was a primary tool used by Indigenous peoples to attract game, to stimulate a rich ground layer of plants for harvesting, and to keep woodlands and grasslands open and easy to traverse; and

WHEREAS, Prescribed fire is a traditional land management practice and public safety tool that helps prevent and lessen the severity of wildfires; and

WHEREAS, Prescribed fire is a valuable tool used by forest, prairie, and wetland landowners and managers in reducing hazardous fuels, reducing the risk of destructive wildfires, preparing sites for both natural and artificial forest regeneration, improving access to and the appearance of land, and controlling detrimental insects and forest diseases; and

WHEREAS, Prescribed fire is an effective natural tool for controlling invasive species; and

WHEREAS, Prescribed fire is one of the most important land management practices in maintaining and restoring healthy landscapes, but only approximately six percent of conservation lands in Illinois are currently being managed with prescribed fire; and

WHEREAS, Prescribed fire is used to restore and maintain fire-dependent ecosystems and to manage wildlife habitat for many species; it is a vital tool to maintain economic, biological, and aesthetic resources across Illinois; and

WHEREAS, The Illinois Prescribed Fire Council is an organization of both public and private partners with a mission to promote the safe and continued use of prescribed fire on the Illinois landscape; and

WHEREAS, The Illinois General Assembly passed the Illinois Prescribed Burning Act in 2007, defining prescribed fire as "the planned application of fire to naturally occurring vegetative fuels under specified environmental conditions and following appropriate precautionary measures, which causes the fire to be confined to a predetermined area and accomplish the planned land management objectives."; and

WHEREAS, Prescribed fire helps keep Illinois grasslands and forests healthy, which, in return, provides ecological services such as clean air and clean water and contributes to the quality of life of the State's citizens and to local economies; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare April of 2023 as "Prescribed Burning Awareness Month" in the State of Illinois; and be it further

RESOLVED, That we support the appropriate and continued use of prescribed fire in Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Illinois Prescribed Fire Council as a symbol of our respect and esteem.

HOUSE JOINT RESOLUTION 20

Offered by Representative Gong-Gershowitz:

WHEREAS, In 1972, the Ninety-second Congress of the United States of America, at its Second Session, in both houses, by a constitutional majority of two-thirds, adopted the following proposition to amend the Constitution of the United States of America:

"JOINT RESOLUTION RESOLVED BY THE HOUSE OF REPRESENTATIVES AND SENATE OF THE UNITED STATES OF AMERICA IN CONGRESS ASSEMBLED (TWO-THIRDS OF EACH HOUSE CONCURRING THEREIN), That the following article is proposed as an amendment to the Constitution of the United States, which shall be valid to all intents and purposes as a part of the Constitution when ratified by the legislatures of three-fourths of the several States within seven years from the date of its submission by the Congress:

"ARTICLE _____

Section 1. Equality of rights under the law shall not be denied or abridged by the United States or by any State on account of sex.

Section 2. The Congress shall have the power to enforce, by appropriate legislation, the provisions of this article.

Section 3. This amendment shall take effect two years after the date of ratification.""; and

WHEREAS, Article V of the Constitution of the United States sets forth a two-step amending procedure; and

WHEREAS, The first step of the Article V amending procedure is proposal of an amendment either by two-thirds vote of both houses of Congress or by a convention called by application of two-thirds of the States; and

WHEREAS, The second and final step of the Article V amending procedure is ratification of an amendment by three-fourths of the States; and

WHEREAS, The Constitution of the United States does not limit the time for States to ratify an amendment; and

WHEREAS, The time limit within the internal resolution used by Congress in 1972 to propose the Equal Rights Amendment is, thus, without force or effect; and

WHEREAS, The so-called Madison Amendment, relating to Compensation of Members of Congress, is the Twenty-Seventh Amendment to the Constitution of the United States; and

WHEREAS, In 1789, by two-thirds vote of each house of the First Congress, the Madison Amendment completed the proposal step of Article V; and

WHEREAS, Approximately 203 years later, the Madison Amendment completed the ratification step of Article V through ratification by three-fourths of the States; and

WHEREAS, In 1992, having met the requirements of Article V, the Madison Amendment was published and certified by the Administration of President George H.W. Bush as the Twenty-Seventh Amendment to the Constitution of the United States; and

WHEREAS, Following publication of the Madison Amendment, Congress affirmed the Madison Amendment as the Twenty-Seventh Amendment to the Constitution of the United States; and

WHEREAS, As of January 27, 2020, three-fourths of the States have ratified the Equal Rights Amendment; and

WHEREAS, In contrast to the Madison Amendment which took 203 years to ratify, the Equal Rights Amendment took a mere 48 years to ratify; and

WHEREAS, The Equal Rights Amendment now meets the requirements of Article V of the Constitution of the United States to be added as the Twenty-Eighth Amendment; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the General Assembly urges the Administration of President Joseph R. Biden, Jr. to publish and certify without delay the Equal Rights Amendment as the Twenty-Eighth Amendment to the Constitution of the United States; and be it further

RESOLVED, That the General Assembly urges the Congress of the United States to pass a joint resolution, affirming the Equal Rights Amendment as the Twenty-Eighth Amendment to the Constitution of the United States; and be it further

RESOLVED, That the General Assembly calls on other States to join in this action by passing the same or similar resolutions; and be it further

RESOLVED, That suitable copies of this resolution be transmitted to the President and Vice President of the United States, to Members of the United States Congress, and to the Archivist of the United States.
