WHEREAS, The Illinois Court Reporters Association (ILCRA) is the sole state-wide association of freelance and official court reporters in Illinois, with professional membership exclusively comprised of licensed certified shorthand reporters (CSRs), individuals who are highly trained and skilled and ethically bound to write in real time each spoken word spoken at hearings, trials, arbitrations, and depositions; and

WHEREAS, Illinois licensed certified shorthand reporters (stenographers) are the only professionals in Illinois for whom the title court reporter is reserved by state statute; and

WHEREAS, Court reporters write shorthand at 225 words a minute, and often much faster, to create the verbatim record upon which the courts and counsel rely as the gold standard of transcripts of proceedings and from which discrete case law and citations derive; and

WHEREAS, Court reporters write each word spoken at legal proceedings in Illinois using phonetic alphabetic keyboards on stenographic machines that store the shorthand verbatim notes on redundant electronic text backup so that the courts, counsel, litigants, and defendants can rest assured that the accurate, full record of proceedings is safe and secure not only for transcript production but also from the dangers of the testimony being altered, publicly disseminated, or entirely lost through the vulnerabilities of unlicensed audio recorder operators who do not possess the inimitable skills of certified shorthand reporters; and

WHEREAS, Illinois shorthand reporters and real-time captioners provide Communication Access Realtime Translation (CART) by captioning for attorneys, litigants, defendants, jurors, and the public at legal proceedings, business meetings, educational classes and lectures, sporting events, and arts performances for many Illinoisans who are deaf or hard-of-hearing, have auditory processing disabilities, or for whom English is not their first language; and

WHEREAS, Stenographers and captioners produce a reliably accurate and complete record of each spoken word and deserve the public's confidence earned by the court reporters' position of neutrality and adherence to confidentiality and ethics guidelines necessitated by the CSRs' role as an officer of the court; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare February 3-10, 2024 as "Court Reporting and Captioning Week" in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Illinois Court Reporters Association as a symbol of our respect and esteem.

HOUSE RESOLUTION 625

Offered by Representative Harper:

WHEREAS, Farming as a family-owned and independent business has been an important part of the social and economic development of Illinois and the United States; and

WHEREAS, Black farmers in America have had a long struggle to own land and operate independently; for more than a century after emancipation and the ratification of the 13th Amendment that abolished slavery, various economic and social barriers were discriminatorily applied towards Black farmers, and the few existing civil rights laws were rarely enforced; and

WHEREAS, Pembroke Township, founded by self-emancipated, escaped enslaved people, was once home to the largest community of Black farmers in the north; and

WHEREAS, In 1920, Illinois had 892 Black farmers, and African Americans owned 14 percent of the nation's farmland; and

WHEREAS, According to the U.S. Department of Agriculture's National Statistics Service, as of April 2019, Illinois had 72,000 farms, covering 27 million acres, which is approximately 75% of the State's total land area; and

WHEREAS, As of the 2017 USDA Agricultural Census, there were 188 individually Black-owned farms, which are a combined 40,412 acres; out of the 116,417 agricultural producers in Illinois, 267 are Black; and

WHEREAS, As farming has become a big business, it has become one of the least diverse business sectors in our State, and the pressure to consolidate has reduced the ranks of family and independent farmers for the past century; and

WHEREAS, The scarcity of African American farmers stems from the troubled history of the U.S.; for sharecroppers, farming was associated with the poverty and the backbreaking labor of slavery; for those who owned land, unequal treatment made it difficult to retain property and earn a living, and racial discrimination played a major role in driving Black farmers off of their land; as recently as the mid-1990s, Black farmers who agreed to sell crops would routinely be offered lower prices at market than white farmers for equivalent products; and

WHEREAS, In a landmark legal settlement, the U.S. Department of Agriculture acknowledged that it had abused Black farmers for generations when agents approved only a fraction of financing requests, delayed loans until after the planting season, and withheld other key payments; and

WHEREAS, Movements in Illinois and across the country have fought to rectify historic discrimination against Black farmers and to develop interest in farming in young people and have worked to innovate in the farming space, including the development of Black-oriented urban agriculture, vertical farming, and microfarms in order to deliver fresher and healthier foods to communities and consumers in need of better food choices; and

WHEREAS, Black farmers can play a leading role in building local healthy food systems and creating regional networks of jobs, food, agricultural goods, and related opportunities; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare April 1 through April 6, 2024 as Black Farmers Week in the State of Illinois; and be it further

RESOLVED, That we encourage the people of Illinois and their representatives in government to learn about the history of Black farming communities and the contributions made by African Americans to agriculture in the United States; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Illinois Department of Agriculture and the National Black Farmers Association.

HOUSE RESOLUTION 628

Offered by Representative Blair-Sherlock:

WHEREAS, In May 1921, Washington D.C. hosted a national convention for amity between the races; it was a multi-racial interfaith gathering where for three days thousands of people assembled in the first ever convention for amity between the Black and white races; and

WHEREAS, Work continues towards achieving peace and unity to reach the vision of our nation, E Pluribus Unum "Out of many, one"; and

WHEREAS, The greatest asset of the State of Illinois is its people; and

WHEREAS, The State of Illinois is comprised of multicultural, multiethnic, and multi-racial residents; and

WHEREAS, A large number of Illinois residents, 39.8% or approximately 5,600,000 people, identify as Black, Hispanic, Asian American, or multi-racial; and

RESOLVED, That we invite communities across the United States of America to join in introspection and reflection on the beauty and richness of the diverse peoples of this great nation while reaching out with a spirit of amity toward one another on Race Amity Day.

HOUSE RESOLUTION 630

Offered by Representative Meier:

WHEREAS, Soil is an essential natural resource, and Illinois farmers and professionals play a critical role in managing Illinois soil and water resources; and

WHEREAS, The Natural Resources Conservation Service (NRCS) of the United States Department of Agriculture (USDA) defines soil health as the continued capacity of soil to function as a vital living ecosystem that sustains plants, animals, and humans; and

WHEREAS, The implementation of soil health principles across the Illinois landscape is not new but has only recently been recognized as an urgent part of the need to prevent soil degradation, return organic resources to the soil, or composting, protect groundwater used for drinking water, and combat climate change; the degradation of soil can be rapid, while the formation and regeneration processes can be very slow; and

WHEREAS, The protection of Illinois soils is essential to long-term prosperity and sustainability of the soil and water resources of our State, counties, and cities, and the six basic principles of soil health necessary for that protection are to:

(1) minimize soil disturbance and external inputs, including reduced tillage and using compost as a beneficial product to increase soil organic matter;

(2) maximize plant and microbial diversity;

(3) maintain the presence of living roots;

(4) keep the soil covered, including with cover crops and crop residue, to armor the soil;

(5) integrate animals into land management, including grazing animals, birds, beneficial insects, or keystone species, such as earthworms; and

(6) incorporate the context of local conditions in decision-making, including for example soil type, topography, and time of year; and

WHEREAS, Soil health principles and the associated voluntary practices of no-till, cover crops, nutrient management plans, and longer crop rotations enhance the ability of farmers to meet the non-point source pollution goals for nitrate-nitrogen and phosphorus; it is essential to reduce the amount of nutrients flowing off of farm fields and into our watersheds; with these reduced nutrient losses from agriculture lands, which are detailed in the Illinois Nutrient Loss Reduction Strategy (NLRs), farmers will be able to meet desired outcomes as outlined by the Mississippi River Basin Hypoxia Task Force for the Gulf of Mexico; and

WHEREAS, Soil health principles provide for the reduction of carbon dioxide in the atmosphere through the sequestration of carbon within the upper reaches of the soil profile; this carbon mitigation

improves the organic matter content in the soil and provides a stable biome for soil organisms, improves nutrient transfer from soil to root, and increases water infiltration and water-holding capacity; and

WHEREAS, Despite soil's importance to human health, the environment, nutrition and food, feed, fiber, and fuel production, there is little public awareness of the importance of soil protection; and

WHEREAS, Illinois soils are some of the best in the world, having the ability to sink carbon and reverse climate change, grow nutritious food for Illinois communities, and keep waterways clean; and

WHEREAS, It is imperative that the State of Illinois actively raise awareness on the importance of soil health and promote its stewardship to safeguard this resource for future generations of Illinois citizens; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare March 3 through March 9, 2024 as Illinois Soil Health Week in the State of Illinois; and be it further

RESOLVED, That we encourage the celebration of Soil Health Week and its related activities to increase the awareness of Illinois farmers, eaters, and those involved in agribusiness of the importance of the air and water quality environment for all citizens of this State; and be it further
