**Firearm Owners Identification Card Act – Report of Court Decisions**  
**430 ILCS 65/11(c)**

**Petitions for Relief Brought Under 430 ILCS 65/10**

In 106 relevant cases, the petitioner sought relief from the relevant firearm prohibition and/or an order directing ISP to issue a FOID card under the provisions of 430 ILCS 65/10, although several were incorrectly styled as complaints for administrative review. Of the Section 10 cases, the court denied or dismissed the petitioner's request for issuance of a FOID card in 59 instances. One appeal by Plaintiff is still pending.

*Enrique Amezcua v. State's Attorney of Will County, Illinois* -- Enrique Amezcua was convicted of Domestic Battery on July 15, 2011. His FOID card was revoked as issuance is contrary to federal law. Mr. Amezcua filed a Petition in Will County seeking relief. On November 23, 2022, Will County denied relief. ISP decision upheld.

*Anthony J. Ard v. Illinois State Police, Firearm Service Bureau* -- Anthony J. Ard was convicted of Manufacture/Deliver a Controlled Substance on October 13, 1988; and Manufacture/Deliver Cannabis and Possession of Cannabis on January 28, 2016. His FOID card was denied as issuance is contrary to federal law. Mr. Ard filed a Complaint in Cook County seeking relief. On November 3, 2022, Cook County dismissed the case for want of prosecution. ISP decision upheld.

*Denise Arnold v. Illinois State Police (Firearms Services)* -- Denise Arnold was convicted of an unknown offense. Her FOID card was denied as issuance is contrary to federal law. Ms. Arnold filed a Complaint in Cook County seeking relief. On October 25, 2022, the case was dismissed for lack of subject-matter jurisdiction. ISP decision upheld.

*Daniel Awkerman v. Department of Illinois State Police* -- Daniel Awkerman was convicted of Conspiracy to Commit Cannabis Trafficking on January 19, 2012. His FOID card application was denied as issuance is contrary to federal law. Mr. Awkerman filed a Petition in Lake County seeking relief. ISP decision upheld. Mr. Awkerman filed an appeal which is still pending.

*Richard Beavers v. State of IL Police, Kane County State's Attorney* -- Richard Beavers was convicted of Theft/Deception on January 25, 2007; Deceptive Practice on September 25, 2005; Domestic Battery on May 22, 1995; and Burglary on March 8, 1988. His FOID card application was denied as issuance is contrary to federal law. Mr. Beavers filed a Summons in Administrative Review and Petition in Kane County seeking relief. On February 2, 2022, Mr. Beaver's Petition was denied. ISP decision upheld.

*Richard Beavers v. Illinois State Police, State of IL* -- Richard Beavers filed a Petition to reconsider and validate his FOID card. Mr. Beavers filed a Petition in Kane County seeking relief. On August 23, 2022, the case was dismissed without prejudice. ISP decision upheld.

*Olen Bell v. Illinois State Police* -- Olen Dwayne Bell, Jr. was convicted of Theft/Deception on March 30, 2004; and Possession of a Controlled Substance on January 4, 1994. His FOID card application was denied as issuance is contrary to federal law. Mr. Bell filed a complaint for Administrative Review in Winnebago County seeking relief. On October 3, 2022, the case was dismissed for want of prosecution. ISP decision upheld.

*Robert Blangiardo v. Lake County State's Attorney and Illinois State Police* -- Robert Blangiardo was convicted of Theft on December 3, 1992; and Manufacture/Deliver Cannabis on October 29, 1992. His FOID card application was denied as issuance is contrary to federal law. Mr. Blangiardo filed a Summons in Administrative Review and Petition in Lake County seeking relief. On February 2, 2022, the case was dismissed. [ISP decision upheld.](#)

*Andrew P. Bratko v. Brendan F. Kelly, Illinois State Police* -- Andrew P. Bratko was convicted of Possession of a Controlled Substance on June 22, 2012; Knowingly Damage Property on March 2, 2012; and Possession of a Controlled Substance on March 13, 2004. His FOID card application was denied as issuance is contrary to federal law. Mr. Bratko filed a Petition in DuPage County seeking relief. On February 23, 2022, DuPage county denied relief. [ISP decision upheld.](#)

*Ronald D. Brazier, Jr. v. Brendan F. Kelly, The Department of Illinois State Police, James W. Glasgow Will County States Attorney* -- Ronald D. Brazier, Jr. was the subject of an Order of Protection entered on July 7, 2021. His FOID card was revoked as issuance is contrary to federal law. The Order of Protection was vacated on July 22, 2021, and the original order did not require his FOID card to be revoked by ISP. Mr. Brazier filed a Complaint in Will County seeking relief. On June 27, 2022, the case was dismissed with prejudice. [ISP decision upheld.](#)

*James E. Byrum v. Illinois State Police* -- James E. Byrum was admitted to a mental health facility in 2017. His FOID card was revoked as issuance is contrary to federal law. Mr. Byrum alleges violations of Due Process and Right to Bear Arms and that his Illinois State Constitutional rights were violated. Mr. Byrum filed a Complaint in Cumberland County seeking relief. On November 22, 2022, the case was dismissed with prejudice. [ISP decision upheld.](#)

*Brandon A. Cabaniss v. Illinois State Police, Firearms Service Bureau* -- Brandon A. Cabaniss was arrested for Domestic Battery on March 9, 2020. His FOID card was revoked as issuance is contrary to federal law. Mr. Cabaniss provided a certified statement of conviction/disposition the case was nolle prosequi on September 4, 2020. Mr. Cabaniss filed a Complaint in Cook County seeking relief. On February 1, 2022, the case was dismissed without prejudice. - [ISP decision upheld.](#)

*Shalet Carroll v. Fayette County State's Attorney* -- Shalet Carroll was convicted of Retail Theft on May 14, 2007. Her FOID card application was denied as issuance is contrary to federal law. Ms. Carroll filed a Petition in Fayette County seeking relief. On November 14, 2022, the case was dismissed for lack of subject matter jurisdiction. [ISP decision upheld.](#)

*Darren Gregory Case v. Andrew Killian, State's Attorney of Ford County and Leo P. Schmitz, Director of Illinois State Police* -- Darren Gregory Case was convicted of Driving under the Influence of Alcohol on May 10, 2005; and on March 12, 1993. His FOID card application was denied as issuance is contrary to federal law. Mr. Case filed a Complaint in Ford County seeking relief. On November 1, 2022, the case was dismissed. [ISP decision upheld.](#)

*Patrick L. Coleman v. Illinois State Police Firearms Bureau* -- Patrick L. Coleman was convicted of Aggravated Battery on June 29, 1987. His FOID card application was denied as issuance is contrary to federal law. Mr. Coleman filed a Summons and in Lake County seeking relief. On October 3, 2022, Lake County denied relief. [ISP decision upheld.](#)

*James Cowart v. State's Attorney of Lake County, Illinois* -- James Cowart was convicted of

Domestic Battery on April 13, 2000. His FOID card application was denied as issuance is contrary to federal law. Mr. Cowart filed a Petition in Lake County seeking relief. On April 1, 2022, the case was dismissed without prejudice. ISP decision upheld.

*Steven Douglas v. People of the State of Illinois, Illinois State Police* -- Steven Douglas was convicted of Possession of a Controlled Substance in 1995, and Bad Check >\$150 (2 counts) in 1993. His FOID card application was denied as issuance is contrary to federal law. Mr. Douglas filed a Petition in Ford County seeking relief. On April 11, 2022, the case was dismissed. ISP decision upheld.

*Philip Galanti v. Kimberly M. Foxx, State's Attorney of Cook County and Brendan F. Kelly, Director of Illinois State Police* -- Philip Galanti was convicted of Unlawful Use of a Weapon on July 11, 1991. His FOID card application was denied as issuance is contrary to federal law. Mr. Galanti filed a Petition in Cook County seeking relief. On January 13, 2022, the case was dismissed for want of prosecution. ISP decision upheld.

*Evan Galvin v. Will County State's Attorney's Office* -- Evan Galvin was convicted of Possession of a Controlled Substance with Intent to Deliver on February 5, 2002. His FOID card application was denied as issuance is contrary to federal law. Mr. Galvin filed a Petition in Will County seeking relief. On October 21, 2022, Will County denied relief. ISP decision upheld.

*Roderick V. Gardiner II v. Illinois State Police* -- Roderick V. Gardiner II was convicted of an unknown offense. His FOID card was revoked as issuance is contrary to federal law. Mr. Gardiner filed a Complaint in Cook County seeking relief. On October 19, 2022, the case was dismissed for want of prosecution. ISP decision upheld.

*Timothy L. Hall v. Randolph County State's Attorney, Illinois State Police* -- Timothy L. Hall was convicted of Knowingly Damaging Property on October 15, 2001. An order to seal Mr. Hall's conviction was entered on June 20, 2020. His FOID card application was denied as issuance is contrary to federal law. Mr. Hall filed a Petition in Randolph County seeking relief. On June 9, 2022, the case was dismissed. ISP decision upheld.

*Isaiah Harris v. Illinois State Police and Brendan F. Kelly as Director of the Illinois State Police* - - Isaiah Harris was convicted of Falsely Impersonating a Police Officer on July 26, 2022. His FOID card application was denied as issuance is contrary to federal law. Mr. Harris filed a Complaint in Cook County seeking relief. On September 16, 2022, the case was dismissed without prejudice. ISP decision upheld.

*Kenny Howell v. Illinois State Police, Firearms Services Bureau* -- Kenny Howell was convicted of Burglary on August 28, 2001. His FOID card application was revoked as issuance is contrary to federal law. Mr. Howell filed a Complaint in Cook County seeking relief. On September 16, 2022, the case was dismissed for want of prosecution. ISP decision upheld.

*Briana Howell-Robinson v. Illinois State Police of Firearms Safety* -- Briana Howell-Robinson was convicted of an unknown offense. Ms. Howell-Robinson filed a Complaint in Cook County seeking relief. On April 28, 2022, the case was dismissed for want of prosecution. ISP decision upheld.

*Joe Irby Jr v. Illinois State Police* -- Joe Irby Jr., was convicted of Perjury on April 16, 1992. His FOID card application was denied as issuance is contrary to federal law. Mr. Irby filed a Summons

in Administrative Review and Complaint in Cook County seeking relief. On April 25, 2022, the case was dismissed for want of prosecution. [ISP decision upheld.](#)

*David Irving v. Illinois State Police* -- David Irving was convicted of Burglary on June 3, 1996. His FOID card application was denied as issuance is contrary to federal law. Mr. Irving filed a Petition in DeKalb County seeking relief. On May 25, 2022, the case was dismissed without prejudice. [ISP decision upheld.](#)

*Marcelo Johnson v. Illinois State Police and Cook County States' Attorney* -- Marcelo Johnson was convicted of Manufacture/Delivery of a Controlled Substance on January 24, 2001. His FOID card application was denied as issuance is contrary to federal law. Mr. Johnson filed a Petition seeking relief in Cook County. On September 16, 2022, Cook County denied relief. [ISP decision upheld.](#)

*Edrick Johnson Sr. v. Illinois State Police* -- Edrick Johnson Sr. was convicted of an unknown felony over 20 years ago. Mr. Johnson filed a Summons and Petition in Will County seeking relief. On September 09, 2022, the case was dismissed. [ISP decision upheld.](#)

*Darnell Junious Jr. v. Illinois State Police* -- Darnell Junious Jr. was convicted of Possession of Domestic Battery on January 29, 2007; and Possession of a Controlled Substance on September 8, 2005. His FOID card application was denied as issuance is contrary to federal law. Mr. Junious Jr. filed a Complaint in Cook County seeking relief. On December 6, 2022, the case was dismissed. [ISP decision upheld.](#)

*Troy J. Kelly v. James W. Glasglow and Brendan F. Kelly* -- Troy J. Kelly was convicted of Retail Theft on December 23, 2002; Possession of a Controlled Substance on March 22, 2001; Possession of Burglary Tools on June 11, 1997; and Burglary on May 3, 1993. His FOID card application was denied as issuance is contrary to federal law. Mr. Kelly filed a Summons in Administrative Review and Petition seeking relief in Will County. On January 10, 2022, Will County denied relief. [ISP decision upheld.](#)

*David Edmund Neely v. Illinois State Police* -- David Edmund Neely was the subject of an Order of Protection on October 17, 2016. His FOID card was revoked as issuance is contrary to federal law. Mr. Neely filed a Petition in County seeking relief. On September 7, 2022, the case was dismissed with prejudice. [ISP decision upheld.](#)

*Kadarian Nellem v. Illinois State Police* -- Kadarian Nellem is seeking to overturn the decision of the ISP judgment for his FOID card. Mr. Nellem filed a Complaint in Cook County seeking relief. On August 4, 2022, the case was dismissed. [ISP decision upheld.](#)

*Vincent Nieves v. Illinois State Police, Cook County State's Attorney* -- Vincent Nieves was convicted of Indecent Liberty-Child on February 7, 1975; and Jury Commission/Bribery in 1971. His FOID card was revoked as issuance is contrary to federal law. Mr. Nieves filed a Petition seeking relief in Cook County. On July 14, 2022, Cook County denied relief. [ISP decision upheld.](#)

*Marcelino Ochoa Jr. v. Illinois State Police, Kane County State's Attorney* -- Marcelino Ochoa Jr., was convicted of Aggravated Discharge of a Firearm on January 4, 2007. His FOID card application was denied as issuance is contrary to federal law. Mr. Ochoa filed a Petition in Kane County seeking relief. On March 15, 2022, Kane County denied relief. [ISP decision upheld.](#)

*Corey Orme aka Corey Brooks v. Illinois State Police, Illinois State Police Firearms Services*

*Bureau -- Corey Orme (Brooks) was convicted of Driving Revoked/Reckless Homicide on September 15, 2011; Driving Revoked/Suspended 2nd Class on January 12, 2009; Involuntary Manslaughter/Reckless Homicide on July 22, 2002; Aggravated Battery on December 12, 1996; Possession of a Controlled Substance on July 25, 1996; and Residential Burglary on May 22, 1996. His FOID card application was denied as issuance is contrary to federal law. Mr. Orme alleges his record was expunged/sealed. Mr. Orme filed a Complaint in Cook County seeking relief. On March 22, 2022, Cook County affirmed ISP's decision to revoke. ISP decision upheld.*

*Orlando Owens v. Illinois State Police -- Orlando Owens was convicted of Domestic Battery on June 30, 1999; and Burglary on June 21, 1985. His FOID card application was denied as issuance is contrary to federal law. Mr. Owens alleged his record was expunged by ISP. Mr. Owens filed a Complaint for Administrative Review in Cook County seeking relief. On December 21, 2022, the case was dismissed. ISP decision upheld.*

*Cole R. Powell v. Illinois State Police -- Cole R. Powell was convicted of Marijuana Possession on an unknown date. Mr. Powell filed a Summons and Complaint in Sangamon County seeking relief. On September 13, 2022, the case was dismissed for want of prosecution. ISP decision upheld.*

*Dewayne Pye v. State's Attorney of Champaign County, Illinois -- Dewayne Pye was convicted of Manufacture and Delivery of Cannabis on December 11, 2000; Unlawful Use of a Weapon on November 14, 1991; and Mob Action on September 10, 1990. His FOID card application was revoked as issuance is contrary to federal law. Mr. Pye filed a Petition in Champaign County seeking relief. On August 17, 2022, Champaign County denied relief. ISP decision upheld.*

*Maurice W. Reynolds v. Illinois State Police, Firearms Services Bureau -- Maurice W. Reynolds. was convicted of Possession of a Controlled Substance on December 1, 2004; Manufacture/Delivery of a Controlled Substance on June 11, 1996; and Attempted Armed Robbery on June 3, 1993. His FOID card application was denied as issuance is contrary to federal law. Mr. Reynolds filed a Complaint in Cook County seeking relief. On July 21, 2022, the case was dismissed for want of prosecution. ISP decision upheld.*

*Jordan Richardson v. Illinois State Police Firearm Review Board -- Jordan Richardson was convicted of an unknown offense. His FOID card application was denied as issuance is contrary to federal law. Mr. Richardson filed a Complaint in Cook County seeking relief. On August 18, 2022, the case was dismissed. ISP decision upheld.*

*Russell William Ryan v. Brendan F. Kelly, Kim Foxx -- Russell William Ryan was convicted of DUI/Alcohol/Drugs on April 6, 2010. His FOID card application was denied as issuance is contrary to federal law. Mr. Ryan filed a FOID administrative appeal on September 16, 2020, and received no response. Mr. Ryan filed a Complaint in Cook County seeking relief. On January 31, 2022, the case was dismissed as moot. ISP decision upheld.*

*Jose Sancen v. Illinois State Police, Illinois State Attorney -- Jose Sancen was convicted of Unlawful Use of Weapons in 1998. His FOID card application was denied as issuance is contrary to federal law. Mr. Sancen filed a Petition in Kane County seeking relief. On May 18, 2022, Kane County denied relief. ISP decision upheld.*

*Jason R. Schindlebeck v. Director Brendan F. Kelly of the Illinois State Police -- Jason Schindlebeck was convicted of Unlawful Delivery of a Look-Alike Substance on March 15, 1996. Mr. Schindlebeck filed a Petition in Kane County seeking relief. On May 4, 2022, the case was*

dismissed without prejudice. ISP decision upheld.

*People v. Larry Schneider* -- Larry Schneider was convicted of Deceptive Practices on February 15, 1991. His FOID card application was revoked as issuance is contrary to federal law. Mr. Schneider filed a Petition in Clinton County seeking relief. On December 2, 2022, the case was dismissed. ISP decision upheld.

*Oleg Alex Schubow v. Illinois State Police, Lake County State's Attorney* -- Oleg Alex Schubow was convicted of Manufacture/Delivery of 50-200 grams of a Controlled Substance on May 15, 1992. His FOID card application was denied as issuance is contrary to federal law. He filed a Petition in Lake County seeking relief. On May 20, 2022, Lake County denied relief. ISP decision upheld.

*Peter Sellers v. State's Attorney of Cook County, Illinois* -- Peter Sellers was convicted of Possession of a Controlled Substance and Possession of a Controlled Substance with Intent to Distribute on March 9, 1994. Mr. Sellers filed a Petition in Cook County seeking relief. On December 5, 2022, the case was dismissed without prejudice. ISP decision upheld.

*Rita Shaffer v. Illinois State Police* -- Rita Shaffer was convicted of State Benefits Fraud on July 29, 1988. Her FOID card application was denied as issuance is contrary to federal law. Ms. Shaffer filed a Complaint in Cook County seeking relief. On October 19, 2022, the case was dismissed. ISP decision upheld.

*Michael Dean Sherrell v. Brendan F. Kelly, Department of Illinois State Police* -- Michael Dean Sherrell was convicted of Domestic Battery/Bodily Harm on January 31, 1997. His FOID card application was denied as issuance is contrary to federal law. Mr. Sherrell filed a Petition in Kankakee County seeking relief. On August 1, 2022, Kankakee County denied relief. ISP decision upheld.

*Dean Shults v. Director of Illinois State Firearms Bureau Jessica Trame and Illinois State Police* -- A Motion to Advance Court Date was received from the Attorney General's Office regarding an appeal of denial of a firearm owner's identification card. Mr. Shults filed a Petition in Kane County seeking relief. On December 20, 2022, Kane County denied relief. ISP decision upheld.

*Germene Shumate v. Illinois State Police* -- Germene Shumate was convicted of Possession of 100<400 Gram Cocaine on November 10, 2010. Her FOID card application was denied as issuance is contrary to federal law. Ms. Shumate filed a Complaint in Cook County seeking relief. On September 30, 2022, Cook County denied relief. ISP decision upheld.

*Jerame Simmons v. James Gomric State's Attorney of St. Clair County, IL and Illinois State Police* -- Jerame Simmons was convicted of Arson and Unauthorized Stop with Flashing Lights on October 12, 1999. His FOID card application was revoked as issuance is contrary to federal law. Mr. Simmons was pardoned on May 14, 2021. Mr. Simmons filed a Complaint in St. Clair County seeking relief. On November 28, 2022, the case was dismissed. ISP decision upheld.

*Jeffrey B. Smith v. Brendan F. Kelly, The Department of the Illinois State Police* -- Jeffrey B. Smith has an unknown misdemeanor conviction on May 10, 2018. His FOID card application was revoked as issuance is contrary to federal law. Mr. Smith filed a Complaint in Kendall County seeking relief. On March 31, 2022, the case was dismissed. ISP decision upheld.

*Warren K. Swenson v. Brendan F. Keller, Director of the Department of Illinois State Police a Municipal Corporation* -- Warren K. Swenson was voluntarily admitted to a mental health facility and the subject of a clear and present danger determination. His FOID card application was revoked as issuance is contrary to federal law. Mr. Swenson filed a Petition in Boone County seeking relief. On May 10, 2022, the case was dismissed. ISP decision upheld.

*Luis Torres v. State's Attorney of Cook County, Illinois* -- Luis Torres was convicted of Burglary on October 6, 1992. His FOID card application was denied as issuance is contrary to federal law. Mr. Torres filed a Petition in Cook County seeking relief. On July 7, 2022, the case was dismissed. ISP decision upheld.

*William Vos v. State's Attorney of Lake County, Illinois* -- William Vos was convicted as a juvenile of Residential Burglary in 2002. His FOID card application was denied as issuance is contrary to federal law. Mr. Vos filed a Petition in Lake County seeking relief. On October 12, 2022, the case was dismissed. ISP decision upheld.

*Jeffrey Wall v. Illinois State Police* -- Jeffrey Wall's FOID card was revoked after Lincolnshire Police Department reported him to ISP as a clear and present danger following an incident at his workplace. Mr. Wall was involuntarily admitted to a mental facility on February 21, 2019. His FOID card was revoked as issuance is contrary to federal law. Mr. Wall alleges he filed a FOID Appeal on May 7, 2019, and ISP had not responded. Mr. Wall filed a Petition in Lake County seeking relief and a declaration Illinois' FOID Act is unconstitutional. On May 27, 2022, the case was dismissed. ISP decision upheld.

*Sierra Whitehead v. Illinois State Police, Illinois Conceal to Carry* -- Ms. Whitehead was the subject of an Order of Protection. Her FOID card application was revoked as issuance is contrary to federal law. Ms. Whitehead filed a Complaint in Cook County seeking relief. On January 7, 2022, the case was dismissed for want of prosecution. ISP decision upheld.

*Dusten Nash Woolsey v. Jamie L. Mosser, Brendan F. Kelly* -- Dusten Nash Woolsey was convicted of False Report of Offense on June 19, 2007. His FOID card application was denied as issuance is contrary to federal law. Mr. Woolsey filed a Petition in Kane County seeking relief. On August 5, 2022, the case was dismissed with prejudice. ISP decision upheld.

*Erik R. Zaczek v. Illinois State Police* -- Erik R. Zaczek was convicted of Possession of Cannabis and Possession of Drug Paraphernalia on March 23, 2013. He alleges Illinois State Constitution Due Process and Right to Bear Arms rights were violated. His FOID card application was revoked as issuance is contrary to federal law. Mr. Zaczek alleges he filed a FOID appeal and has not received a response in 63 months. Mr. Zaczek filed a Complaint in Cook County seeking relief. On July 12, 2022, the case was dismissed with prejudice. ISP decision upheld.

The court granted relief and/or directed ISP to issue a FOID card to the petitioner in 47 instances. In all of those cases, ISP determined that the Courts had proper authority to grant relief and did not oppose the orders.

*Gilbert Abington v. Lake County State's Attorney, Illinois State Police* -- Gilbert Abington was convicted of Manufacture/Deliver 15/+Grams Cocaine/Analog and Possession of 100-400 Grams of Cocaine on May 5, 1995. His FOID card application was denied as issuance is contrary to federal law. Mr. Abington filed a Petition in Lake County seeking relief. On March 2, 2022, Lake County ordered ISP to issue a FOID card to Mr. Abington. ISP decision reversed.



*Linda Adams v. Illinois Department of State Police and Brendan F. Kelly, Director of Illinois State Police* -- Linda Adams was convicted of Manufacture/Delivery of Controlled Substances on November 14, 1995; September 3, 1996; and on April 30, 1998. Her FOID card application was denied as issuance is contrary to federal law. She was pardoned and her record was expunged on December 31, 2014. Ms. Adams filed a Complaint for Administrative Review in Cook County seeking relief. On August 23, 2022, Cook County ordered ISP to issue a FOID card to Ms. Adams. ISP decision reversed.

*William A. Balacek v. Illinois State Police* -- William A. Balacek was convicted of Manufacture/Delivery of Controlled Substances on June 3, 1987. His FOID card application was denied as issuance is contrary to federal law. Mr. Balacek filed a Petition in McHenry County seeking relief. On October 5, 2022, McHenry County ordered ISP to issue a FOID card to Mr. Balacek. ISP decision reversed.

*Shawn Branner v. Dept of the Illinois State Police and James W. Glasgow Will County State's Attorney* -- Shawn Branner was convicted of Possession/Display/Fraudulent Driver's License/Credit and Burglary on February 26, 1996. His FOID card application was denied as issuance is contrary to federal law. Mr. Branner filed a Petition seeking relief in Will County. On May 5, 2022, Will County ordered ISP to issue a FOID card to Mr. Branner. ISP decision reversed.

*Michael Branum v. State's Attorney of Winnebago County, Illinois* -- Michael Branum was convicted of Battery on December 21, 1988. His FOID card application was revoked as issuance is contrary to federal law. Mr. Branum filed a Petition in Winnebago County seeking relief. On December 21, 2022, Winnebago County ordered ISP to issue a FOID card to Mr. Branum. ISP decision reversed.

*Greg Cellitti v. Winnebago County State's Attorney's Office* -- Greg Cellitti was convicted of Burglary on March 10, 1970. His FOID card application was revoked as issuance is contrary to federal law. Mr. Cellitti filed a Petition in Winnebago County seeking relief. On January 8, 2022, an Agreed Order of Withdrawal was filed by Mr. Cellitti who received his FOID card. ISP decision reversed.

*Robert P. Chow v. People of the State of Illinois* -- Robert P. Chow was convicted of Carrying/Possession of a Concealed Gun in 1998. His FOID card application was denied as issuance is contrary to federal law. Mr. Chow filed a Petition in Winnebago County seeking relief. On July 21, 2022, Winnebago County ordered ISP to issue a FOID card to Mr. Chow. ISP decision reversed.

*Brian Clark v. Illinois State Police, Cook County State's Attorney* -- Brian Clark was convicted of Attempt Burglary in January 1985. His FOID card application was revoked as issuance is contrary to federal law. Mr. Clark filed a Summons and Petition seeking relief in Cook County. On August 26, 2022, Cook County ordered ISP to issue a FOID card to Mr. Clark. ISP decision reversed.

*Order for Certificate of Good Conduct / Kevin M. Conway* -- An Order was entered by Mason County on December 26, 2019. The Order improperly orders the ISP to issue Kevin M. Conway a FOID card. Mr. Conway is prohibited from possessing a firearm due to his Domestic Violence conviction as issuance of a FOID card is contrary to federal law. On May 23, 2022, Mason County ordered ISP to issue a FOID card to Mr. Conway. ISP decision

reversed.

*Sergio Cruz v. State's Attorney of Cook County, IL* -- Sergio Cruz was convicted of Manufacture and Delivery of Controlled Substances on May 15, 1995; and Possession of a Firearm in Public on January 24, 1995. His FOID card application was denied as issuance is contrary to federal law. Mr. Cruz filed a Petition in Cook County seeking relief. On December 27, 2022, Cook County ordered ISP to issue a FOID card to Mr. Cruz. ISP decision reversed.

*Chad J. Czerwinski v. Kane County State's Attorney* -- Chad J. Czerwinski was convicted of Burglary on September 8, 2021; and was granted a Pardon on November 25, 2015. His FOID card application was denied as issuance is contrary to federal law. Mr. Czerwinski filed a Petition in Kane County seeking relief. On January 31, 2022, Kane County ordered ISP to issue FOID to Mr. Czerwinski. ISP decision reversed.

*Kimberly Donnyell Corley v. Illinois State Police, Firearms Services Bureau* -- Kimberly Donnyell Corley was convicted of Other Amount Narcotics Scheduled on January 29, 1997. Her FOID card application was denied as issuance is contrary to federal law. Ms. Corley filed a Complaint in Cook County seeking relief. On May 11, 2022, Cook County ordered ISP to issue a FOID card to Ms. Corley. ISP decision reversed.

*James N. Douvas v. Illinois State Police* -- James N. Douvas was convicted of Criminal Drug Conspiracy with Intent to Deliver between 1 and 15 Grams on October 14, 1992. His FOID card application was denied as issuance is contrary to federal law. Mr. Douvas filed a Complaint seeking relief in DuPage County. On April 21, 2022, DuPage County ordered ISP to issue a FOID card to Mr. Douvas. ISP decision reversed.

*Alan Dowdy v. People of the State of Illinois* -- An Order entered on October 8, 2019, directed ISP to issue a FOID card to Alan Dowdy. Mr. Dowdy was convicted of a misdemeanor crime of Domestic Violence. ISP opposed the Order as Mr. Dowdy is still federally prohibited. On July 15, 2022, Kankakee County ordered ISP to issue a FOID card to Mr. Dowdy. ISP decision reversed.

*Richard A. Egger v. Brendan F. Kelly, Director of the Illinois State Police, and the Department of State Police* -- Richard A. Egger was convicted of Burglary on December 15, 1975; and Possession of a Controlled Substance on January 21, 1975. His FOID card application was denied as issuance is contrary to federal law. Mr. Egger filed a Petition in Sangamon County seeking relief. On October 30, 2022, County granted Mr. Egger's Reinstatement of Firearm Privileges and Issuance of FOID Card. ISP decision reversed.

*Kevin S. Ellis v. Brendan F. Kelly, et al.* -- Kevin S. Ellis was convicted of Armed Robbery on September 16, 1987. His FOID card application was denied as issuance is contrary to federal law. Mr. Ellis filed a Petition in Vermilion County seeking relief. On November 8, 2022, Vermilion County ordered ISP to issue a FOID card to Mr. Ellis. ISP decision reversed.

*Alfred Evans Jr. v. Will County State's Attorney* -- An Order was entered by Will County on March 22, 2022, requiring the Will County State's Attorney to submit the administrative file from ISP by April 12, 2022. ISP intervened. On October 14, 2022, Will County ordered ISP to issue a FOID card to Mr. Evans. ISP decision reversed.

*Walter Fantauzzi v. Illinois State Police* -- Walter Fantauzzi was convicted of a felony in 1989.

His FOID card application was denied as issuance is contrary to federal law. Mr. Fantauzzi filed a Summons in Administrative Review and Complaint seeking relief in Cook County. On May 18, 2022, Cook County ordered ISP to issue a FOID card to Mr. Fantauzzi. ISP decision reversed.

*Darin M. Grubisic v. Illinois State Police* -- Darin M. Grubisic was convicted of Burglary on November 8, 1995. His FOID card application was denied as issuance is contrary to federal law. Mr. Grubisic filed a Complaint in DuPage County seeking relief. On March 17, 2022, DuPage County ordered ISP to issue a FOID card to Mr. Grubisic. ISP decision reversed.

*Kendrick Howse v. James W. Glasgow, Brendan F. Kelly* -- Kendrick Howse was convicted of Possession of a Controlled Substance on February 11, 1998. His FOID card application was denied as issuance is contrary to federal law. Mr. Howse filed a Petition in Will County seeking relief. On March 9, 2022, Will County ordered ISP to issue a FOID card to Mr. Howse. ISP decision reversed.

*John Jackson v. Illinois State Police Firearms Service* -- John R. Jackson was convicted of an unknown charge. He received an Order to Expunge Juvenile Records on April 16, 2019. His FOID card application was denied as issuance is contrary to federal law. Mr. Jackson filed a Summons and Petition for Administrative Review in Cook County seeking relief. On May 2, 2022, Cook County ordered ISP to issue a FOID card to Mr. Jackson. ISP decision reversed.

*Joe Johnson v. Illinois Department State Police & Cook County State Attorney* -- Joe Johnson was convicted of Robbery in 1973. His FOID card application was denied as issuance is contrary to federal law. Mr. Johnson filed a Petition in Cook County seeking relief. On May 26, 2022, Cook County ordered ISP to issue a FOID card to Mr. Johnson. ISP decision reversed.

*Antonio Johnson v. Illinois State Police, Office of Firearms and Safety* -- Antonio Johnson was convicted of Possession of Cannabis on March 1, 2006, and Manufacture/Delivery of a Controlled Substance on March 9, 2000. His FOID card application was denied as issuance is contrary to federal law. Mr. Johnson filed a Summons and Complaint in Cook County seeking relief. On December 1, 2022, Cook County ordered ISP to issue a FOID card to Mr. Johnson. ISP decision reversed.

*Bobby Kellar v. Illinois State Police* -- Bobby Kellar was convicted of Manufacturing and Delivery of Cocaine in 1995, and Unlawful Use of Weapons in 1994. Mr. Kellar also alleges his felony convictions were sealed. His FOID card application was denied as issuance is contrary to federal law. Mr. Kellar filed a Petition in Cook County seeking relief. On July 14, 2022, Cook County ordered ISP to issue a FOID card to Mr. Kellar. ISP decision reversed.

*Mark Krog v. State's Attorney of McHenry County, IL* -- Mark Krog was convicted of Domestic Battery in 2020, Making a False Report in 2010, and Burglary in 1998. His FOID card application was denied as issuance is contrary to federal law. Mr. Krog filed a Petition in McHenry County seeking relief. On November 14, 2022, McHenry County ordered ISP to issue a FOID card to Mr. Krog. ISP decision reversed.

*In Re the Application of Graham A. Lackland for a Firearm Owners Identification Card* -- Graham A. Lackland was convicted of Burglary on May 18, 1998. His FOID card application was denied as issuance is contrary to federal law. Mr. Lackland filed a Petition in Lee County seeking relief. On July 14, 2022, Lee County ordered ISP to issue a FOID card to Mr. Lackland. ISP decision reversed.

*Darin Leduke v. People of the State of Illinois and Illinois State Police* -- Darin Leduke was convicted of Burglary on July 26, 1991. His FOID card application was denied as issuance is contrary to federal law. Mr. Leduke filed a Petition in Kankakee County seeking relief. On September 8, 2022, Kankakee County ordered ISP to issue a FOID card to Mr. Leduke. ISP decision reversed.

*Davis Howard Leighty II v. Illinois State Police and Kane County State's Attorney* -- Davis Howard Leighty II was convicted of Domestic Battery in 1997. His FOID card application was denied as issuance is contrary to federal law. Mr. Leighty filed a Petition in Kane County seeking relief. On July 5, 2022, Kane County ordered ISP to issue a FOID card to Mr. Leighty. ISP decision reversed.

*In Re the Firearms Possession Rights of Albert Edward Lorr, III* -- Albert Edward Lorr, III was convicted of Burglary on January 30, 1986. His FOID card application was denied as issuance is contrary to federal law. Mr. Lorr filed a Petition in McHenry County seeking relief. On December 27, 2022, McHenry County ordered ISP to issue a FOID card to Mr. Lorr. ISP decision reversed.

*People v. Joseph W. Lyons* -- Joseph W. Lyons was convicted of Battery on November 10, 1997, following an incident involving domestic violence. His FOID card application was revoked as issuance is contrary to federal law. An Order for Relief from Firearm Possession Prohibition was entered by Marion County on December 8, 2014, directing ISP to issue a FOID card to Lyons. ISP opposed the Order. On November 3, 2022, Marion County granted relief to Mr. Lyons. ISP decision reversed.

*Robert Mack AKA Robert Makowski, Jr. v. Illinois State Police, Cook County State's Attorney* -- Robert Mack (Makowski) was convicted of Manufacture/Delivery of a Controlled Substance on December 3, 1984. His FOID card application was denied as issuance is contrary to federal law. Mr. Mack filed a Petition seeking relief in Cook County. On July 20, 2022, Cook County ordered ISP to issue a FOID card to Mr. Mack. ISP decision reversed.

*Nicholas Mobus v. State's Attorney of Lake County, Illinois* -- Nicholas Mobus was convicted of Manufacture/Delivery of a Controlled Substance on September 10, 2007. His FOID card application was denied as issuance is contrary to federal law. Mr. Mobus filed a Petition in Lake County seeking relief. On May 26, 2022, Lake County ordered ISP to issue a FOID card to Mr. Mobus. ISP decision reversed.

*Roy Moore v. Illinois State Police* -- Roy Moore was convicted of Forgery on January 11, 1984; and Illegal Possession of a Weapon by a Felon on August 31, 1993. His FOID card application was denied as issuance is contrary to federal law. Mr. Moore filed a Complaint for Administrative Review in Cook County seeking relief. On December 15, 2022, Cook County ordered ISP to issue a FOID card to Mr. Moore. ISP decision reversed.

*Michael E. Nash v. Brendan F. Kelly Director Illinois State Police and, the Department of the Illinois State Police* -- Michael E. Nash was convicted of Burglary in 1968. His FOID card application was denied as issuance is contrary to federal law. Mr. Nash filed a Petition in Grundy County seeking relief. On February 14, 2022, Grundy County ordered ISP to issue a FOID card to Mr. Nash. ISP decision reversed.

*Brian Lee Ohlendorf v. Brendan F. Kelly, Department of Illinois State Police, James W. Glasgow*

-- Brian Lee Ohlendorf was convicted of Burglary on October 11, 1988. His FOID card application was denied as issuance is contrary to federal law. Mr. Ohlendorf filed a Petition in Will County seeking relief. On March 9, 2022, Will County ordered ISP to issue a FOID card to Mr. Ohlendorf. ISP decision reversed.

*Michael Ryan v. DuPage County State's Attorney's Office, Illinois State Police Firearms Service Bureau* -- Michael Ryan was convicted of Burglary on January 13, 1997. His FOID card application was denied as issuance is contrary to federal law. Mr. Ryan filed a Petition in DuPage County seeking relief. On November 23, 2022, DuPage County ordered ISP to issue a FOID card to Mr. Ryan. ISP decision reversed.

*Edward J. Schmitt v. Randolph County State's Attorney and the Illinois State Police* -- Edward J. Schmitt was convicted of Battery on September 28, 1997. His FOID card application was revoked as issuance is contrary to federal law. Mr. Schmitt filed an Amended Petition in Randolph County seeking relief. On March 10, 2022, Randolph County ordered ISP to issue a FOID card to Mr. Schmitt instantaner. ISP decision reversed.

*Brian R. Sitar v. Brendan F. Kelly and Department of the Illinois State Police* -- Brian R. Sitar was convicted of Burglary on October 22, 1997. His FOID card application was denied as issuance is contrary to federal law. Mr. Sitar filed a Petition in Grundy County seeking relief. On June 16, 2022, Grundy County ordered ISP to issue a FOID card to Mr. Sitar. ISP decision reversed.

*Deandre Smith v. Brendan F. Kelly, Department of Illinois State Police, James W. Glasgow* -- Deandre Smith was convicted of Burglary on September 21, 1994. His FOID card application was denied as issuance is contrary to federal law. Mr. Smith filed a Complaint in Will County seeking relief. On November 30, 2022, Will County ordered ISP to issue a FOID card to Mr. Smith. ISP decision reversed.

*Donald J. Soper v. Illinois State Police* -- Donald J. Soper alleges his Illinois Constitutional Due Process and Right to Bear Arms rights were violated. Donald J. Soper was convicted of Aggravated IVC felony on May 30, 1996. His FOID card application was denied as issuance is contrary to federal law. Mr. Soper alleges he submitted an appeal to ISP and has not received a response in 67 months. Mr. Soper filed a Complaint in Kane County seeking relief. On August 25, 2022, the case was dismissed with prejudice. Mr. Soper received his FOID. ISP decision reversed.

*Thomas W. Thornton v. McHenry County State's Attorney, Illinois Department of State Police* -- Thomas W. Thornton was convicted of Manufacturing/Delivery of a Controlled Substance and Unlawful Delivery of a Controlled Substance on April 14, 1983. His FOID card application was denied as issuance is contrary to federal law. Mr. Thornton filed a Petition in McHenry County seeking relief. On December 20, 2022, McHenry County ordered ISP to issue a FOID card to Mr. Thornton. ISP decision reversed.

*Anthony Valentin v. Illinois State Police, Cook County State's Attorney* -- Anthony Valentin was convicted of Unlawful Possession of a Weapon by a Felon in July 2007, and Manufacturing and/or Delivering Controlled Substances in April 2000. His FOID card application was denied as issuance is contrary to federal law. Mr. Valentin filed a Petition seeking relief in Cook County. On December 2, 2022, Cook County ordered ISP to issue a FOID card to Mr. Valentin. ISP decision reversed.

*Wayne L. Wakefield v. Christopher M. Quick, State's Attorney of Lawrence County, Illinois* -- Wayne L. Wakefield was convicted of Domestic Battery on June 3, 1997. His FOID card application was denied as issuance is contrary to federal law. On June 15, 2015, Lawrence County entered an order directing ISP to issue a FOID card to Mr. Wakefield. On July 26, 2022, Lawrence ordered ISP to issue a FOID card to Mr. Wakefield. ISP decision reversed.

*Douglas Scott Wayland v. Cass County State's Attorney* -- Douglas Scott Wayland v. Cass County State's Attorney - Douglas Scott Wayland was convicted of Unlawful Possession of a Controlled Substance Not for Purpose of Sale on January 1, 1991, in Nevada. His FOID card application was denied as issuance is contrary to federal law. Mr. Scott filed a Petition in Cass County seeking relief. On August 7, 2018, Cass County ordered ISP to promptly issue a FOID card to Wayland. On October 20, 2022, the case was dismissed for want of prosecution. ISP decision reversed.

*Saul Whitaker v. People of the State of Illinois and Illinois State Police* -- Saul Whitaker was convicted of Burglary on March 24, 1998. His FOID card application was denied as issuance is contrary to federal law. Mr. Whitaker filed a Petition in Kankakee County seeking relief. On September 8, 2022, Kankakee County ordered ISP to issue a FOID card to Mr. Whitaker. ISP decision reversed.

*Natalia Wright v. State's Attorney of Cook County, Illinois* -- Natalia Wright was convicted of Forgery on June 15, 2005; Possession of a Controlled Substance on July 15, 1999, and August 23, 2001; Retail Theft on February 16, 1999; and Manufacture/Delivery of a Controlled Substance on September 17, 1998. Her FOID card application was denied as issuance is contrary to federal law. Ms. Wright filed a Petition in Cook County seeking relief. On August 30, 2022, Cook County ordered ISP to issue a FOID card to Ms. Wright. ISP decision reversed.

*Preston Zollicoffer v. Illinois State Police, Firearms Services Bureau* -- Preston Zollicoffer alleges his FOID card was denied. Mr. Zollicoffer filed a Complaint in Cook County seeking relief. On July 25, 2022, Cook County ordered ISP to issue a FOID card to Mr. Zollicoffer. ISP decision reversed.
