Executive Summary

This report is compiled to satisfy the requirements of Chapter 730 ILCS 5/5-8-1.2.

The current Impact Program (IP) facilities are located at Dixon Springs (currently closed) in the Shawnee National Forest in southeastern Illinois, at the DuQuoin State Fairgrounds in southern Illinois (currently housed at Murphysboro), and Logan Correctional Center.

In FY2023, 42 individuals exited the Impact Program. The individuals were recommended for admission to the IP by Judges in 24 different counties. Of those admitted into IP, 54.8% (23) successfully completed the program and were released to Mandatory Supervised Release (MSR) in the community. The 3-Year recidivism rate for FY2019 IP graduates was 26.2% compared with the overall departmental recidivism rate of 36.7% for the same year.

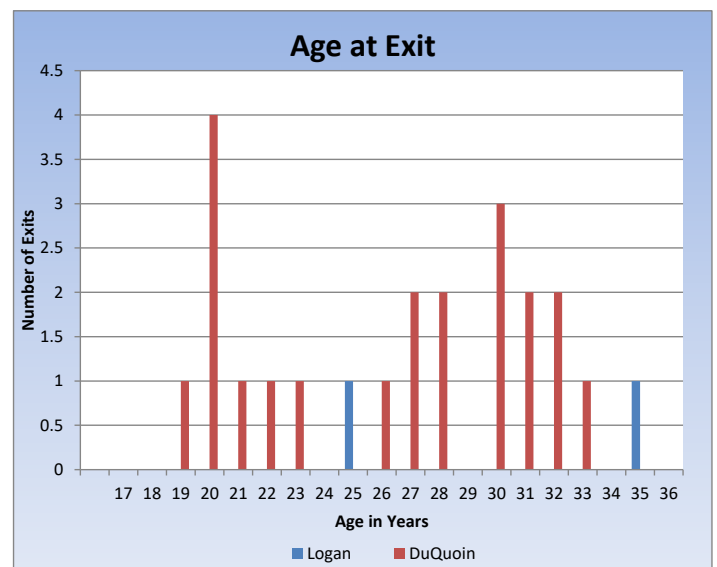
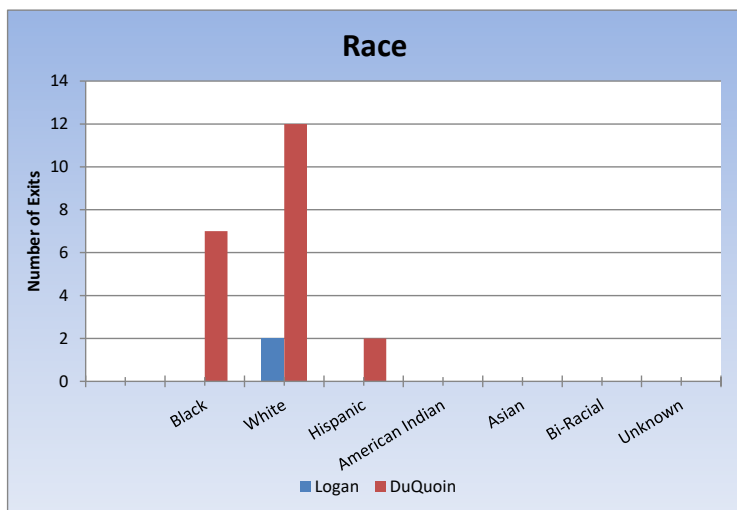
