### HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

#### HOUSE RESOLUTION 499

Offered by Representative Weaver:

WHEREAS, On October 7, 2023, Hamas, a designated foreign terrorist organization, perpetrated a brutal terrorist attack against the Republic of Israel, launching thousands of rockets and conducting incursions into Israeli territory; and

WHEREAS, This savage assault resulted in the tragic loss of numerous innocent lives, leaving thousands more injured and over one hundred individuals, including U.S. citizens, subjected to abductions, with reports of horrifying acts of violence being perpetrated by Hamas terrorists, including rape, torture, and murder; and

WHEREAS, The international community stands united in its condemnation of this heinous act of terrorism, and it expresses unwavering solidarity with the victims and their families, including Hersh Goldberg-Polin and Aner Shapira, whose bravery and courage are being recognized and acknowledged by communities across the globe; and

WHEREAS, Hersh Goldberg-Polin, a 23-year-old man, was among those taken hostage, sustaining severe injuries in the process, including the loss of his arm below the elbow due to a grenade explosion he survived while fighting back against Hamas' merciless attack on Israel; he was last seen showing unwavering strength, determination, and poise while being abducted by Hamas terrorists; and

WHEREAS, Hersh Goldberg-Polin's parents, now residing in Israel, were originally raised in Chicago, and his grandmothers currently reside in Chicago and Evanston, highlighting the profound and intense impact this tragedy has had on communities across Israel, the United States, and the world; and

WHEREAS, Aner Shapira, an off-duty Israel Defense Forces soldier and member of the Nahal Brigade, was among those killed that day and sacrificed his life in an incredible and inspiring act of bravery; as he and over 20 other festivalgoers sought safety in a public bomb shelter, Hamas terrorists began throwing live grenades into the shelter; in response, he defended and protected those beside him by catching and throwing back grenades at the terrorists, saving others while laying down his life in the process; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we condemn in the strongest terms the terrorist acts perpetrated by Hamas on October 7, 2023 and express our full solidarity with the Republic of Israel and its citizens; and be it further

RESOLVED, That we believe that the responsible parties behind this heinous act, including Hamas and its affiliates, must be held accountable for their actions and that all necessary measures need to be taken to ensure justice is served; and be it further

RESOLVED, That we demand the immediate and safe return of Hersh Goldberg-Polin, along with all other hostages forcibly taken by Hamas terrorists, from Hamas captivity, and that every option must be explored and every effort must be exerted to secure their release and facilitate their safe return to their loving, brave, and courageous families; and be it further

RESOLVED, That we urge the United Nations, relevant international bodies, and member states to mobilize all available resources to assist in the negotiation and rescue efforts, with a focus on the well-being and immediate medical attention required for Hersh Goldberg-Polin and the other hostages; and be it further

RESOLVED, That we call upon the nations of the world to work collectively to prevent such acts of terror in the future and to strengthen global cooperation in combating terrorism in all of its forms; and be it further

RESOLVED, That we recognize and honor the extraordinary bravery and sacrifice of Hersh Goldberg-Polin's friend, Aner Shapira, who valiantly gave his life to protect others in the attack, displaying selflessness and heroism in the face of unimaginable danger; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the United States, the U.S. Senate Majority Leader, the U.S. Senate Minority Leader, the U.S. Speaker of the House, the U.S. House of Representatives Minority Leader, and all members of the Illinois Congressional Delegation.

#### HOUSE RESOLUTION 501

Offered by Representative Ness:

WHEREAS, The members of the Illinois House of Representatives wish to recognize McHenry County on the occasion of its participation in Operation Green Light for Veterans in an effort to further support veterans and their families; and

WHEREAS, Veterans swear an oath to defend the U.S. Constitution against enemies foreign and domestic, and they have repeatedly put themselves in harm's way to fulfill this oath; it is important to support and acknowledge the sacrifices veterans and their families have made in carrying out this oath; and

WHEREAS, Countless Americans throughout history have given their lives in service to the defense of the U.S. Constitution and the founding principles of this country; and

WHEREAS, Many veterans have suffered trauma and loss as a result of fulfilling the oath they took on induction day, including serving through combat, handling the relocation of their families, and experiencing the loss of their communities; and

WHEREAS, The security of the United States depends on the strength of our Armed Forces and the men and women who continue to step forward and volunteer to do their duty, endangering their lives to defend our shores in the process; and

WHEREAS, Veterans often need help assimilating back into civilian life through the use of local, state, and federal resources, providing intervention specially designed to address the impact of military service; and

WHEREAS, The National Association of Counties encourages all counties, parishes, and boroughs to recognize November 6 through November 12, 2023 as Operation Green Light for Veterans to raise awareness of the unique challenges many veterans face and the resources available at the county, state, and federal levels to assist veterans and their families; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize McHenry County for its participation in Operation Green Light for Veterans and its continued support for veterans and their families; and be it further

RESOLVED, That, in observance of Veterans Day and Operation Green Light for Veterans, we encourage the residents of Illinois to recognize and honor all veterans who have made immeasurable

contributions and sacrifices to preserve freedom by displaying a green light in a window of their business or residence; and be it further

RESOLVED, That we encourage the residents of Illinois to honor the service, courage, and sacrifice of every veteran, service member, and their families.

#### HOUSE JOINT RESOLUTION 44

Offered by Representative Reick:

WHEREAS, It is the obligation of the Illinois General Assembly and the various executive agencies of State government to provide such public services as are necessary to ensure that every person in Illinois can maximize his or her own potential and to provide such services as are required to ensure that the most unfortunate among us can live in dignity and safety; and

WHEREAS, It is also the obligation of the Illinois General Assembly and the various executive agencies of State government to not unduly burden the taxpayers of the State by extracting any greater amount of tax revenue than is necessary to achieve those ends; and

WHEREAS, The budgeting process in Illinois all too often fails to examine the inefficiencies brought about by the existence of redundant and outdated programs; and

WHEREAS, State agencies may not be in compliance with adequate cost-control measures to provide efficient use of State appropriations, or such measures may be outdated or non-existent; and

WHEREAS, The failure to examine measures to control costs leads to ever-increasing demands for revenue; and

WHEREAS, The taxpayers of Illinois are faced with high taxation that is hampering the development of business in the State and creating an exodus of productive, taxpaying citizens to other States, thus making it necessary to investigate ways by which Illinois government can reduce costs and yet fulfill its obligations in an efficient and cost-effective manner; therefore, be it

RESOLVED, That the Commission should conduct a private sector survey on cost control in State government and advise the Governor, the General Assembly, and the executive agency heads with respect to improving management practices and reducing costs; and be it further

RESOLVED, That the heads of executive agencies should, to the extent permitted by law and in a timely manner, be required to provide to the Commission and its staff units such information, including that relating to the structure, organization, personnel and operations of the executive agencies, as may be required for carrying out the purposes of the Commission's duties; and be it further

RESOLVED, That the Commission's recommendations should focus on the following areas: (1) Discretionary State spending, (2) Specific areas in which State agencies could be required to reduce expenditures, and (3) State budget and accounting practices leading to the establishment and enforcement of guidelines and procedures by which executive agencies must demand and confirm accountability from such stakeholders who may seek or be granted appropriations of State funds; and be it further

RESOLVED, That the Illinois Commission on Fiscal Responsibility and Reform, as a body with responsibilities that cross over the chronological boundaries of this Illinois General Assembly, should be created by legislation; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Speaker of the House, the House Minority Leader, the President of the Senate, and the Senate Minority Leader.
