Pursuant to our recent conversation, I am writing on behalf of Diversified Behavioral Comprehensive Care in response to a letter from the Illinois Violence Prevention Authority dated May 25, 2012 that DBCC owes it \$71,130.09.

DBCC is interested and willing to settle this claim by the end of this month under the general following terms and conditions. First, DBCC does not admit that it owes \$71,130.09 to the IVPA. However, DBCC is willing to admit that it does owe some money. Second, and as you may know, DBCC is in the early stages of determining whether it will be winding up its business. No formal decision has been made, but the issue of winding up is under consideration. Accordingly, to the extent that the IVPA is interested in resolving this matter, now is the time. If this matter is not resolved soon, the funds that DBCC has to repay IVPA may no longer be available. Third, DBCC is willing to settle this matter without admitting or denying liability. Fourth, DBCC has already deposited funds at Henderson Adam, LLC in anticipation of this claim. Accordingly, Henderson Adam, LLC is willing to forward any proceeds to IVPA five business days after a complete settlement and release have been executed. Finally, in order to resolve this matter DBCC is able to forward \$35,000.00.
