HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 588

Offered by Representative Ford:

WHEREAS, Four out of five children aged 2 to 17 in the United States live in a home in which either they or their parents access the Internet; and

WHEREAS, Youth who create Internet content and use social networking sites are more likely to be targets of cyber-bullying; and

WHEREAS, Some parents use social media as a means to discipline, embarrass, or coerce their child in order to correct behavior in their child that the parents believe is inappropriate; and

WHEREAS, This type of online victimization is associated with emotional distress and other psychological problems, including depression; and

WHEREAS, Cyber-bullying, especially by parents, can cause psychological harm, including depression, negatively impact academic performance, safety, and the well-being of the child and in some cases lead to extreme violent behavior, including murder and suicide; and

WHEREAS, Sixty percent of mental health professionals who responded to the Survey of Internet Mental Health Issues report having treated at least one patient with a problematic Internet experience in the previous 5 years; many of these clients were under 18 years of age; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Congress, consistent with the First Amendment to the United States Constitution, to pass a law prohibiting parents from cyber-bullying their children by posting messages or images on social media sites on the Internet that embarrass, intimidate, coerce, harass, or cause substantial emotional distress to their children; and be it further

RESOLVED, That suitable copies of this Resolution be forwarded to each member of the Illinois Congressional delegation.

HOUSE RESOLUTION 589

Offered by Representative Sosnowski:

WHEREAS, After Illinois adopted its first Constitution on August 26, 1818, it joined the Union as the 21st state on December 3, 1818; and

WHEREAS, Since its incorporation into the United States of America, Illinois has had 2 official State flags; the first was adopted on July 6, 1915 and the second was adopted on July 1, 1970; for its first 97 years of existence, however, the State of Illinois did not officially adopt a State flag; and

WHEREAS, In 1911, while on a visit to Washington D.C., Ella Park Lawrence, the State Regent of the Daughters of the American Revolution, noticed that the State of Illinois did not have a flag or symbol located in the organization's Memorial Continental Hall; determined to have Illinois adopt a flag, she wrote countless letters to members of the General Assembly in order to have a bill filed creating a State flag; so sincere was her effort that she offered a \$25 prize to the Illinois Daughters of the American Revolution chapter that submitted the best design for a flag; and

WHEREAS, A total of 35 designs were submitted to the Daughters of the American Revolution-sponsored contest; in the end, a 4-person panel decided on the submission of Miss Lucy Derwent of the Rockford Daughters of the American Revolution Chapter; the design, which placed the Great Seal of the State of Illinois before a plain, white background, was simple, yet emphatic and plenary; and

WHEREAS, With the Daughters of the American Revolution competition complete and a winning design selected, State Senator Raymond D. Meeker introduced the bill that was to legalize the flag; Senator Meeker's bill passed both houses and became law on July 6, 1915, thereby becoming the Flag Act of 1915; and

WHEREAS, The Flag Act represented the first official endorsement of a State flag; however, it did not necessarily create a monolithic, uniform symbol; various flag manufacturing companies failed to create a standard design, as each reproduction seemed to deviate from the other; in some cases, the colors would be modified in order to cater to different settings, such as weddings, funerals, and dinners; over 50 years passed before further changes to the flag were made in order to address concerns of uniformity and distinctiveness; and

WHEREAS, In 1968, Chief Petty Officer Bruce McDaniel of Waverly was serving a tour of duty in Vietnam; the Illinois flag was one of many state flags that were hung on the walls of his mess hall, yet he was concerned that there was nothing in the Illinois flag that distinctly demarcated or represented the State of Illinois; he subsequently wrote his representative seeking a remedy; and

WHEREAS, Upon receiving CPO McDaniel's request to modify the design to make it more easily recognizable as Illinoisan, State Representative Jack E. Walker sponsored legislation to amend the original Flag Act of 1915; Representative Walker's bill added the State's name to the flag, yet failed to address the issues which had given way for non-conformity in the flag's design and reproduction; and

WHEREAS, Then-Governor Richard B. Ogilvie appointed a flag committee made up of the State Historian, the Director of the Illinois Information Service, and the State Records Archivist that was entrusted with the task of ascertaining proper flag design specifications; the committee produced a list of 5 recommendations that they believed would ensure uniformity in reproduction of design and color by flag makers; Florence Sanford Hutchinson of Greenfield submitted a flag design that abided by all the required elements stipulated under the committee's specifications; and

WHEREAS, On July 1, 1970, the amendments to the Flag Act went into effect; the sun, water, rock, land, shield, ribbon, and name of the State of Illinois became the codified components of the flag; and

WHEREAS, While there may be things that divide us here in the State of Illinois, many more things unite us; the flag, which contains the words "State Sovereignty, National Union," is a symbol that was crafted by the faithful hands of a Daughter of the American Revolution; 100 years later, that symbol signifies that much more to every Illinoisan; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize and celebrate the centennial of the flag of the State of Illinois, which will reach the one-hundredth year of existence on July 6, 2015; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Rockford Chapter of the Daughters of the American Revolution as a token of our sincere appreciation for their continued commitment to American history, education, and patriotism both in Winnebago County and the State of Illinois.

HOUSE RESOLUTION 591

Offered by Representative David Harris:

WHEREAS, It is necessary to have a Fiscal Year 2016 budget in place in order for State payments to proceed normally for the new Fiscal Year; and

WHEREAS, In order for a budget to take effect, the spending authority authorized in appropriations bills must be passed by the General Assembly and signed by the Governor; and

WHEREAS, There is currently much disagreement between the Governor and the General Assembly as to the level of appropriations and revenue for the Fiscal Year that begins on July 1, 2016; and

WHEREAS, It is possible that there will not be new spending authority passed by the General Assembly and signed by the Governor prior to the beginning of the new Fiscal Year; and

WHEREAS, It is also possible that there could be a significant delay in reaching agreement on spending authority and revenue and that this delay could stretch well into the new Fiscal Year; and

WHEREAS, Many payments made by the State of Illinois will be delayed until there is an agreement; and

WHEREAS, One of the payments that will come due shortly after the beginning of the new Fiscal Year is the payroll for State employees; and

WHEREAS, It is possible that lack of an agreement on spending authority could delay the paychecks of State employees; and

WHEREAS, There are some state expenditures that are on a continuing appropriation; these expenditures do not require an agreement on spending authority prior to the expenditure being made; and

WHEREAS, Public Act 98-682 allows one of the expenditures on a continuing appropriation to be the payment made for salaries to members of the General Assembly; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we believe that it would be inappropriate for members of the General Assembly to receive their salaries in a timely manner when all other State employees are not being paid on time; and be it further

RESOLVED, That we believe that the expenditure of State funds for salaries to members of the General Assembly should not be made until such expenditure is made for the salaries for all State employees.

HOUSE RESOLUTION 592

Offered by Representative Flowers:

WHEREAS, Ride to Freedom, composed of 30 young cyclists from around the world, embarked on a 3,000 mile journey from Los Angeles, California to Washington, D.C. to call attention to the plight of orphaned children of Falun Dafa practitioners who were persecuted and killed by the Chinese Communist Party for their spiritual beliefs; and

WHEREAS, Falun Dafa (also known as Falun Gong) is a traditional Chinese spiritual discipline founded by Mr. Li Hongzhi in 1992 that consists of spiritual and moral teachings, meditation, and exercises based upon the universal principles of truthfulness, compassion, and tolerance; and

WHEREAS, During the mid-1990s, Falun Dafa acquired a large and diverse following, with at least 70 million practitioners at its peak; and

WHEREAS, Falun Dafa has been persecuted in its country of origin since June 10, 1999, when the then-President of the Chinese Communist Party Jiang Zemin ordered the creation of the 6-10 office, an extrajudicial security apparatus designated to "eradicate" Falun Gong; practitioners have been arrested and tortured to death, their children left without families or homes, often pursued by the state, and abused for their parents' beliefs; and

WHEREAS, The young cyclists are rallying their way across the United States, meeting with supporters at every stop before reaching Washington, D.C. to meet with national leaders to expose the persecution; the cycling team will travel to New York City to address the United Nations General Assembly; some riders will then attempt travel to China to rescue specific orphans; and

WHEREAS, The Ride to Freedom team arrives in Illinois on July 4, 2015; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that in recognition of the noble actions of Ride to Freedom in

bringing awareness to the persecution of Falun Dafa and the impact it is having on millions of children and families throughout China and the bravery of the riders who plan to travel to China to rescue children orphaned from the persecution, we do hereby proclaim July 4, 2015 to be Ride to Freedom Day and urge all citizens to commend these determined young riders in bringing peace to Falun Dafa practitioners and their families.
