SYNOPSIS AS INTRODUCED:

55 ILCS 5/5-44010
55 ILCS 5/5-44020

Amends the Local Government Reduction and Efficiency Division of the Counties Code. Provides that the Division applies to all counties (currently, only applies to DuPage, Lake, and McHenry Counties). Excludes community mental health boards and boards established under the County Care for Persons with Developmental Disabilities Act from the definition of "unit of local government". Effective immediately.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The Counties Code is amended by changing
5 Sections 5-44010 and 5-44020 as follows:

6 (55 ILCS 5/5-44010)

7 Sec. 5-44010. Applicability. The powers and authorities
8 provided by this Division 5-44 apply to all counties ~~DuPage,~~
9 ~~Lake, and McHenry Counties~~ and units of local government within
10 such counties.

13 Sec. 5-44020. Definitions. In this Division 5-44:

14 "Fire protection jurisdiction" means a fire protection
15 district, municipal fire department, or service organized
16 under Section 5-1056.1 of the Counties Code, Sections 195 and
17 200 of the Township Code, Section 10-2.1 of the Illinois
18 Municipal Code, or the Illinois Fire Protection District Act.

19 "Governing board" means the individual or individuals who
20 constitute the corporate authorities of a unit of local
21 government.

22 "Unit of local government" or "unit" means any unit of

1 local government located entirely within one county, to which
2 the county board chairman or county executive directly appoints
3 a majority of its governing board with the advice and consent
4 of the county board, but shall not include a fire protection
5 district that directly employs any regular full-time
6 employees, a conservation district organized under the
7 Conservation District Act, ~~or~~ a special district organized
8 under the Water Commission Act of 1985, a community mental
9 health board established under the Community Mental Health
10 Board Act, or a board established under the County Care for
11 Persons with Developmental Disabilities Act.
