1 AMENDMENT TO HOUSE BILL 4223 AMENDMENT NO. \_\_\_\_\_. Amend House Bill 4223 by replacing 2 everything after the enacting clause with the following: 3 "Section 5. The Illinois Public Aid Code is amended by 4 5 changing Section 5-5.01a as follows: (305 ILCS 5/5-5.01a) 6 7 Sec. 5-5.01a. Supportive living facilities program. (a) The Department shall establish and provide oversight 8 for a program of supportive living facilities that seek to 9 promote resident independence, dignity, respect, 10 well-being in the most cost-effective manner. 11 12 A supportive living facility is (i) either a free-standing facility or (ii) a distinct physical and operational entity 13 within a mixed-use building that meets the criteria established 14 in subsection (d) nursing facility. A supportive living 15

facility integrates housing with health, personal care, and

- 1 supportive services and is a designated setting that offers
- 2 residents their own separate, private, and distinct living
- 3 units.
- 4 Sites for the operation of the program shall be selected by
- 5 the Department based upon criteria that may include the need
- for services in a geographic area, the availability of funding,
- 7 and the site's ability to meet the standards.
- 8 (b) Beginning July 1, 2014, subject to federal approval,
- 9 the Medicaid rates for supportive living facilities shall be
- 10 equal to the supportive living facility Medicaid rate effective
- on June 30, 2014 increased by 8.85%. Once the assessment
- 12 imposed at Article V-G of this Code is determined to be a
- 13 permissible tax under Title XIX of the Social Security Act, the
- 14 Department shall increase the Medicaid rates for supportive
- living facilities effective on July 1, 2014 by 9.09%. The
- Department shall apply this increase retroactively to coincide
- 17 with the imposition of the assessment in Article V-G of this
- 18 Code in accordance with the approval for federal financial
- 19 participation by the Centers for Medicare and Medicaid
- 20 Services.
- 21 The Medicaid rates for supportive living facilities
- 22 effective on July 1, 2017 must be equal to the rates in effect
- for supportive living facilities on June 30, 2017 increased by
- 24 2.8%.
- 25 (c) The Department may adopt rules to implement this
- 26 Section. Rules that establish or modify the services,

1	standards, and conditions for participation in the program
2	shall be adopted by the Department in consultation with the
3	Department on Aging, the Department of Rehabilitation
4	Services, and the Department of Mental Health and Developmental
5	Disabilities (or their successor agencies).
6	(d) Subject to federal approval by the Centers for Medicare
7	and Medicaid Services, the Department shall accept for
8	consideration of certification under the program any
9	application for a site or building where distinct parts of the
10	site or building are designated for purposes other than the
11	provision of supportive living services, but only if:
12	(1) those distinct parts of the site or building are
13	not designated for the purpose of providing assisted living
14	services as required under the Assisted Living and Shared
15	Housing Act;
16	(2) those distinct parts of the site or building are
17	completely separate from the part of the building used for
18	the provision of supportive living program services,
19	including separate entrances;
20	(3) those distinct parts of the site or building do not
21	share any common spaces with the part of the building used
22	for the provision of supportive living program services;
23	and
24	(4) those distinct parts of the site or building do not
25	share staffing with the part of the building used for the

provision of supportive living program services.

- (e) Facilities or distinct parts of facilities which are 1
- selected as supportive living facilities and are in good 2
- 3 standing with the Department's rules are exempt from the
- 4 provisions of the Nursing Home Care Act and the Illinois Health
- 5 Facilities Planning Act.
