SYNOPSIS AS INTRODUCED:

105 ILCS 5/10-22.39 105 ILCS 5/34-18.8a new

Amends the School Code. Provides that, at least once every 2 years, a school board shall conduct an in-service training program for all school personnel on the identification of special needs in students and shall be taught appropriate referral techniques. Effective immediately.

STATE MANDATES ACT MAY REQUIRE REIMBURSEMENT 1 AN ACT concerning education.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 4 Section 5. The School Code is amended by changing Section
- 5 10-22.39 and by adding Section 34-18.8a as follows:
- 6 (105 ILCS 5/10-22.39)
- 7 Sec. 10-22.39. In-service training programs.
- 8 (a) To conduct in-service training programs for teachers.
- 9 (b) In addition to other topics at in-service training 10 programs, school guidance counselors, teachers, school social 11 workers, and other school personnel who work with pupils in 12 grades 7 through 12 shall be trained to identify the warning 13 signs of mental illness and suicidal behavior in adolescents
- 14 and teens and shall be taught appropriate intervention and
- 15 referral techniques.
- 16 (c) School guidance counselors, nurses, teachers and other
- 17 school personnel who work with pupils may be trained to have a
- 18 basic knowledge of matters relating to acquired
- immunodeficiency syndrome (AIDS), including the nature of the
- 20 disease, its causes and effects, the means of detecting it and
- 21 preventing its transmission, and the availability of
- 22 appropriate sources of counseling and referral, and any other
- 23 information that may be appropriate considering the age and

- 1 grade level of such pupils. The School Board shall supervise
- 2 such training. The State Board of Education and the Department
- 3 of Public Health shall jointly develop standards for such
- 4 training.
 - (d) In this subsection (d):
- 6 "Domestic violence" means abuse by a family or household
- 7 member, as "abuse" and "family or household members" are
- 8 defined in Section 103 of the Illinois Domestic Violence Act of
- 9 1986.

- "Sexual violence" means sexual assault, abuse, or stalking
- of an adult or minor child proscribed in the Criminal Code of
- 12 1961 or the Criminal Code of 2012 in Sections 11-1.20, 11-1.30,
- 13 11-1.40, 11-1.50, 11-1.60, 12-7.3, 12-7.4, 12-7.5, 12-12,
- 14 12-13, 12-14, 12-14.1, 12-15, and 12-16, including sexual
- violence committed by perpetrators who are strangers to the
- victim and sexual violence committed by perpetrators who are
- 17 known or related by blood or marriage to the victim.
- 18 At least once every 2 years, an in-service training program
- 19 for school personnel who work with pupils, including, but not
- 20 limited to, school and school district administrators,
- 21 teachers, school guidance counselors, school social workers,
- 22 school counselors, school psychologists, and school nurses,
- 23 must be conducted by persons with expertise in domestic and
- 24 sexual violence and the needs of expectant and parenting youth
- and shall include training concerning (i) communicating with
- and listening to youth victims of domestic or sexual violence

- and expectant and parenting youth, (ii) connecting youth 1 2 victims of domestic or sexual violence and expectant and parenting youth to appropriate in-school services and other 3 agencies, programs, and services as needed, and 4 5 implementing the school district's policies, procedures, and 6 with regard to such vouth, 7 confidentiality. At a minimum, school personnel must be trained to understand, provide information and referrals, and address 8 9 issues pertaining to youth who are parents, expectant parents, 10 or victims of domestic or sexual violence.
- 11 (e) At least every 2 years, an in-service training program 12 for school personnel who work with pupils must be conducted by 13 persons with expertise in anaphylactic reactions and 14 management.
- (f) At least once every 2 years, a school board shall conduct in-service training on educator ethics, teacher-student conduct, and school employee-student conduct for all personnel.
- (q) At least once every 2 years, a school board shall
 conduct an in-service training program for all school personnel
 on the identification of special needs in students and shall be
 taught appropriate referral techniques.
