## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

ARTICLE 1

Section 5. The following named amounts, or so much thereof 5 6 as may be necessary, respectively, for the objects and purposes hereinafter named, are appropriated from the General Revenue 7 8 Fund to the Illinois Community College Board for ordinary and 9 contingent expenses: 10 11 For State Contributions to Social 12 For Contractual Services .......325,000 13 14 15 16 17

- 1 Section 10. The sum of \$980,000, or so much thereof as may
- 2 be necessary, is appropriated from the General Revenue Fund to
- 3 Illinois Community College Board for costs associated with
- 4 administering high school equivalency tests.
- 5 Section 15. The sum of \$2,800,000, or so much thereof as
- 6 may be necessary, is appropriated from the General Revenue Fund
- 7 to the Illinois Community College Board for grants to the
- 8 alternative schools network and other providers for educational
- 9 purposes or bridge programs.
- 10 Section 20. The sum of \$150,000 or so much thereof as may
- 11 be necessary, is appropriated from the General Revenue Fund to
- 12 the Illinois Community College Board for support of the P-20
- 13 Council.
- 14 Section 25. The amount of \$500,000, or so much thereof as
- may be necessary, is appropriated from the General Revenue Fund
- 16 to the Illinois Community College Board for Career and
- 17 Technical Education Licensed Practical Nurse and Registered
- 18 Nurse Preparation.
- 19 Section 30. The sum of \$60,200, or so much thereof as may
- 20 be necessary, is appropriated from the General Revenue Fund to
- 21 the Illinois Community College Board for awarding scholarships

- 1 to qualifying graduates of the Lincoln's Challenge Program.
- 2 Section 35. The sum of \$11,697,900, or so much thereof as
- 3 may be necessary, is appropriated from the General Revenue Fund
- 4 to the Illinois Community College Board for the City Colleges
- of Chicago for educational-related expenses.
- 6 Section 40. The following named amounts, or so much thereof
- 7 as may be necessary, respectively, are appropriated from the
- 8 General Revenue Fund to the Illinois Community College Board
- 9 for distribution to qualifying public community colleges for

- Section 70. The sum of \$300,000, or so much thereof as may be necessary, is appropriated from ICCB Instructional Development and Enhancement Applications Revolving Fund to the Illinois Community College Board for costs associated with maintaining and updating instructional technology.
- Section 75. The sum of \$500,000, or so much thereof as may be necessary, is appropriated from the High School Equivalency Testing Fund to the Illinois Community College Board for costs associated with administering high school equivalency tests.
- Section 80. The sum of \$12,500,000, or so much thereof as may be necessary, is appropriated from the Illinois Community
  College Board Contracts and Grants Fund to the Illinois
  Community College Board to be expended under the terms and conditions associated with the moneys being received, including prior year expenditures.

- 1 Section 85. The sum of \$525,000, or so much thereof as may
- 2 be necessary, is appropriated from the ICCB Federal Trust Fund
- 3 to the Illinois Community College Board for ordinary and
- 4 contingency expenses of the Board.
- 5 Section 90. The sum of \$1,250,000, or so much thereof as
- 6 may be necessary, is appropriated from the ICCB Adult Education
- 7 Fund to the Illinois Community College Board for operational
- 8 expenses associated with administration of adult education and
- 9 literacy activities.
- 10 Section 99. Effective date. This Act takes effect July 1,
- 2017, if and only if Senate Bill 2063 of the 100<sup>th</sup> General
- 12 Assembly (the Unbalanced Budget Response Act), as introduced
- in the Illinois Senate, becomes law.
