### SYNOPSIS AS INTRODUCED:

Makes various appropriations to the Office of the Attorney General for the fiscal year ending June 30, 2018. Effective July 1, 2017.

A BILL FOR

1 AN ACT making appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 Section 5. The sum of \$30,843,200, or so much thereof as  
5 may be necessary, is appropriated from the General Revenue Fund  
6 to the Office of the Attorney General to meet its operational  
7 expenses for the fiscal year ending June 30, 2018.

8 Section 10. The sum of \$1,400,000, or so much thereof as  
9 may be necessary, is appropriated from the General Revenue Fund  
10 to the Office of the Attorney General for disbursement to the  
11 Illinois Equal Justice Foundation for use as provided in the  
12 Illinois Equal Justice Act.

13 Section 15. The sum of \$1,000,000, or so much thereof as  
14 is available for use by the Attorney General, is appropriated  
15 to the Attorney General from the Illinois Gaming Law  
16 Enforcement Fund for State law enforcement purposes.

17 Section 20. The sum of \$13,200,000, or so much thereof as  
18 may be necessary, is appropriated from the Attorney General  
19 Court Ordered and Voluntary Compliance Payment Projects Fund  
20 to the Office of the Attorney General for use, subject to

1     pertinent court order or agreement, in the performance of any  
2     function pertaining to the exercise of the duties of the  
3     Attorney General, including State law enforcement and public  
4     education.

5             Section 25. The sum of \$1,700,000, or so much thereof as  
6     may be necessary, is appropriated from the Illinois Charity  
7     Bureau Fund to the Office of the Attorney General to enforce  
8     the provisions of the Solicitation for Charity Act and to gather  
9     and disseminate information about charitable trustees and  
10    organizations to the public.

11            Section 30. The sum of \$7,000,000, or so much thereof as  
12    may be necessary, is appropriated from the Attorney General  
13    Whistleblower Reward and Protection Fund to the Office of the  
14    Attorney General for ordinary and contingent expenses,  
15    including State law enforcement purposes.

16            Section 35. The sum of \$11,300,000, or so much thereof as  
17    may be necessary, is appropriated from the Attorney General's  
18    State Projects and Court Ordered Distribution Fund to the  
19    Attorney General for payment of interagency agreements, for  
20    court-ordered distributions to third parties, and, subject to  
21    pertinent court order, for performance of any function  
22    pertaining to the exercise of the duties of the Attorney

1 General, including State law enforcement and public education.

2 Section 40. The following named sums, or so much thereof  
3 as may be necessary, respectively, for the objects and purposes  
4 named in this Section, are appropriated to the Attorney General  
5 to meet the ordinary and contingent expenses of the Attorney  
6 General:

22 Section 45. The sum of \$1,000,000, or so much thereof as  
23 may be necessary, is appropriated from the Attorney General

1 Federal Grant Fund to the Office of the Attorney General for  
2 funding for federal grants.

3 Section 50. The sum of \$500,000, or so much thereof as may  
4 be necessary, is appropriated to the Office of the Attorney  
5 General from the Domestic Violence Fund pursuant to Public Act  
6 95-711 for grants to public or private nonprofit agencies for  
7 the purposes of facilitating or providing free domestic  
8 violence legal advocacy, assistance, or services to victims of  
9 domestic violence who are married or formerly married or  
10 parties or former parties to a civil union related to order of  
11 protection proceedings, or other proceedings for civil remedies  
12 for domestic violence.

13 Section 55. The sum of \$2,500,000, or so much thereof as  
14 may be necessary, is appropriated from the Attorney General  
15 Tobacco Fund to the Office of the Attorney General for the  
16 oversight, enforcement, and implementation of the Master  
17 Settlement Agreement entered in the case of People of the State  
18 of Illinois v. Philip Morris, et al (Circuit Court of Cook  
19 County, No. 96L13146), for the administration and enforcement  
20 of the Tobacco Product Manufacturers' Escrow Act, for the  
21 handling of tobacco-related litigation, and for other law  
22 enforcement activities of the Attorney General.

1           Section 60. The sum of \$250,000, or so much thereof as may  
2           be necessary, is appropriated from the Attorney General Sex  
3           Offender Awareness, Training, and Education Fund to the Office  
4           of the Attorney General to administer the I-SORT program and  
5           to alert and educate the public, victims, and witnesses of  
6           their rights under various victim notification laws and for  
7           training law enforcement agencies, State's Attorneys, and  
8           medical providers regarding their legal duties concerning the  
9           prosecution and investigation of sex offenses.

10           Section 70. The sum of \$1,400,000, or so much thereof as  
11           may be necessary, is appropriated from the Access to Justice  
12           Fund to the Office of the Attorney General for disbursement to  
13           the Illinois Equal Justice Foundation pursuant to the Access  
14           to Justice Act.

15           Section 99. Effective date. This Act takes effect July 1,  
16           2017.
