

## 100TH GENERAL ASSEMBLY State of Illinois 2017 and 2018 SB2334

Introduced 1/24/2018, by Sen. Laura M. Murphy

## SYNOPSIS AS INTRODUCED:

110 ILCS 330/6.7 new 210 ILCS 85/7.7 new

Amends the University of Illinois Hospital Act and Hospital Licensing Act. Provides that a hospital shall maintain a metal detector at each point of entry into the hospital. Provides that a hospital shall ensure that all members of the public, other than the employees of the hospital who display proper credentials, who enter the hospital at a point of entry are subjected to screening by a metal detector. Provides that individuals subject to screening shall include, but not be limited to, individuals in wheelchairs. Defines "point of entry". Effective July 1, 2018.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The University of Illinois Hospital Act is amended by adding Section 6.7 as follows:
- 6 (110 ILCS 330/6.7 new)
- Sec. 6.7. Metal detectors required. As used in this

  Section, "point of entry" means an entrance accessible to the

  public. "Point of entry" does not include ambulance entrances.
- 10 The University of Illinois Hospital shall maintain a metal detector at each point of entry into the University of Illinois 11 12 Hospital. A hospital licensed under this Act shall maintain a metal detector at each point of entry into the hospital. A hospital shall ensure that all members of the public, other than the employees of the hospital who display proper credentials, who enter the hospital at a point of entry are subjected to screening by a metal detector. Individuals subject to screening under this Section shall include, but not be limited to, individuals in wheelchairs.

Section 99. Effective date. This Act takes effect July 1, 2018.
