Makes appropriations for the ordinary and contingent expenses of the Board of Trustees of the University of Illinois for the fiscal year beginning July 1, 2018, as follows:

A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The sum of \$14,803,100, or so much thereof as
6 may be necessary, is appropriated from the General Revenue Fund
7 to the Board of Trustees of the University of Illinois for
8 costs and expenses related to or in support of the Prairie
9 Research Institute, in accordance with Public Act 95-0728.

10 Section 10. The sum of \$39,588,800, or so much thereof as
11 may be necessary, is appropriated from the General Revenue Fund
12 to the Board of Trustees of the University of Illinois for
13 operating costs and expenses related to or in support of the
14 University of Illinois Hospital.

15 Section 15. The amount of \$528,614,000, or so much thereof
16 as may be necessary, is appropriated from the Education
17 Assistance Fund to the Board of Trustees of the University of
18 Illinois to meet its operational expenses for the fiscal year
19 ending June 30, 2019.

1 Section 20. The sum of \$4,155,700, or so much thereof as
2 may be necessary, is appropriated from the Fire Prevention Fund
3 to the Board of Trustees of the University of Illinois for the
4 purpose of maintaining the Illinois Fire Service Institute,
5 paying the Institute's expenses, and providing the facilities
6 and structures incident thereto, including payment to the
7 University for personal services and related costs incurred.

8 Section 25. The sum of \$250,000, or so much thereof as may
9 be necessary, is appropriated from the State College and
10 University Trust Fund to the Board of Trustees of the University
11 of Illinois for scholarship grant awards.

12 Section 30. The sum of \$200,000, or so much thereof as may
13 be necessary, is appropriated from the Emergency Public Health
14 Fund to the University of Illinois for costs and expenses
15 related to or in support of Emergency Mosquito Abatement.

16 Section 35. The sum of \$200,000, or so much thereof as may
17 be necessary, is appropriated from the Used Tire Management
18 Fund to the University of Illinois for costs and expenses
19 related to or in support of mosquito research and abatement.

20 Section 40. The sum of \$500,000, or so much thereof as may
21 be necessary, is appropriated from the Hazardous Waste Research

1 Fund to the University of Illinois for its ordinary and
2 contingent expenses.

3 Section 45. The sum of \$500,000, or so much thereof as may
4 be necessary, is appropriated from the General Professions
5 Dedicated Fund to the Board of Trustees of the University of
6 Illinois for costs associated with the development, support or
7 administration of pharmacy practice education or training
8 programs for the College of Medicine at Rockford.

9 Section 99. Effective Date. This Act takes effect July 1,
10 2018. Notwithstanding anything in this Act to the contrary,
11 appropriations authorized in this Act shall be used for all
12 costs incurred prior to July 1, 2019.
