SENATE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT SC0007

Introduced 2/7/2017, by Sen. Melinda Bush

SYNOPSIS AS INTRODUCED:

ILCON Art. IV, Sec. 6
ILCON Art. V, Sec. 2

Proposes to amend the Legislative and Executive Articles of the Illinois Constitution. Provides that a person who has served four two-year terms as Speaker of the House of Representatives, President of the Senate, Minority Leader of the House of Representatives, or Minority Leader of the Senate may not be reelected to the same office. Provides that service before the second Wednesday in January of 2019 shall not be considered in the calculation of a person's service. Provides that a person may not be elected to the office of Governor or Lieutenant Governor for terms totalling more than eight years for each office. Provides that service before the second Monday in January of 2019 shall not be considered in the calculation of a person's service.

- 15 (a) A majority of the members elected to each house constitutes a quorum.
- 17 (b) On the first day of the January session of the General
 18 Assembly in odd-numbered years, the Secretary of State shall
 19 convene the House of Representatives to elect from its
 20 membership a Speaker of the House of Representatives as
 21 presiding officer, and the Governor shall convene the Senate to
 22 elect from its membership a President of the Senate as
 23 presiding officer.

(c) For purposes of powers of appointment conferred by this

- 2 Constitution, the Minority Leader of either house is a member 3 of the numerically strongest political party other than the party to which the Speaker or the President belongs, as the 4 5 case may be. A person who has served four two-year terms as
- Speaker of the House of Representatives, President of the 6
- 7 Senate, Minority Leader of the House of Representatives, or
- 8 Minority Leader of the Senate may not be re-elected to the same
- 9 office. Service before the second Wednesday in January of 2019
- shall not be considered in the calculation of a person's 10

- shall 12 Each house determine the rules $\circ f$ its (d) 13 proceedings, judge the elections, returns and qualifications of its members and choose its officers. No member shall be 14 expelled by either house, except by a vote of two-thirds of the 15
- 16 members elected to that house. A member may be expelled only
- 17 once for the same offense. Each house may punish by
- imprisonment any person, not a member, guilty of disrespect to 18
- 19 the house by disorderly or contemptuous behavior in its
- 20 presence. Imprisonment shall not extend beyond twenty-four
- 21 hours at one time unless the person persists in disorderly or
- 22 contemptuous behavior.

SECTION 2. TERMS

These elected officers of the Executive Branch shall hold office for four years beginning on the second Monday of January after their election and, except in the case of the Lieutenant Governor, until their successors are qualified. They shall be elected at the general election in 1978 and every four years thereafter. A person may not be elected to the office of Governor or Lieutenant Governor for terms totalling more than eight years for each office. Service before the second Monday in January of 2019 shall not be considered in the calculation of a person's service.
