Amends the Rehabilitation of Persons with Disabilities Act. Makes a technical change in a Section concerning services for the visually impaired.

AN ACT concerning State government.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The Rehabilitation of Persons with Disabilities
Act is amended by changing Section 12 as follows:

6 (20 ILCS 2405/12) (from Ch. 23, par. 3443)

7 Sec. 12. Services for the visually impaired. The The 8 Department shall provide community services for persons with 9 visual disabilities at the Illinois Center for Rehabilitation and Education to promote the general welfare and rehabilitation 10 of persons with major visual disabilities and provide such 11 related services as will promote independent living, lessen the 12 limitations of their disability, teach them vocational and 13 14 other skills, and assist in making them self-supporting and responsible citizens of their communities. The community 15 16 services program shall provide such instruction and intensive 17 rehabilitation training service individually or in groups as is deemed necessary and practicable for each individual case, 18 19 using the best appliances, skills, and specialist services 20 known. The Center shall carry out these purposes by providing 21 appropriate training in a residential center for persons with 22 visual disabilities who are found to be qualified for such 23 training.

In order to facilitate the training and rehabilitation of 1 2 persons with major visual disabilities in industrial work processes and provide necessary services, the Center and the 3 community services program shall have authority to seek and 4 5 negotiate contracts with agencies, individuals, firms, manufacturers or corporations for the repair of machines or 6 7 equipment for persons with visual disabilities and for 8 separating, sorting, packaging, tying, wrapping, or otherwise 9 putting together small objects. The rates charged for such work 10 shall be reasonable and adequate, and comparable to those paid 11 other persons for similar services, except as the projects are 12 used for training and rehabilitation of persons with visual 13 disabilities who may not be compensated during the period of 14 training.

15 All money which has been or may be paid to, or is received 16 as payment for such work shall be deposited in an approved bank 17 or savings and loan association in a special account known as the Industrial Project Fund. All deposits and expenditures of 18 the Industrial Project Fund shall be made under the direction 19 20 of the Department and in accordance with its rules and regulations. Expenditures shall be limited to salaries and 21 22 wages paid to the persons with visual disabilities performing 23 the work and for necessary supplies, expenses and equipment facilitate and operate such training and 24 required to employment, and for the benefit, special comfort, pleasure, 25 amusement and rehabilitation of all persons with visual 26

1 disabilities receiving services from the Department.

No bank or savings and loan association shall receive public funds as permitted by this Section, unless it has complied with the requirements established under Section 6 of the Public Funds Investment Act.
