SYNOPSIS AS INTRODUCED:

Amends the Rescue Squad Districts Act. Provides that a rescue squad district may fix, charge, and collect fees for rescue squad services and ambulance services within or outside of the rescue squad district not exceeding the reasonable cost of the service. Effective immediately.

1 AN ACT concerning local government.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Rescue Squad Districts Act is amended by changing Section 11 as follows:
- 6 (70 ILCS 2005/11) (from Ch. 85, par. 6861)
- 7 Sec. 11. Property tax; fees.
 - (a) A rescue squad district organized under this Act may levy and collect a general tax on the property situated in the district, but the aggregate amount of taxes levied for any one year shall not exceed the rate of .20% of value, as equalized or assessed by the Department of Revenue. The board of trustees shall determine and certify the amount to be levied and shall return the same to the county clerk. The limitation upon the tax rate may be increased or decreased under the referendum provisions of the General Revenue Law of Illinois.

In case the district is located in more than one county, the board of trustees shall determine and certify the amount to be levied upon the taxable property lying in each county and return the same to the respective county clerks of the counties in which the amount is to be levied. In order to determine the amount to be levied upon the taxable property of that part of the district lying in each county, the board shall ascertain

from the county clerk of the respective counties in which the 1 2 district lies the last ascertained equalized value of the 3 taxable property of the district lying in their respective counties, then shall ascertain the rate per cent required and 5 shall, accordingly, apportion the whole amount to be raised between the several parts of the district so lying in the 6 different counties. The tax provided for in this Section shall 7 8 be levied at the same time and in the same manner as nearly as 9 practicable as taxes are now levied for municipal purposes 10 under the laws of this State.

All general taxes under this Act, when collected, shall be paid over to the treasurer of the board of trustees, who is authorized to receive and receipt for the same.

(b) A rescue squad district organized under this Act may fix, charge, and collect fees for rescue squad services and ambulance services within or outside of the rescue squad district not exceeding the reasonable cost of the service.
