

## 101ST GENERAL ASSEMBLY State of Illinois 2019 and 2020 SB0094

Introduced 1/23/2019, by Sen. Chuck Weaver

## SYNOPSIS AS INTRODUCED:

25 ILCS 170/4.6 new

Amends the Lobbyist Registration Act. Requires lobbyists to file with the Secretary of State a written statement that describes the procedures that the lobbyist and lobbyist's client will follow if the lobbyist or client determines that the lobbyist's representation of the client creates a conflict of interest. Prohibits a lobbyist from representing a client if the representation involves a conflict of interest, unless otherwise provided in the agreement between the lobbyist and the party he or she represents.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Lobbyist Registration Act is amended by adding Section 4.6 as follows:
- 6 (25 ILCS 170/4.6 new)
- 7 <u>Sec. 4.6. Lobbyist conflict of interest.</u>
- 8 (a) Except as provided in subsection (c), this Section does
  9 not apply to a lobbyist if the lobbyist's activity under this
- 10 <u>Section is governed by the Illinois Rules of Professional</u>
- 11 <u>Conduct of 2010 of the Illinois Supreme Court.</u>
- 12 <u>(b) As used in this Section, "conflict of interest" means a</u>
  13 circumstance where:
- 14 <u>(1) the representation of a client will be directly</u>
  15 adverse to another client; or
- 16 (2) there is a significant risk that the representation

  17 of one or more clients will be materially limited by the

  18 lobbyist's responsibilities to (i) another client or (ii) a

  19 personal interest of the lobbyist.
- 20 <u>(c) A lobbyist shall file with the Secretary of State a</u>
  21 <u>written statement that describes the procedures that the</u>
  22 <u>lobbyist and the lobbyist's client will follow if the lobbyist</u>
  23 or client determines at any time that the lobbyist's

1	representation of the client might involve a conflict of
2	interest. The lobbyist shall file the statement with the
3	Secretary at the time the lobbyist files the lobbyist's annual
4	registration. If the lobbyist's activity under this Section is
5	governed by the Illinois Rules of Professional Conduct of 2010
6	of the Illinois Supreme Court, the lobbyist shall file a

- 7 statement to that effect with the Secretary.
  8 (d) The statement filed under subsection (c) must be
  9 included in the agreement between the lobbyist and the client
- for the lobbyist's services as a lobbyist.
- 11 <u>(e) A lobbyist may not represent a client if the</u>
  12 <u>representation involves a conflict of interest, except as is</u>
  13 <u>provided in the statement filed by the lobbyist under</u>
  14 subsection (c).
