## SYNOPSIS AS INTRODUCED:

Amends the Illinois Act on the Aging. Defines "greatest social need" for the purpose of a specified rule. Makes a conforming change. Amends the Assisted Living and Shared Housing Act. Prohibits unlawful discrimination by an owner, licensee, administrator, employee, or agent of an assisted living establishment of residents in assisted living establishments. Provides that unlawful discrimination does not include an action by an owner, licensee, administrator, employee, or agent that is required by the Act or rules adopted under the Act. Effective immediately.

4 Section 5. The Illinois Act on the Aging is amended by 5 changing Section 3 and by adding Section 3.11 as follows:

Sec. 3. As used in this Act, unless the context otherwise

Sec. 3.11. Greatest social need. For the purposes of 89 12 13 Ill. Adm. Code 210.50, "greatest social need" means the need caused by noneconomic factors that restrict an individual's 14 15 ability to perform normal daily tasks or that threaten his or her capacity to live independently. These factors include 16 17 physical or mental disability, language barriers, and cultural 18 or social isolation caused by, among other things, racial and ethnic status, sexual orientation, gender identity, gender 19 20 expression, or HIV status.

#### 2 (210 ILCS 9/97 new) 3 Sec. 97. Unlawful discrimination. No resident shall be subjected to unlawful discrimination as defined in Section 4 1-103 of the Illinois Human Rights Act by any owner, licensee, 5 administrator, employee, or agent of an assisted living 6 establishment. Unlawful discrimination does not include an 7 action by any owner, licensee, administrator, employee, or 8 agent of an assisted living establishment that is required by 9 10 this Act or rules adopted under this Act.

Section 99. Effective date. This Act takes effect upon becoming law.
