12 Section 215. The sum of \$40,000,000, or so much thereof  
13 as may be necessary, is appropriated from the Public  
14 Transportation Fund to the Department of Transportation for  
15 making a grant to the Regional Transportation Authority for  
16 Additional State Assistance to be used for its purposes as  
17 provided in the "Regional Transportation Authority Act", but

1           Section 220. The sum of \$91,000,000, or so much thereof  
2 as may be necessary, is appropriated from the Public  
3 Transportation Fund to the Department of Transportation for  
4 making a grant to the Regional Transportation Authority for  
5 Additional Financial Assistance to be used for its purposes as  
6 provided in the "Regional Transportation Authority Act", but  
7 in no event shall this amount exceed the amount provided for  
8 in Sections 4.09 (c-5) and 4.09 (d) with respect to Strategic  
9 Capital Improvement bonds issued by the Regional Transportation  
10 Authority pursuant to the Regional Transportation Authority Act  
11 as amended in 1999.

12           Section 225. The sum of \$17,570,000, or so much thereof  
13 as may be necessary, is appropriated from the Road Fund to the  
14 Department of Transportation for grants to the Regional  
15 Transportation Authority intended to reimburse the Service  
16 Boards for providing reduced fares on mass transportation  
17 services for students, handicapped persons, and the elderly,  
18 to be allocated proportionally among the Service Boards based  
19 upon actual costs incurred by each Service Board for such  
20 reduced fares.

21           Section 230. The sum of \$8,394,800, or so much thereof as  
22 may be necessary, is appropriated from the Road Fund to the
