**SYNOPSIS AS INTRODUCED:**

20 ILCS 2905/3

from Ch. 127 1/2, par. 3

Amends the State Fire Marshal Act. Corrects typographical errors and includes the Illinois Chapter of the International Association of Arson Investigators in the organizations from which ex officio members of the Illinois Fire Advisory Commission shall serve. Effective immediately.

**A BILL FOR**

1 AN ACT concerning fire safety.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The State Fire Marshal Act is amended by  
5 changing Section 3 as follows:

6 (20 ILCS 2905/3) (from Ch. 127 1/2, par. 3)

7 Sec. 3. There is created the Illinois Fire Advisory  
8 Commission which shall advise the Office in the exercise of its  
9 powers and duties. The Commission shall be appointed by the  
10 Governor as follows:

11 3 professional, full-time ~~fulltime~~ paid firefighters;

12 one volunteer firefighter;

13 one Fire Protection Engineer who is registered in Illinois;

14 one person who is a representative of the fire insurance  
15 ~~Fire Insurance~~ industry in Illinois;

16 one person who is a representative of a registered United  
17 States Department of Labor apprenticeship program primarily  
18 instructing in the installation and repair of fire  
19 extinguishing systems;

20 one ~~a~~ licensed operating or stationary engineer who has an  
21 associate degree in facilities engineering technology and has  
22 knowledge of the operation and maintenance ~~maintenance~~ of fire  
23 alarm and fire extinguishing systems primarily for the life

1 safety of occupants in a variety of commercial or residential  
2 structures; and

3 3 persons with an interest in and knowledgeable about fire  
4 prevention methods.

5 In addition, the following shall serve as ex officio  
6 members of the Commission: the Chicago Fire Commissioner, or  
7 his or her designee; the executive officer, or his or her  
8 designee, of each of the following organizations: the Illinois  
9 Fire Chiefs Association, the Illinois Fire Protection District  
10 Association, the Illinois Fire Inspectors Association, the  
11 Illinois Professional Firefighters Association, the Illinois  
12 Firemen's Association, the Associated Firefighters of  
13 Illinois, the Illinois Society of Fire Service Instructors, the  
14 Illinois Chapter of the International Association of Arson  
15 Investigators, and the Fire Service Institute, University of  
16 Illinois.

17 The Governor shall designate, at the time of appointment, 3  
18 members to serve terms expiring on the third Monday in January,  
19 1979; 3 members to serve terms expiring the third Monday in  
20 January, 1980; and 2 members to serve terms expiring the third  
21 Monday in January, 1981. The additional member appointed by the  
22 Governor pursuant to Public Act 85-718 ~~this amendatory Act of~~  
23 ~~1987~~ shall serve for a term expiring the third Monday in  
24 January, 1990. Thereafter, all terms shall be for 3 years. A  
25 member shall serve until his or her successor is appointed and  
26 qualified. A vacancy shall be filled for the unexpired term.

1           The Governor shall designate one of the appointed members  
2 to be chairperson ~~chairman~~ of the Commission.

3           Members shall serve without compensation but shall be  
4 reimbursed for their actual reasonable expenses incurred in the  
5 performance of their duties.
