SYNOPSIS AS INTRODUCED:

225 ILCS 10/25 new 30 ILCS 105/5.990 new

Amends the Child Care Act of 1969. Provides that subject to appropriation, the Department of Children and Family Services shall create and implement a 3-year pilot program to provide grants to underserved units of local government to establish licensed day care centers within local government facilities for local government employees, visitors, and eligible residents who reside in the local government's jurisdiction. Provides that the Department shall arrange for an evaluation of the pilot program to determine whether the pilot program is successfully supporting local government employees. Provides that at the end of the 3-year pilot program, the Department shall submit a report to the General Assembly with its findings from the evaluation. Provides that the report shall state whether the Department intends to continue the pilot program and the rationale for its decision. Provides that the Department may adopt rules and procedures to implement and administer the program. Creates the Local Government Facilities Day Care Fund and makes a corresponding change in the State Finance Act.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Child Care Act of 1969 is amended by adding
Section 25 as follows:

Sec. 25. Local government facilities day care centers grant program.
(a) Subject to appropriation, the Department shall create
and implement a 3-year pilot program to provide grants to
underserved units of local government to establish licensed
day care centers within local government facilities for local

13 government employees, visitors, and eligible residents who 14 reside in the local government's jurisdiction.

(b) The Local Government Facilities Day Care Fund is 15 created as a special fund in the State treasury. The fund shall 16 17 consist of any money appropriated to the Department for the local government facilities day care centers grant program. 18 Money in the fund shall be expended for the local government 19 20 facilities day care centers grant program and for no other 21 purpose. All interest earned on money in the fund shall be 22 deposited into the fund.

23 (c) The Department shall arrange for an evaluation of the

pilot program to determine whether the pilot program is
 successfully supporting local government employees. This
 evaluation shall support the determination of whether there is
 a long-term cost benefit to continuing the pilot program.

5 <u>(d) At the end of the 3-year pilot program, the Department</u> 6 <u>shall submit a report to the General Assembly with its</u> 7 <u>findings from the evaluation. The report shall state whether</u> 8 <u>the Department intends to continue the pilot program and the</u> 9 rationale for its decision.

(e) The Department may adopt rules and procedures to implement and administer this Section.
