Sec. 40. Acquisition.

(a) The Authority may, but need not, acquire title to
any project with respect to which it exercises its authority.
(b) The Authority shall have power to acquire by
purchase, lease, gift, or otherwise any property or rights
therein from any person, the State of Illinois, any municipal
corporation, any local unit of government, the government of
the United States, any agency or instrumentality of the

1 United States, any body politic, or any county useful for its 2 purposes, whether improved for the purposes of any 3 prospective project or unimproved. The Authority may also 4 accept any donation of funds for its purposes from any of 5 those sources.

6 (c) The Authority shall have power to develop, 7 construct, and improve, either under its own direction or 8 through collaboration with any approved applicant, or to 9 acquire through purchase or otherwise any project, using for that purpose the proceeds derived from its sale of revenue 10 11 bonds, notes, or other evidences of indebtedness or governmental loans or grants, and to hold title in the name 12 of the Authority to those projects. 13

The Authority shall have the power to enter 14 (d) into intergovernmental agreements with the State of Illinois, the 15 16 county of Will, the Illinois Development Finance Authority, the Illinois Education Facilities Authority, the Metropolitan 17 Pier and Exposition Authority, the United States government, 18 19 any agency or instrumentality of the United States, any unit of local government located within the territory of the 20 Authority, or any other unit of government to the extent 21 VII, Section 10 of the Illinois 22 allowed by Article 23 Constitution and the Intergovernmental Cooperation Act.

(e) The Authority shall have the power to share
employees with other units of government, including agencies
of the United States, agencies of the State of Illinois, and
agencies or personnel of any unit of local government.

(f) Subject to subsection (i) of Section 35 of this Act, the Authority shall have the power to exercise powers and issue revenue bonds as if it were a municipality so authorized in Divisions 12.1, 74, 74.1, 74.3, and 74.5 of Article 11 of the Illinois Municipal Code.

33 (g) All property belonging to the Joliet Arsenal
 34 Development Authority is exempt from property taxes.
