2 AMENDMENT NO. _____. Amend Senate Bill 562, AS AMENDED,
3 with reference to page and line numbers of House Amendment No.
4 1, on page 2, line 21, by inserting after the comma the
5 following:

6 "methamphetamine waste site or other methamphetamine-related
7 site"; and

8 on page 2, line 22, by deleting "methamphetamine"; and

9 on page 2, by inserting immediately below line 30 the
10 following:

11 "'Finished methamphetamine" means methamphetamine in a
12 form commonly used for personal consumption."; and

13 on page 3, line 1, by replacing "or extract" with "extract, or
14 package"; and

15 on page 3, by replacing lines 5 through 8 with the following:

16 "'Methamphetamine" means the chemical methamphetamine (a
17 Schedule II controlled substance under the Illinois Controlled
18 Substances Act) or any salt, optical isomer, salt of optical
19 isomer, or analog thereof, with the exception of
20 3,4-Methylenedioxymethamphetamine (MDMA) or any other
21 scheduled substance with a separate listing under the Illinois
22 Controlled Substances Act."; and

1 on page 4, by replacing lines 3 and 4 with "."; and

2 on page 4, line 10, by replacing "or diluted" with ", diluted,
3 or washed"; and

4 on page 4, by replacing lines 14 through 17 with the following:
5 "is left over from, results from, or is produced by the process
6 of manufacturing methamphetamine, other than finished
7 methamphetamine."; and

8 on page 4, line 31, by replacing "or extract" with "extract, or
9 package"; and

10 on page 5, line 11, by inserting ", or to cause another to take
11 such action" after "means"; and

12 on page 5, line 34, by inserting "anhydrous ammonia tankers,"
13 after "pipelines,"; and

14 on page 17, line 32, by replacing "over" with "at least"; and

15 on page 18, line 2, by replacing "over" with "at least"; and

16 on page 21, by replacing lines 11 and 12 with the following:

19 be subject to forfeiture to the"; and

25 on page 375, by deleting lines 14 through 16; and

26 on page 376, by replacing lines 27 through 32 with the
