- Code. I understand that willfully filing a false or incomplete 16
- statement is a business offense subject to a fine of at least 17

- 5 (e) Any business entity required to register under

- whose identity is required to be disclosed under subsection 7
- (b), shall give notice to any political committee to which it 8
- 9 makes a contribution, at the time of the contribution, of the
- 10 fact that the relevant business entity has contracts with State
- agencies that, in the aggregate, annually total more than 11
- \$50,000. 12

- (f) Business entities, affiliated entities, and affiliated 16
