## ARTICLE 1

5	Section 15. The following named sums, or so much thereof

18 Section 20. The following named sum, or so much thereof 19 as may be necessary, is appropriated from the Illinois 20 Affordable Housing Trust Fund to the Department of Veterans' 21 Affairs for the object and purpose and in the amount set HB6545 Engrossed

1 forth as follows:

The sum of \$842,500, or so much thereof as Section 25. 3 may be necessary, is appropriated from the General Revenue 4 5 Fund to the Department of Veterans' Affairs for the payment of scholarships to students who are dependents of Illinois 6 resident military personnel declared to be prisoners of war, 7 missing in action, killed or permanently disabled, 8 as 9 provided by law.

10 Section 30. The sum of \$750,000, or so much thereof as 11 may be necessary, is appropriated from the General Revenue 12 Fund to the Department of Veterans' Affairs for costs 13 associated with Post Traumatic Stress Disorder Outpatient 14 Counseling Program.

15 Section 40. The sum of \$250,000, or so much thereof as 16 may be necessary, is appropriated from the Illinois Military 17 Family Relief Fund to the Department of Veterans' Affairs for 18 the payment of benefits authorized under the Survivor's 19 Compensation Act.

20 Section 50. The sum of \$8,000,000, or so much thereof as 21 may be necessary, is appropriated from the Illinois Veterans HB6545 Engrossed -3- LRB095 21176 RCE 50373 b

Assistance Fund to the Department of Veterans' Affairs for 1 making grants, funding additional services, or conducting 2 additional research projects relating to veterans' 3 post traumatic stress disorder; veterans' homelessness; the health 4 insurance cost of veterans; veterans' disability benefits, 5 6 including but not limited to, disability benefits provided by veterans service organizations and veterans assistance 7 commissions or centers; and the long-term care of veterans. 8

9 Section 87. In addition to amounts appropriated for this 10 purpose, the sum of \$6,000,000, or so much thereof as may be 11 necessary, is appropriated from the General Revenue Fund to 12 the Department of Veterans' Affairs for the 80 bed expansion 13 at the Illinois Veterans' Home at LaSalle.

## ARTICLE 998

15 Section 998. Each of the amounts appropriated in this 16 Act (after all actions by the Governor and the General 17 Assembly) controls over any lower amount appropriated in any 18 other Public Act (after all actions by the Governor and the 19 General Assembly) for the same purpose unless that other 20 Public Act expressly states otherwise.
