#### SYNOPSIS AS INTRODUCED:

105 ILCS 5/21-5b

Amends the School Code. With respect to the Alternative Teacher Certification program, provides that a provisional alternative teaching certificate may be issued to an applicant who has attained at least a cumulative grade average of a "B" if the individual is assigned either to a school district that has not met the annual measurable objective for highly qualified teachers required by the Illinois Revised Highly Qualified Teachers (HQT) Plan or to a school district whose data filed with the State Board of Education indicates that the district's poor and minority students are taught by teachers who are not highly qualified at a higher rate than other students (instead of just if the applicant has been employed for a period of at least 5 years in an area requiring application of the individual's education). Effective immediately.

A BILL FOR

1 AN ACT concerning education.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The School Code is amended by changing Section  
5 21-5b as follows:

6 (105 ILCS 5/21-5b)

7 Sec. 21-5b. Alternative certification. The State Board of  
8 Education, in consultation with the State Teacher  
9 Certification Board, shall establish and implement an  
10 alternative certification program under which persons who meet  
11 the requirements of and successfully complete the program  
12 established by this Section shall be issued an alternative  
13 teaching certificate for teaching in the schools. The program  
14 shall be limited to not more than 260 new participants during  
15 each year that the program is in effect. The State Board of  
16 Education, in cooperation with a partnership formed with a  
17 university that offers 4-year baccalaureate and masters degree  
18 programs and that is a recognized institution as defined in  
19 Section 21-21 and one or more not-for-profit organizations in  
20 the State which support excellence in teaching, shall within 30  
21 days after submission by the partnership approve a course of  
22 study developed by the partnership that persons in the program  
23 must successfully complete in order to satisfy one criterion

1 for issuance of an alternative certificate under this Section.  
2 The Alternative Teacher Certification program course of study  
3 must include the current content and skills contained in the  
4 university's current courses for State certification which  
5 have been approved by the State Board of Education, in  
6 consultation with the State Teacher Certification Board, as the  
7 requirement for State teacher certification.

8 The alternative certification program established under  
9 this Section shall be known as the Alternative Teacher  
10 Certification program. The Alternative Teacher Certification  
11 Program shall be offered by the submitting partnership and may  
12 be offered in conjunction with one or more not-for-profit  
13 organizations in the State which support excellence in  
14 teaching. The program shall be comprised of the following 3  
15 phases: (a) the first phase is the course of study offered on  
16 an intensive basis in education theory, instructional methods,  
17 and practice teaching; (b) the second phase is the person's  
18 assignment to a full-time teaching position for one school  
19 year; and (c) the third phase is a comprehensive assessment of  
20 the person's teaching performance by school officials and the  
21 partnership participants and a recommendation by the partner  
22 institution of higher education to the State Board of Education  
23 that the person be issued a standard alternative teaching  
24 certificate. Successful completion of the Alternative Teacher  
25 Certification program shall be deemed to satisfy any other  
26 practice or student teaching and subject matter requirements

1 established by law.

2 A provisional alternative teaching certificate, valid for  
3 one year of teaching in the common schools and not renewable,  
4 shall be issued under this Section 21-5b to persons who at the  
5 time of applying for the provisional alternative teaching  
6 certificate under this Section:

7 (1) have graduated from an accredited college or  
8 university with a bachelor's degree;

9 (2) have successfully completed the first phase of the  
10 Alternative Teacher Certification program as provided in  
11 this Section;

12 (3) have passed the tests of basic skills and subject  
13 matter knowledge required by Section 21-1a; and

14 (4) (i) have been employed for a period of at least 5  
15 years in an area requiring application of the individual's  
16 education or (ii) have attained at least a cumulative grade  
17 average of a "B" if the individual is assigned either to a  
18 school district that has not met the annual measurable  
19 objective for highly qualified teachers required by the  
20 Illinois Revised Highly Qualified Teachers (HQT) Plan or to  
21 a school district whose data filed with the State Board of  
22 Education indicates that the district's poor and minority  
23 students are taught by teachers who are not highly  
24 qualified at a higher rate than other students; however,  
25 this item (4) requirement does not apply with respect to a  
26 provisional alternative teaching certificate for teaching

1 in schools situated in a school district that is located in  
2 a city having a population in excess of 500,000  
3 inhabitants.

4 A person possessing a provisional alternative certificate  
5 under this Section shall be treated as a regularly certified  
6 teacher for purposes of compensation, benefits, and other terms  
7 and conditions of employment afforded teachers in the school  
8 who are members of a bargaining unit represented by an  
9 exclusive bargaining representative, if any.

10 Until February 15, 2000, a standard alternative teaching  
11 certificate, valid for 4 years for teaching in the schools and  
12 renewable as provided in Section 21-14, shall be issued under  
13 this Section 21-5b to persons who first complete the  
14 requirements for the provisional alternative teaching  
15 certificate and who at the time of applying for a standard  
16 alternative teaching certificate under this Section have  
17 successfully completed the second and third phases of the  
18 Alternative Teacher Certification program as provided in this  
19 Section. Alternatively, beginning February 15, 2000, at the end  
20 of the 4-year validity period, persons who were issued a  
21 standard alternative teaching certificate shall be eligible,  
22 on the same basis as holders of an Initial Teaching Certificate  
23 issued under subsection (b) of Section 21-2 of this Code, to  
24 apply for a Standard Teaching Certificate, provided they meet  
25 the requirements of subsection (c) of Section 21-2 of this Code  
26 and further provided that a person who does not apply for and

1 receive a Standard Teaching Certificate shall be able to teach  
2 only in schools situated in a school district that is located  
3 in a city having a population in excess of 500,000 inhabitants.

4 Beginning February 15, 2000, persons who have completed the  
5 requirements for a standard alternative teaching certificate  
6 under this Section shall be issued an Initial Alternative  
7 Teaching Certificate valid for 4 years of teaching and not  
8 renewable. At the end of the 4-year validity period, these  
9 persons shall be eligible, on the same basis as holders of an  
10 Initial Teaching Certificate issued under subsection (b) of  
11 Section 21-2 of this Code, to apply for a Standard Teaching  
12 Certificate, provided they meet the requirements of subsection  
13 (c) of Section 21-2.

14 This alternative certification program shall be  
15 implemented so that the first provisional alternative teaching  
16 certificates issued under this Section are effective upon the  
17 commencement of the 1997-1998 academic year and the first  
18 standard alternative teaching certificates issued under this  
19 Section are effective upon the commencement of the 1998-1999  
20 academic year.

21 The State Board of Education, in cooperation with the  
22 partnership establishing the Alternative Teacher Certification  
23 program, shall adopt rules and regulations that are consistent  
24 with this Section and that the State Board of Education deems  
25 necessary to establish and implement the program.

1           Section 99. Effective date. This Act takes effect upon  
2           becoming law.
