18 Section 40. The sum of \$4,000,000, or so much thereof as
 19 may be necessary, is appropriated from the Title III Social
 20 Security and Employment Fund to the Department of Employment
 21 Security for administrative expenses associated with Training
 22 and Employment Services in accordance with applicable laws
 23 and regulations for the state portion of federal funds made

1 available by the American Recovery and Reinvestment Act of
2 2009.

3 Section 99. Effective date. This Act takes effect July
4 1, 2011.
