SYNOPSIS AS INTRODUCED:

Amends the Private College Campus Police Act. Provides that nothing in the Act shall be construed to provide college or university police departments or their officers the authority to issue moving violations in accordance with the Illinois Vehicle Code.

1 AN ACT concerning education.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Private College Campus Police Act is amended by changing Section 1 as follows:
- 6 (110 ILCS 1020/1) (from Ch. 144, par. 1951)

7 Sec. 1. The Board of Trustees of a private college or 8 private university, may appoint persons to be members of a 9 campus police department. The Board shall assign duties, enforcement of college 10 the or regulations, and prescribe the oath of office. With respect to 11 any such campus police department established for police 12 protection, the members of such campus police department shall 13 14 be persons who have successfully completed the Minimum Standards Basic Law Enforcement Training Course offered at a 15 16 police training school established under the Illinois Police 17 Training Act, as such Act may be now or hereafter amended. All members of such campus police departments must 18 19 successfully complete the Firearms Training for Peace Officers established under an Act in Relation To Firearms Training for 20 21 Peace Officers, as such Act may be now or hereafter amended. 22 Members of the campus police department shall have the powers of municipal peace officers and county sheriffs, including the 23

power to make arrests under the circumstances prescribed in Section 107-2 of the Code of Criminal Procedure of 1963, as amended, for violations of state statutes or municipal or county ordinances, including the ability to regulate and control traffic on the public way contiguous to the college or university property, for the protection of employees, visitors and their property, and the property branches, and interests of the college or university, in the county where the college or university is located. Campus police shall have no authority to serve civil process. Nothing in this Act shall be construed to provide college or university police departments or their officers the authority to issue moving violations in accordance with the Illinois Vehicle Code.

Members of the campus police department at a private college or private university shall not be eligible to participate in any State, county or municipal retirement fund and shall not be reimbursed for training with state funds. the uniforms, vehicles, and badges of such officers shall be distinctive from those of the local law enforcement agency where the main campus is located.

The Board of Trustees shall provide liability insurance coverage for each member of the campus police department without cost to the member, which insures the member against any liability which arises out of or in the course of the member's employment for no less than \$250,000 of coverage, unless such indemnification is provided by a program of

1 self-insurance.

2 For the purposes of this Section, "private college" or 3 "private university" means: (1) any college or university which is not owned or controlled by the State or any political subdivision thereof, and (2) which provides a program of 5 6 education in residence leading to a baccalaureate degree, or 7 which provides a program of education in residence, for which the baccalaureate degree is a prerequisite, leading to an 8 9 academic or professional degree, and (3) which is accredited by 10 the North Central Association or other nationally recognized 11 accrediting agency.
