2 AMENDMENT NO. _____. Amend Senate Bill 3287 as follows:

3 on page 1, line 10, after "any", by inserting "full-time"; and

4 on page 2, immediately below line 1, by inserting the
5 following:

6 "Primary occupant" means the current residential customer
7 of record, in whose name the utility company or electric
8 cooperative account is registered."; and

11 "(c) In order to be eligible for the benefits granted to
12 service members under this Section, a service member must
13 provide the company or electric cooperative with a copy of the
14 orders calling the service member to military service, or

2 hardship, the primary occupant must demonstrate to the company
3 or electric cooperative's satisfaction that as a service member
4 his or her military service has materially and currently
5 affected his or her ability to pay for such services when due.
6 Further, in the event the service member no longer claims to be
7 the primary occupant of the residential premises or the
8 customer account of record changes, then the company or
9 electric cooperative may enforce all applicable rules,
10 regulations, and tariffs."; and
