

1 AN ACT concerning transportation.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The Illinois Vehicle Code is amended by changing
5 Sections 3-806 and 3-815 and by adding Sections 1-123.2 and
6 3-804.3 as follows:

7 (625 ILCS 5/1-123.2 new)

8 Sec. 1-123.2. Former military vehicle. A vehicle or
9 trailer, regardless of size, weight, or year of manufacture,
10 that was manufactured for use in any country's military forces
11 and is maintained to depict or represent military design or
12 markings. A former military vehicle does not include a vehicle
13 used for any commercial or production agriculture purpose.

14 (625 ILCS 5/3-804.3 new)

15 Sec. 3-804.3. Former military vehicles.

16 (a) The owner of a former military vehicle may register the
17 vehicle for a fee not to exceed:

18 (1) \$100 for a vehicle with a gross vehicle weight
19 rating of 26,000 pounds or less;

20 (2) \$150 for a vehicle with a gross vehicle weight
21 rating of 26,001 to 45,000 pounds;

22 (3) \$500 for a vehicle with a gross vehicle weight

1 rating of 45,001 to 65,000 pounds;

2 (4) \$1,000 for a vehicle with a gross vehicle weight
3 rating of over 65,000 pounds; or

4 (5) \$25 for a trailer with a weight of 3,000 pounds or
5 less; or

6 (6) \$75 for a trailer with a weight of over 3,000
7 pounds.

8 (b) The Secretary may prescribe, in the Secretary's
9 discretion, that former military vehicle plates be issued for a
10 definite or an indefinite term, such term to correspond to the
11 term of registration plates issued generally, as provided in
12 Section 3-414.1. Any person requesting former military vehicle
13 plates under this Section may also apply to have vanity or
14 personalized plates as provided under Section 3-405.1.

15 (c) A vehicle registered as a former military vehicle is
16 not subject to Section 3-815 and 3-818 of this Code.

17 (d) A vehicle may not be registered under this Section
18 unless a title for the vehicle has been issued by the Secretary
19 and the vehicle is eligible for registration without regard to
20 its status as a military vehicle.

23 Sec. 3-806. Registration Fees; Motor Vehicles of the First
24 Division. Every owner of any other motor vehicle of the first
25 division, except as provided in Sections 3-804, 3-804.01,

1 3-804.3, 3-805, 3-806.3, 3-806.7, and 3-808, and every second
2 division vehicle weighing 8,000 pounds or less, shall pay the
3 Secretary of State an annual registration fee at the following
4 rates:

16 Beginning with the 2010 registration year a \$1 surcharge
17 shall be collected in addition to the above fees for motor
18 vehicles of the first division, motorcycles, motor driven
19 cycles, and pedalcycles to be deposited into the State Police
20 Vehicle Fund.

21 All of the proceeds of the additional fees imposed by
22 Public Act 96-34 shall be deposited into the Capital Projects
23 Fund.

 2 Sec. 3-815. Flat weight tax; vehicles of the second
 3 division.

4 (a) Except as provided in Section 3-806.3 and 3-804.3,
 5 every owner of a vehicle of the second division registered
 6 under Section 3-813, and not registered under the mileage
 7 weight tax under Section 3-818, shall pay to the Secretary of
 8 State, for each registration year, for the use of the public
 9 highways, a flat weight tax at the rates set forth in the
 10 following table, the rates including the \$10 registration fee:

8 Beginning with the 2010 registration year a \$1 surcharge
9 shall be collected for vehicles registered in the 8,000 lbs.
10 and less flat weight plate category above to be deposited into
11 the State Police Vehicle Fund.

12 All of the proceeds of the additional fees imposed by this
13 amendatory Act of the 96th General Assembly shall be deposited
14 into the Capital Projects Fund.

15 (a-1) A Special Hauling Vehicle is a vehicle or combination
16 of vehicles of the second division registered under Section
17 3-813 transporting asphalt or concrete in the plastic state or
18 a vehicle or combination of vehicles that are subject to the
19 gross weight limitations in subsection (a) of Section 15-111
20 for which the owner of the vehicle or combination of vehicles
21 has elected to pay, in addition to the registration fee in
22 subsection (a), \$125 to the Secretary of State for each
23 registration year. The Secretary shall designate this class of
24 vehicle as a Special Hauling Vehicle.

25 (b) Except as provided in Section 3-806.3, every camping
26 trailer, motor home, mini motor home, travel trailer, truck

1 camper or van camper used primarily for recreational purposes,
 2 and not used commercially, nor for hire, nor owned by a
 3 commercial business, may be registered for each registration
 4 year upon the filing of a proper application and the payment of
 5 a registration fee and highway use tax, according to the
 6 following table of fees:

22 Every house trailer must be registered under Section 3-819.

23 (c) Farm Truck. Any truck used exclusively for the owner's
 24 own agricultural, horticultural or livestock raising
 25 operations and not-for-hire only, or any truck used only in the
 26 transportation for-hire of seasonal, fresh, perishable fruit

1 or vegetables from farm to the point of first processing, may
 2 be registered by the owner under this paragraph in lieu of
 3 registration under paragraph (a), upon filing of a proper
 4 application and the payment of the \$10 registration fee and the
 5 highway use tax herein specified as follows:

22 In the event the Secretary of State revokes a farm truck
 23 registration as authorized by law, the owner shall pay the flat
 24 weight tax due hereunder before operating such truck.

25 Any combination of vehicles having 5 axles, with a distance
 26 of 42 feet or less between extreme axles, that are subject to

1 the weight limitations in subsection (a) of Section 15-111 for
2 which the owner of the combination of vehicles has elected to
3 pay, in addition to the registration fee in subsection (c),
4 \$125 to the Secretary of State for each registration year shall
5 be designated by the Secretary as a Special Hauling Vehicle.

6 (d) The number of axles necessary to carry the maximum load
7 provided shall be determined from Chapter 15 of this Code.

8 (e) An owner may only apply for and receive 5 farm truck
9 registrations, and only 2 of those 5 vehicles shall exceed
10 59,500 gross weight in pounds per vehicle.

11 (f) Every person convicted of violating this Section by
12 failure to pay the appropriate flat weight tax to the Secretary
13 of State as set forth in the above tables shall be punished as
14 provided for in Section 3-401.
