Two or more acts of sales tax evasion may be charged as a single count in any indictment, information, or complaint and the amount of tax deficiency may be aggregated for purposes of determining the amount of tax which is attempted to be or is evaded and the period between the first and last acts may be alleged as the date of the offense.

- (1) When the amount of tax, the assessment or payment of which is attempted to be or is evaded is less than \$500 a person is guilty of a Class 4 felony.
- (2) When the amount of tax, the assessment or payment of which is attempted to be or is evaded is \$500 or more but less than \$10,000, a person is quilty of a Class 3 felony.
- (3) When the amount of tax, the assessment or payment of which is attempted to be or is evaded is \$10,000 or more but less than \$100,000, a person is quilty of a Class 2 felonv.
- (4) When the amount of tax, the assessment or payment of which is attempted to be or is evaded is \$100,000 or more, a person is guilty of a Class 1 felony.

Any person who knowingly sells, purchases, installs, 1 transfers, possesses, uses, or accesses any automated sales suppression device, zapper, or phantom-ware in this State is quilty of a Class 3 felony.

For the purposes of this Section:

"Automated sales suppression device" or "zapper" means a software program that falsifies the electronic records of an electronic cash register or other point-of-sale system, including, but not limited to, transaction data and transaction reports. The term includes the software program, any device that carries the software program, or an Internet link to the software program.

"Phantom-ware" means a hidden programming option embedded in the operating system of an electronic cash register or hardwired into an electronic cash register that can be used to create a second set of records or that can eliminate or manipulate transaction records in an electronic cash register.

"Electronic cash register" means a device that keeps a register or supporting documents through the use of an electronic device or computer system designed to record transaction data for the purpose of computing, compiling, or processing retail sales transaction data in any manner.

"Transaction data" includes: items purchased by a customer; the price of each item; a taxability determination for each item; a segregated tax amount for each taxed item; the amount of cash or credit tendered; the net amount returned to

- the customer in change; the date and time of the purchase; the 1
- 2 name, address, and identification number of the vendor; and the
- 3 receipt or invoice number of the transaction.
- 4 "Transaction report" means a report that documents,
- without limitation, the sales, taxes, or fees collected, media 5
- totals, and discount voids at an electronic cash register and 6
- 7 that is printed on a cash register tape at the end of a day or
- shift, or a report that documents every action at an electronic 8
- 9 cash register and is stored electronically.
- (c) A prosecution for any act in violation of this Section 10
- 11 may be commenced at any time within 5 years of the commission
- 12 of that act.
