1	AMENDMENT TO HOUSE BILL 1156									
2	AMENDMENT NO Amend House Bill 1156, AS AMENDED, by									
3	replacing everything after the enacting clause with the									
4	following:									
5	"Section 5. The Criminal Code of 2012 is amended by adding									
6	Section 24-11 as follows:									
7	(720 ILCS 5/24-11 new)									
8	Sec. 24-11. Possession, delivery, sale, receipt, transfer,									
9	or purchase of large capacity ammunition feeding device.									
10	(a) As used in this Section:									
11	"Large capacity ammunition feeding device" means:									
12	(1) a magazine, belt, drum, feed strip, or similar									
13	device that has a capacity of, or that can be readily									
14	restored or converted to accept, more than 10 rounds of									
15	ammunition; or									
16	(2) any combination of parts from which a device									

1	described in paragraph (1) can be assembled.
2	"Large capacity ammunition feeding device" does not
3	include an attached tubular device designed to accept, and
4	capable of operating only with, .22 caliber rimfire ammunition.
5	"Large capacity ammunition feeding device" does not include a
6	tubular magazine that is contained in a lever-action firearm or
7	any device that has been made permanently inoperable.
8	(b) It is unlawful for any person within this State to
9	knowingly deliver, sell, receive, transfer, purchase, or
10	possess or cause to be delivered, sold, received, transferred,
11	or purchased a large capacity ammunition feeding device.
12	(c) Exemptions. This Section does not apply to or affect
13	any of the following:
14	(1) Peace officers as defined in Section 2-13 of the
15	Criminal Code of 2012.
16	(2) Acquisition and possession by a local law
17	enforcement agency for the purpose of equipping the
18	agency's peace officers as defined in paragraph (1) of this
19	subsection.
20	(3) Wardens, superintendents, and keepers of prisons,
21	penitentiaries, jails, and other institutions for the
22	detention of persons accused or convicted of an offense.
23	(4) Members of the Armed Services or Reserve Forces of
24	the United States or the Illinois National Guard, for the
25	performance of their official duties.
26	(5) Any company that employs armed security officers in

- (6) Sale of large capacity ammunition feeding devices to persons authorized under subdivisions (1) through (5) of this subsection (c) to possess those devices.
- (7) Sale of large capacity ammunition feeding devices for sale or transfer in another state.
- (8) Sale or rental of large capacity ammunition feeding devices for blank-firing prohibited weapons to persons authorized or permitted, or both authorized and permitted, to acquire these devices for the purpose of rental for use solely as props for a motion picture, television, or video production or entertainment event.".
