The Personnel Code is amended by changing 4 Section 4c as follows: 5 6 (20 ILCS 415/4c) (from Ch. 127, par. 63b104c) 7 Sec. 4c. General exemptions. The following positions in State service shall be exempt from jurisdictions A, B, and C, 8 unless the jurisdictions shall be extended as provided in this 10 Act: (1) All officers elected by the people. 11 12 (2) All positions under the Lieutenant Governor, Secretary of State, State Treasurer, State Comptroller, 13 14 State Board of Education, Clerk of the Supreme Court, 15 Attorney General, and State Board of Elections. (3) Judges, and officers and employees of the courts, 16

- (4) All officers and employees of the Illinois General Assembly, all employees of legislative commissions, all officers and employees of the Illinois Legislative Reference Bureau, the Legislative Research Unit, and the Legislative Printing Unit.
- (5) All positions in the Illinois National Guard and Illinois State Guard, paid from federal funds or positions in the State Military Service filled by enlistment and paid from State funds.
- (6) All employees of the Governor at the executive mansion and on his immediate personal staff.
- (7) Directors of Departments, the Adjutant General, the Assistant Adjutant General, the Director of the Illinois Emergency Management Agency, members of boards and commissions, and all other positions appointed by the Governor by and with the consent of the Senate.
- (8) The presidents, other principal administrative officers, and teaching, research and extension faculties of Chicago State University, Eastern Illinois University, Governors State University, Illinois State University, Northeastern Illinois University, Northern Illinois University, Western Illinois University, the Illinois Community College Board, Southern Illinois University, Illinois Board of Higher Education, University of Illinois, State Universities Civil Service System,

University Retirement System of Illinois, and administrative officers and scientific and technical staff of the Illinois State Museum.

- (9) All other employees except the presidents, other principal administrative officers, and teaching, research and extension faculties of the universities under the jurisdiction of the Board of Regents and the colleges and universities under the jurisdiction of the Board of Governors of State Colleges and Universities, Illinois Community College Board, Southern Illinois University, Illinois Board of Higher Education, Board of Governors of State Colleges and Universities, the Board of Regents, University of Illinois, State Universities Civil Service System, University Retirement System of Illinois, so long as these are subject to the provisions of the State Universities Civil Service Act.
- (10) The State Police so long as they are subject to the merit provisions of the State Police Act.

- 11 (a) Creation. There is created under the jurisdiction of
- 12 the Governor the Illinois Sentencing Policy Advisory Council,
- hereinafter referred to as the Council.
- 14 (b) Purposes and goals. The purpose of the Council is to
- 15 review sentencing policies and practices and examine how these
- 16 policies and practices impact the criminal justice system as a
- whole in the State of Illinois. In carrying out its duties, the
- 18 Council shall be mindful of and aim to achieve the purposes of
- 19 sentencing in Illinois, which are set out in Section 1-1-2 of
- 20 this Code:
- 21 (1) prescribe sanctions proportionate to the

- (2) Members of the Council who serve because of their public office or position, or those who are designated as members by such officials, shall serve only as long as they hold such office or position.
- (3) Council members shall serve without compensation but shall be reimbursed for travel and per diem expenses incurred in their work for the Council.
- (4) The Council may exercise any power, perform any function, take any action, or do anything in furtherance of its purposes and goals upon the appointment of a quorum of its members. The term of office of each member of the Council ends on the date of repeal of this amendatory Act of the 96th General Assembly.
- (d) Duties. The Council shall perform, as resources permit, duties including:
 - (1)Collect and analyze information including sentencing data, crime trends, and existing correctional resources to support legislative and executive action affecting the use of correctional resources on the State and local levels.
 - (2) Prepare criminal justice population projections annually, including correctional and community-based supervision populations.
 - (3) Analyze data relevant to proposed sentencing legislation and its effect on current policies

provide information practices, and to support evidence-based sentencing.

- (4) Ensure that adequate resources and facilities are available for carrying out sentences imposed on offenders and that rational priorities are established for the use of those resources. To do so, the Council shall prepare criminal justice resource statements, identifying the and practical effects of proposed criminal sentencing legislation, including, but not limited to, the correctional population, court processes, and county or local government resources.
- (5) Perform such other studies or tasks pertaining to sentencing policies as may be requested by the Governor or the Illinois General Assembly.
- (6) Perform such other functions as may be required by law or as are necessary to carry out the purposes and goals of the Council prescribed in subsection (b).

(e) Authority.

- (1) The Council shall have the power to perform the functions necessary to carry out its duties, purposes and goals under this Act. In so doing, the Council shall utilize information and analysis developed by the Illinois Criminal Justice Information Authority, the Administrative Office of the Illinois Courts, and the Illinois Department of Corrections.
 - (2) Upon request from the Council, each executive

- provide information and records to the Council in the 2

- 4 (f) Report. The Council shall report in writing annually to
- 5 the General Assembly, the Illinois Supreme Court, and the
