2	AMENDMENT NO Amend House Bill 1810 by replacing
3	everything after the enacting clause with the following:
4	"Section 5. The Illinois Vehicle Code is amended by
5	changing Section 15-111 as follows:
6	(625 ILCS 5/15-111) (from Ch. 95 1/2, par. 15-111)
7	Sec. 15-111. Wheel and axle loads and gross weights.
8	(a) No vehicle or combination of vehicles with pneumatic
9	tires may be operated, unladen or with load, when the total
10	weight on the road surface exceeds the following: 20,000 pounds
11	on a single axle; 34,000 pounds on a tandem axle with no axle
12	within the tandem exceeding 20,000 pounds; 80,000 pounds gross
13	weight for vehicle combinations of 5 or more axles; or a total
14	weight on a group of 2 or more consecutive axles in excess of
15	that weight produced by the application of the following
16	formula: W = 500 times the sum of (LN divided by N-1) + 12N +

1 36, where "W" equals overall total weight on any group of 2 or 2 more consecutive axles to the nearest 500 pounds, "L" equals 3 the distance measured to the nearest foot between extremes of 4 any group of 2 or more consecutive axles, and "N" equals the 5 number of axles in the group under consideration.

6 The above formula when expressed in tabular form results in 7 allowable loads as follows:

19 \*If the distance between 2 axles is 96 inches or less, the 2 20 axles are tandem axles and the maximum total weight may not 21 exceed 34,000 pounds, notwithstanding the higher limit 22 resulting from the application of the formula.

Vehicles not in a combination having more than 4 axles may not exceed the weight in the table in this subsection (a) for 4 axles measured between the extreme axles of the vehicle.

26 Vehicles in a combination having more than 6 axles may not

exceed the weight in the table in this subsection (a) for 6
 axles measured between the extreme axles of the combination.

3 Local authorities, with respect to streets and highways 4 under their jurisdiction, without additional fees, may also by 5 ordinance or resolution allow the weight limitations of this subsection, provided the maximum gross weight on any one axle 6 shall not exceed 20,000 pounds and the maximum total weight on 7 any tandem axle shall not exceed 34,000 pounds, on designated 8 9 highways when appropriate regulatory signs giving notice are 10 erected upon the street or highway or portion of any street or 11 highway affected by the ordinance or resolution.

The following are exceptions to the above formula:

13 (1) Vehicles for which a different limit is established
14 and posted in accordance with Section 15-316 of this Code.

15 (2) Vehicles for which the Department of
16 Transportation and local authorities issue overweight
17 permits under authority of Section 15-301 of this Code.
18 These vehicles are not subject to the bridge formula.

(3) Cities having a population of more than 50,000 may 19 20 permit by ordinance axle loads on 2 axle motor vehicles 33 21 1/2% above those provided for herein, but the increase 22 shall not become effective until the city has officially 23 notified the Department of the passage of the ordinance and 24 shall not apply to those vehicles when outside of the 25 limits of the city, nor shall the gross weight of any 2 26 axle motor vehicle operating over any street of the city

1 exceed 40,000 pounds.

2 (4) Weight limitations shall not apply to vehicles 3 (including loads) operated by a public utility when 4 transporting equipment required for emergency repair of 5 public utility facilities or properties or water wells.

6 (5) Two consecutive sets of tandem axles may carry a 7 total weight of 34,000 pounds each if the overall distance 8 between the first and last axles of the consecutive sets of 9 tandem axles is 36 feet or more, notwithstanding the lower 10 limit resulting from the application of the above formula.

(6) A truck, not in combination and used exclusively for the collection of rendering materials, may, when laden, transmit upon the road surface, except when on part of the National System of Interstate and Defense Highways, the following maximum weights: 22,000 pounds on a single axle; 40,000 pounds on a tandem axle.

(7) A truck not in combination, equipped with a self 17 compactor or an industrial roll-off hoist and roll-off 18 19 container, used exclusively for garbage, refuse, or 20 recycling operations, may, when laden, transmit upon the 21 road surface, except when on part of the National System of Interstate and Defense Highways, the following maximum 22 23 weights: 22,000 pounds on a single axle; 40,000 pounds on a 24 tandem axle; 40,000 pounds gross weight on a 2-axle 25 vehicle; 54,000 pounds gross weight on a 3-axle vehicle. 26 This vehicle is not subject to the bridge formula.

(8) Tandem axles on a 3-axle truck registered as a 1 Special Hauling Vehicle, manufactured prior to or in the 2 3 model year of 2014 and first registered in Illinois prior to January 1, 2015, with a distance greater than 72 inches 4 5 but not more than 96 inches between any series of 2 axles, is allowed a combined weight on the series not to exceed 6 36,000 pounds and neither axle of the series may exceed 7 8 20,000 pounds. Any vehicle of this type manufactured after 9 the model year of 2014 or first registered in Illinois 10 after December 31, 2014 may not exceed a combined weight of 34,000 pounds through the series of 2 axles and neither 11 axle of the series may exceed 20,000 pounds. 12

13 (8.5) A combination sewer cleaning jetting vacuum 14 truck registered as a Special Hauling Vehicle, used 15 exclusively for the transportation of non-hazardous solid waste, manufactured before or in the model year of 2014, 16 first registered in Illinois before January 1, 2015, may, 17 when laden, transmit upon the road surface, except when on 18 19 part of the National System of Interstate and Defense 20 Highways, the greater of the gross vehicle weight of the 21 truck or: 22,000 pounds on a single axle; 40,000 pounds on 22 a tandem axle; 54,000 pounds gross weight on a 3-axle 23 vehicle; 66,000 pounds gross weight on a 4-axle vehicle. 24 This vehicle is not subject to the bridge formula.

25 (9) A 4-axle truck mixer registered as a Special
26 Hauling Vehicle, used exclusively for the mixing and

1 transportation of concrete in the plastic state, manufactured before or in the model year of 2014, first 2 3 registered in Illinois before January 1, 2015, and not operated on a highway that is part of the National System 4 5 of Interstate Highways, is allowed the following maximum weights: 20,000 pounds on any single axle; 36,000 pounds on 6 a series of axles greater than 72 inches but not more than 7 96 inches; and 34,000 pounds on any series of 2 axles 8 9 greater than 40 inches but not more than 72 inches. The 10 gross weight of this vehicle may not exceed the weights allowed by the bridge formula for 4 axles. The bridge 11 formula does not apply to any series of 3 axles while the 12 13 vehicle is transporting concrete in the plastic state, but 14 no axle or tandem axle of the series may exceed the maximum 15 weight permitted under this paragraph (9) of subsection 16 (a).

(10) Combinations of vehicles, registered as Special 17 Hauling Vehicles that include a semitrailer manufactured 18 prior to or in the model year of 2014, and registered in 19 20 Illinois prior to January 1, 2015, having 5 axles with a 21 distance of 42 feet or less between extreme axles, may not 22 exceed the following maximum weights: 20,000 pounds on a 23 single axle; 34,000 pounds on a tandem axle; and 72,000 24 pounds gross weight. This combination of vehicles is not 25 subject to the bridge formula. For all those combinations of vehicles that include a semitrailer manufactured after 26

the effective date of P.A. 92-0417, the overall distance between the first and last axles of the 2 sets of tandems must be 18 feet 6 inches or more. Any combination of vehicles that has had its cargo container replaced in its entirety after December 31, 2014 may not exceed the weights allowed by the bridge formula.

7 (11) The maximum weight allowed on a vehicle with
8 crawler type tracks is 40,000 pounds.

9 (12) A combination of vehicles, including a tow truck 10 and a disabled vehicle or disabled combination of vehicles, that exceeds the weight restriction imposed by this Code, 11 12 may be operated on a public highway in this State provided 13 that neither the disabled vehicle nor any vehicle being 14 towed nor the tow truck itself shall exceed the weight 15 limitations permitted under this Chapter. During the towing operation, neither the tow truck nor the vehicle 16 combination shall exceed 24,000 pounds on a single rear 17 18 axle and 44,000 pounds on a tandem rear axle, provided the 19 towing vehicle:

(i) is specifically designed as a tow truck having
a gross vehicle weight rating of at least 18,000 pounds
and is equipped with air brakes, provided that air
brakes are required only if the towing vehicle is
towing a vehicle, semitrailer, or tractor-trailer
combination that is equipped with air brakes;

(ii) is equipped with flashing, rotating, or

oscillating amber lights, visible for at least 500 feet in all directions;

3 (iii) is capable of utilizing the lighting and
4 braking systems of the disabled vehicle or combination
5 of vehicles; and

(iv) does not engage in a tow exceeding 20 miles 6 from the initial point of wreck or disablement. Any 7 8 additional movement of the vehicles may occur only upon 9 issuance of authorization for that movement under the 10 provisions of Sections 15-301 through 15-319 of this 11 Code. The towing vehicle, however, may tow any disabled vehicle to a point where repairs are actually to occur. 12 13 This movement shall be valid only on State routes. The 14 tower must abide by posted bridge weight limits.

15 Gross weight limits shall not apply to the combination of 16 the tow truck and vehicles being towed. The tow truck license plate must cover the operating empty weight of the tow truck 17 only. The weight of each vehicle being towed shall be covered 18 by a valid license plate issued to the owner or operator of the 19 20 vehicle being towed and displayed on that vehicle. If no valid plate issued to the owner or operator of that vehicle is 21 22 displayed on that vehicle, or the plate displayed on that 23 vehicle does not cover the weight of the vehicle, the weight of 24 the vehicle shall be covered by the third tow truck plate 25 issued to the owner or operator of the tow truck and 26 temporarily affixed to the vehicle being towed. 1 carrier is registered and being used as a tow truck, however, 2 the license plate or plates for the tow truck must cover the 3 gross vehicle weight, including any load carried on the bed of 4 the roll-back carrier.

5 Department may by rule or regulation prescribe The 6 additional requirements. However, nothing in this Code shall prohibit a tow truck under instructions of a police officer 7 8 from legally clearing a disabled vehicle, that may be in 9 violation of weight limitations of this Chapter, from the 10 roadway to the berm or shoulder of the highway. If in the 11 opinion of the police officer that location is unsafe, the officer is authorized to have the disabled vehicle towed to the 12 13 nearest place of safety.

For the purpose of this subsection, gross vehicle weight rating, or GVWR, means the value specified by the manufacturer as the loaded weight of the tow truck.

(b) As used in this Section, "recycling haul" or "recycling operation" means the hauling of non-hazardous, non-special, non-putrescible materials, such as paper, glass, cans, or plastic, for subsequent use in the secondary materials market.

(c) No vehicle or combination of vehicles equipped with pneumatic tires shall be operated, unladen or with load, upon the highways of this State in violation of the provisions of any permit issued under the provisions of Sections 15-301 through 15-319 of this Chapter.

(d) No vehicle or combination of vehicles equipped with

other than pneumatic tires may be operated, unladen or with load, upon the highways of this State when the gross weight on the road surface through any wheel exceeds 800 pounds per inch width of tire tread or when the gross weight on the road surface through any axle exceeds 16,000 pounds.

6 (e) No person shall operate a vehicle or combination of 7 vehicles over a bridge or other elevated structure constituting 8 part of a highway with a gross weight that is greater than the 9 maximum weight permitted by the Department, when the structure 10 is sign posted as provided in this Section.

11 (f) The Department upon request from any local authority shall, or upon its own initiative may, conduct an investigation 12 13 of any bridge or other elevated structure constituting a part 14 of a highway, and if it finds that the structure cannot with 15 safety to itself withstand the weight of vehicles otherwise 16 permissible under this Code the Department shall determine and declare the maximum weight of vehicles that the structures can 17 withstand, and shall cause or permit suitable signs stating 18 maximum weight to be erected and maintained before each end of 19 20 the structure. No person shall operate a vehicle or combination 21 of vehicles over any structure with a gross weight that is 22 greater than the posted maximum weight.

(g) Upon the trial of any person charged with a violation of subsection (e) or (f) of this Section, proof of the determination of the maximum allowable weight by the Department and the existence of the signs, constitutes conclusive evidence 1 of the maximum weight that can be maintained with safety to the
