1 forces, as determined necessary, to combat recyclable metal 2 theft. The Task Force shall consider and develop long-term 3 solutions, both legislative and enforcement-driven, for the 4 rising problem of recyclable metal thefts in this State.

5 <u>(e) Each year, the Task Force shall review the</u> 6 <u>effectiveness of its efforts in deterring and investigating the</u> 7 <u>problem of recyclable metal theft and in assisting in the</u> 8 <u>prosecution of persons engaged in recyclable metal theft.
