1 AN ACT concerning education.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 4 Section 5. The School Code is amended by adding Section
- 5 2-3.157 and by changing Sections 10-20.14 and 34-19 as follows:
- 6 (105 ILCS 5/2-3.157 new)
- 7 Sec. 2-3.157. Standard student expulsion policy. The State
- 8 Board of Education shall establish a standard student expulsion
- 9 policy that applies to each school district in this State.
- 10 (105 ILCS 5/10-20.14) (from Ch. 122, par. 10-20.14)
- Sec. 10-20.14. Student discipline policies; Parent-teacher advisory committee.
- 13 (a) To establish and maintain a parent-teacher advisory
- 14 committee to develop with the school board policy guidelines on
- pupil discipline, including school searches. With respect to
- 16 <u>expulsions</u>, the policy must conform to the standard student
- expulsion policy established by the State Board of Education
- under Section 2-3.157 of this Code. A school board must (i)
- 19 post the pupil discipline policy on the school district's
- 20 <u>Internet website</u>, if any, within 15 days after the beginning of
- 21 <u>the school year or, if the district does not have an Internet</u>
- 22 <u>website</u>, to furnish a copy of the <u>pupil discipline</u> policy to

- the parents or guardian of each pupil within 15 days after the beginning of the school year, or within 15 days after starting classes for a pupil who transfers into the district during the school year, and (ii) to require that each school inform informs its pupils of the contents of its policy. School boards, along with the parent-teacher advisory committee, are encouraged to annually review their pupil discipline policies, the implementation of those policies, and any other factors related to the safety of their schools, pupils, and staff.
- (b) The parent-teacher advisory committee in cooperation with local law enforcement agencies shall develop, with the school board, policy guideline procedures to establish and maintain a reciprocal reporting system between the school district and local law enforcement agencies regarding criminal offenses committed by students.
- (c) The parent-teacher advisory committee, in cooperation with school bus personnel, shall develop, with the school board, policy guideline procedures to establish and maintain school bus safety procedures. These procedures shall be incorporated into the district's pupil discipline policy.
- (d) The school board, in consultation with the parent-teacher advisory committee and other community-based organizations, must include provisions in the student discipline policy to address students who have demonstrated behaviors that put them at risk for aggressive behavior, including without limitation bullying, as defined in the

- 1 policy. These provisions must include procedures for notifying
- 2 parents or legal guardians and early intervention procedures
- 3 based upon available community-based and district resources.

34-19. By-laws, rules and regulations; business 6 7 transacted at regular meetings; voting; records. The board 8 shall, subject to the limitations in this Article, establish 9 by-laws, rules and regulations, which shall have the force of 10 ordinances, for the proper maintenance of a uniform system of 11 discipline for both employees and pupils, and for the entire 12 management of the schools, and may fix the school age of 13 pupils, the minimum of which in kindergartens shall not be under 4 years, except that, based upon an assessment of the 14 15 child's readiness, children who have attended a non-public 16 preschool and continued their education at that school through kindergarten, were taught in kindergarten by an appropriately 17 certified teacher, and will attain the age of 6 years on or 18 before December 31 of the year of the 2009-2010 school term and 19 20 each school term thereafter may attend first grade upon 21 commencement of such term, and in grade schools shall not be 22 under 6 years. It may expel, suspend or, subject to the limitations of all policies established or adopted under 23 24 Section 14-8.05, otherwise discipline any pupil found guilty of gross disobedience, misconduct or other violation of the 25

by-laws, rules and regulations, including gross disobedience 1 2 or misconduct perpetuated by electronic means. An expelled pupil may be immediately transferred to an alternative program 3 in the manner provided in Article 13A or 13B of this Code. A 4 5 pupil must not be denied transfer because of the expulsion, 6 except in cases in which such transfer is deemed to cause a 7 threat to the safety of students or staff in the alternative 8 program. A pupil who is suspended in excess of 20 school days 9 may be immediately transferred to an alternative program in the 10 manner provided in Article 13A or 13B of this Code. A pupil 11 must not be denied transfer because of the suspension, except 12 in cases in which such transfer is deemed to cause a threat to 13 the safety of students or staff in the alternative program. With respect to expulsions, the district's pupil discipline 14 policy must conform to the standard student expulsion policy 15 16 established by the State Board of Education under Section 17 2-3.157 of this Code. The board must post the district's pupil discipline policy on the district's Internet website within 15 18 19 days after the beginning of the school year and require that each school inform its pupils of the contents of its policy. 20 The bylaws, rules and regulations of the board shall be 21 22 enacted, money shall be appropriated or expended, salaries 23 shall be fixed or changed, and textbooks, electronic textbooks, 24 and courses of instruction shall be adopted or changed only at 25 the regular meetings of the board and by a vote of a majority membership of the board; provided 26 of the full that

notwithstanding any other provision of this Article or the School Code, neither the board or any local school council may purchase any textbook for use in any public school of the district from any textbook publisher that fails to furnish any computer diskettes as required under Section 28-21. Funds appropriated for textbook purchases must be available for electronic textbook purchases and the technological equipment necessary to gain access to and use electronic textbooks at the local school council's discretion. The board shall be further encouraged to provide opportunities for public hearing and testimony before the adoption of bylaws, rules and regulations. Upon all propositions requiring for their adoption at least a majority of all the members of the board the yeas and nays shall be taken and reported. The by-laws, rules and regulations of the board shall not be repealed, amended or added to, except by a vote of 2/3 of the full membership of the board. The board shall keep a record of all its proceedings. Such records and all by-laws, rules and regulations, or parts thereof, may be proved by a copy thereof certified to be such by the secretary of the board, but if they are printed in book or pamphlet form which are purported to be published by authority of the board they need not be otherwise published and the book or pamphlet shall be received as evidence, without further proof, of the records, by-laws, rules and regulations, or any part thereof, as of the dates thereof as shown in such book or pamphlet, in all courts and places where judicial proceedings are had.

Notwithstanding any other provision in this Article or in 1 2 the School Code, the board may delegate to the general superintendent or to the attorney the authorities granted to 3 the board in the School Code, provided such delegation and 4 5 appropriate oversight procedures are made pursuant to board 6 by-laws, rules and regulations, adopted as herein provided, 7 except that the board may not delegate its authorities and responsibilities regarding (1) budget approval obligations; 8 9 (2) rule-making functions; (3) desegregation obligations; (4) 10 real estate acquisition, sale or lease in excess of 10 years as 11 provided in Section 34-21; (5) the levy of taxes; or (6) any 12 mandates imposed upon the board by "An Act in relation to 13 school reform in cities over 500,000, amending Acts herein named", approved December 12, 1988 (P.A. 85-1418). 14 (Source: P.A. 96-864, eff. 1-21-10; 96-1403, eff. 7-29-10; 15 16 97-340, eff. 1-1-12; 97-495, eff. 1-1-12; 97-813, eff. 17 7-13-12.)
