SYNOPSIS AS INTRODUCED:

625 ILCS 5/11-1301.2 from Ch. 95 1/2, par. 11-1301.2

Amends the Illinois Vehicle Code. Provides that parking-fee exempt parking placards may be issued to persons with visual disabilities as certified by an ophthalmologist or optometrist.

AN ACT concerning transportation.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Illinois Vehicle Code is amended by changing
Section 11-1301.2 as follows:

6 (625 ILCS 5/11-1301.2) (from Ch. 95 1/2, par. 11-1301.2)
7 Sec. 11-1301.2. Special decals for parking; persons with
8 disabilities.

9 Secretary of State shall provide for, (a) The bv administrative rules, the design, size, color, and placement of 10 a person with disabilities motorist decal or device and shall 11 provide for, by administrative rules, the content and form of 12 13 an application for a person with disabilities motorist decal or 14 device, which shall be used by local authorities in the issuance thereof to a person with temporary disabilities, 15 16 provided that the decal or device is valid for no more than 90 17 days, subject to renewal for like periods based upon continued disability, and further provided that the decal or device 18 19 clearly sets forth the date that the decal or device expires. 20 The application shall include the requirement of an Illinois 21 Identification Card number or a State of Illinois driver's 22 license number. This decal or device may be used by the authorized holder to designate and identify a vehicle not owned 23

or displaying a registration plate as provided in Sections 1 2 3-609 and 3-616 of this Act to designate when the vehicle is 3 being used to transport said person or persons with disabilities, and thus is entitled to enjoy all the privileges 4 5 that would be afforded a person with disabilities licensed 6 vehicle. Person with disabilities decals or devices issued and displayed pursuant to this Section shall be recognized and 7 8 honored by all local authorities regardless of which local 9 authority issued such decal or device.

10 The decal or device shall be issued only upon a showing by 11 adequate documentation that the person for whose benefit the 12 decal or device is to be used has a disability as defined in 13 Section 1-159.1 of this Code and the disability is temporary.

(b) The local governing authorities shall be responsible for the provision of such decal or device, its issuance and designated placement within the vehicle. The cost of such decal or device shall be at the discretion of such local governing authority.

19 (c) The Secretary of State may, pursuant to Section 20 3-616(c), issue a person with disabilities parking decal or device to a person with disabilities as defined by Section 21 22 1-159.1. Any person with disabilities parking decal or device 23 issued by the Secretary of State shall be registered to that person with disabilities in the form to be prescribed by the 24 25 Secretary of State. The person with disabilities parking decal or device shall not display that person's address. One 26

1 additional decal or device may be issued to an applicant upon 2 his or her written request and with the approval of the 3 Secretary of State. The written request must include a 4 justification of the need for the additional decal or device.

(c-5) Beginning January 1, 2014, the Secretary shall 5 provide by administrative rule for the issuance of a separate 6 7 and distinct parking decal or device for persons with disabilities as defined by Section 1-159.1 of this Code and who 8 9 meet the qualifications under this subsection. The authorized 10 holder of a decal or device issued under this subsection (c-5)11 shall be exempt from the payment of fees generated by parking 12 in a metered space, a parking area subject to paragraph (10) of 13 subsection (a) of Section 11-209 of this Code, or a publicly 14 owned parking area.

15 The Secretary shall issue a meter-exempt decal or device to 16 person with disabilities who: (i) has been issued а 17 registration plates under subsection (a) of Section 3-609 or Section 3-616 of this Code or a special decal or device under 18 this Section, (ii) holds a valid Illinois driver's license, and 19 20 (iii) is unable to do one or more of the following:

(1) manage, manipulate, or insert coins, or obtain tickets or tokens in parking meters or ticket machines in parking lots, due to the lack of fine motor control of both hands;

(2) reach above his or her head to a height of 42inches from the ground, due to a lack of finger, hand, or

upper extremity strength or mobility;

2 (3) approach a parking meter due to his or her use of a
3 wheelchair or other device for mobility; or

4 (4) walk more than 20 feet due to an orthopedic,
5 neurological, cardiovascular, or lung condition in which
6 the degree of debilitation is so severe that it almost
7 completely impedes the ability to walk.

8 The application for a meter-exempt parking decal or device 9 shall contain a statement certified by a licensed physician, 10 physician assistant, or advanced practice nurse attesting to 11 the permanent nature of the applicant's condition and verifying 12 that the applicant meets the physical qualifications specified 13 in this subsection (c-5).

Notwithstanding the requirements of this subsection (c-5), the Secretary shall issue a meter-exempt decal or device to:

16 (1) a person who has been issued registration plates 17 under Section 3-616 of this Code or a special decal or 18 device under this Section, if the applicant is the parent 19 or guardian of a person with disabilities who is under 18 20 years of age and incapable of driving; or.

(2) a person with a Type Three visual disability as
 defined in subsection (a) of Section 4A of the Illinois
 Identification Card Act if the applicant submits a
 statement from his or her ophthalmologist or optometrist
 certifying the applicant's visual disability.

26 (d) Replacement decals or devices may be issued for lost,

stolen, or destroyed decals upon application and payment of a \$10 fee. The replacement fee may be waived for individuals that have claimed and received a grant under the Senior Citizens and Disabled Persons Property Tax Relief Act.
