2 AMENDMENT NO. _____. Amend House Bill 6084, AS AMENDED,
3 by deleting everything after the enacting clause and
4 inserting the following:

5 "ARTICLE 1

6 Section 5. The following named amounts, or so much
7 thereof as may be necessary, respectively, for the objects
8 and purposes hereinafter named, are appropriated to meet the
9 ordinary and contingent expenses of the Illinois Criminal
10 Justice Information Authority:

17 Section 15. The sum of \$42,500,000, or so much thereof
 18 as may be necessary, is appropriated from the Criminal
 19 Justice Trust Fund to the Illinois Criminal Justice
 20 Information Authority for awards and grants to local units of
 21 government and non-profit organizations.

22 Section 20. The sum of \$15,000,000, or so much thereof

1 as may be necessary, is appropriated from the Criminal
 2 Justice Trust Fund to the Illinois Criminal Justice
 3 Information Authority for awards and grants to state
 4 agencies.

5 Section 25. The following named sums, or so much thereof
 6 as may be necessary, are appropriated to the Illinois
 7 Criminal Justice Information Authority for activities
 8 undertaken in support of federal assistance programs
 9 administered by units of state and local government and non-
 10 profit organizations:

11 Payable from the Criminal Justice
 12 Trust Fund.....5,800,000

13 Section 30. The following named amounts, or so much
 14 thereof as may be necessary, are appropriated to the Illinois
 15 Criminal Justice Information Authority for awards and grants
 16 and other monies received from federal agencies, from other
 17 units of government, and from private/not-for-profit
 18 organizations for activities undertaken in support of
 19 investigating issues in criminal justice and for undertaking
 20 other criminal justice information projects:

 4 develop Crime Stoppers programs in Illinois.

5 Section 45. The following named amounts, or so much
 6 thereof as may be necessary, respectively, for the objects
 7 and purposes hereinafter named, are appropriated to the
 8 Illinois Criminal Justice Information Authority for the
 9 training of law enforcement personnel and services for
 10 families of homicide or murder:

1 Section 50. The sum of \$150,000, or so much thereof as
 2 may be necessary, is appropriated from the Prescription Pill
 3 and Drug Disposal Fund to the Illinois Criminal Justice
 4 Information Authority for the purpose of collection,
 5 transportation, and incineration of pharmaceuticals by local
 6 law enforcement agencies.

7 Section 55. The following amounts, or so much thereof as
 8 may be necessary, respectively, are appropriated for the
 9 objects and purposes named, to meet the ordinary and
 10 contingent expenses of the Illinois Criminal Justice
 11 Information Authority:

3 Section 60. The sum of \$1,200,000, or so much thereof as
4 may be necessary, is appropriated from the ICJIA Violence
5 Prevention Fund to the Illinois Criminal Justice Information
6 Authority for the purpose of awarding grants under the
7 provisions of the Violence Prevention Act of 1995.

8 Section 65. The amount of \$528,300, or so much thereof
9 as may be necessary, is appropriated from the General Revenue
10 Fund to the Illinois Criminal Justice Information Authority
11 for the Illinois Family Violence Coordinating Council
12 Program.

13 Section 70. The amount of \$4,400,000, or so much thereof
14 as may be necessary, is appropriated from the General Revenue
15 Fund to the Illinois Criminal Justice Information Authority
16 for grants and administrative expenses related to Operation
17 CeaseFire.

18 Section 75. The amount of \$1,200,000, or so much thereof
19 as may be necessary, is appropriated from the General Revenue
20 Fund to the Illinois Criminal Justice Information Authority
21 for grants and administrative expenses for Franklin County

1 Juvenile Detention Center for Methamphetamine Pilot Program.

2 Section 80. The amount of \$100,000, or so much thereof
3 as may be necessary, is appropriated from the General Revenue
4 Fund to the Illinois Criminal Justice Information Authority
5 for a grant to the South Suburban Major Crimes Task Force.

6 Section 85. The amount of \$1,800,000, or so much thereof
7 as may be necessary, is appropriated from the General Revenue
8 Fund to the Illinois Criminal Justice Information Authority
9 for grants and administrative expenses related to Operation
10 CeaseFire for the following areas: Rockford, Springfield,
11 Peoria, Rock Island, South Suburban Cook County, and the
12 Metro East area including Belleville and Alton.

13 Section 90. The amount of \$650,000, or so much thereof
14 as may be necessary, is appropriated from the General Revenue
15 Fund to the Illinois Criminal Justice Information Authority
16 for all costs associated with Bullying Prevention.

17 Section 95. The amount of \$10,000,000, or so much
18 thereof as may be necessary, is appropriated from the General
19 Revenue Fund to the Illinois Criminal Justice Information
20 Authority for grants and administrative expenses associated
21 with before and after school programs.
