Amends the Metropolitan Water Reclamation District Act. Expands the corporate limits of the District. Effective immediately.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 4 Section 5. The Metropolitan Water Reclamation District Act
- is amended by adding Section 307 as follows:

- 9 limits of the Metropolitan Water Reclamation District of
