- Section 5. The Counties Code is amended by adding Section 5-1183 as follows:

- (a) Notwithstanding any other provision of law, a household 8 goods recycling bin in any county shall have a permanent, written, printed label affixed to the bin and prominently 10 displayed. The label shall include the name, address, and 11 12 contact information of the person or entity owning, operating, or maintaining that bin. The person or entity owning, 13 14 operating, or maintaining the bin shall also label the bin to designate if the person or entity owning, operating, or 15 maintaining the bin is a "not for profit" or a "for profit" 16

- 11 (a) Notwithstanding any other provision of law, a household goods recycling bin in any municipality shall have a permanent, 12 written, printed label affixed to the bin and prominently 13 14 displayed. The label shall include the name, address, and 15 contact information of the person or entity owning, operating, or maintaining that bin. The person or entity owning, 16 17 operating, or maintaining the bin shall also label the bin to designate if the person or entity owning, operating, or 18 maintaining the bin is a "not for profit" or a "for profit" 19 20 entity.
