A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named amounts, or so much
6 thereof as may be necessary, respectively, are appropriated
7 for the objects and purposes hereinafter named, to meet the
8 ordinary and contingent expenses of the Historic Preservation
9 Agency:

4 may be necessary, is appropriated from the Illinois Historic
5 Sites Fund to the Historic Preservation Agency for awards and
6 grants for historic preservation programs made either
7 independently or in cooperation with the Federal Government
8 or any agency thereof, any municipal corporation, or
9 political subdivision of the State, or with any public or
10 private corporation, organization, or individual.

11 Section 25. The sum of \$312,227, or so much thereof as
12 may be necessary and remains unexpended at the close of
13 business on June 30, 2014, from appropriations heretofore
14 made for such purpose in Article 23, Sections 30 and 35 of
15 Public Act 98-0064, is reappropriated from the Illinois
16 Historic Sites Fund to the Historic Preservation Agency for
17 awards and grants for historic preservation programs made
18 either independently or in cooperation with the Federal
19 Government or any agency thereof, any municipal corporation,
20 or political subdivision of the State, or with any public or
21 private corporation, organization, or individual.

22 Section 30. The sum of \$150,000, or so much thereof as

1 may be necessary, is appropriated from the Historic Property
 2 Administrative Fund to the Historic Preservation Agency for
 3 administrative expenses associated with the Historic Tax
 4 Credit Program.

5 Section 35. The following named sums, or so much thereof
 6 as may be necessary, respectively, for the objects and
 7 purposes hereinafter named, are appropriated to meet the
 8 ordinary and contingent expenses of the Historic Preservation
 9 Agency:

 23 Sites Fund to the Historic Preservation Agency for the

1 ordinary and contingent expenses of the Administrative
 2 Services division for costs associated with but not limited
 3 to Union Station, the Old State Capitol and the Old Journal
 4 Register Building.

5 Section 45. The following named sums, or so much thereof
 6 as may be necessary, respectively, for the objects and
 7 purposes hereinafter named, are appropriated to meet the
 8 ordinary and contingent expenses of the Historic Preservation
 9 Agency:

9 special events, and all other costs related to the operation
10 of Illinois Historic Sites and only to the extent which
11 donations are received at Illinois State Historic Sites.

12 Section 65. The following named sums, or so much thereof
13 as may be necessary, respectively, for the objects and
14 purposes hereinafter named, are appropriated to meet the
15 ordinary and contingent expenses of the Historic Preservation
16 Agency:
