1 AMENDMENT TO HOUSE BILL 2811

2 AMENDMENT NO. _____. Amend House Bill 2811 by replacing
3 everything after the enacting clause with the following:

4 "Section 5. The Illinois Vehicle Code is amended by
5 changing Section 3-806.3 as follows:

6 (625 ILCS 5/3-806.3) (from Ch. 95 1/2, par. 3-806.3)

7 Sec. 3-806.3. Senior Citizens. Commencing with the 2009
8 registration year, the registration fee paid by any vehicle
9 owner who has been approved for benefits under the Senior
10 Citizens and Disabled Persons Property Tax Relief Act or who is
11 the spouse of such a person shall be \$24 instead of the fee
12 otherwise provided in this Code for passenger cars displaying
13 standard multi-year registration plates issued under Section
14 3-414.1, motor vehicles displaying special registration plates
15 issued under Section 3-609, 3-616, 3-621, 3-622, 3-623, 3-624,
16 3-625, 3-626, 3-628, 3-638, 3-642, 3-645, 3-647, 3-650, 3-651,

1 or 3-663, motor vehicles registered at 8,000 pounds or less
2 under Section 3-815(a), and recreational vehicles registered
3 at 8,000 pounds or less under Section 3-815(b). Widows and
4 widowers of claimants shall also be entitled to this reduced
5 registration fee for the registration year in which the
6 claimant was eligible.

7 Commencing with the 2009 registration year, the
8 registration fee paid by any vehicle owner who has claimed and
9 received a grant under the Senior Citizens and Disabled Persons
10 Property Tax Relief Act or who is the spouse of such a person
11 shall be \$24 instead of the fee otherwise provided in this Code
12 for passenger cars displaying standard multi-year registration
13 plates issued under Section 3-414.1, motor vehicles displaying
14 special registration plates issued under Section 3-607, 3-609,
15 3-616, 3-621, 3-622, 3-623, 3-624, 3-625, 3-626, 3-628, 3-638,
16 3-642, 3-645, 3-647, 3-650, 3-651, 3-663, or 3-664, motor
17 vehicles registered at 8,000 pounds or less under Section
18 3-815(a), and recreational vehicles registered at 8,000 pounds
19 or less under Section 3-815(b). Widows and widowers of
20 claimants shall also be entitled to this reduced registration
21 fee for the registration year in which the claimant was
22 eligible.

23 Commencing with the 2017 registration year, the reduced fee
24 under this Section shall apply to any special registration
25 plate authorized in Article VI of Chapter 3 of this Code, for
26 which the applicant would otherwise be eligible.

1 No more than one reduced registration fee under this
2 Section shall be allowed during any 12 month period based on
3 the primary eligibility of any individual, whether such reduced
4 registration fee is allowed to the individual or to the spouse,
5 widow or widower of such individual. This Section does not
6 apply to the fee paid in addition to the registration fee for
7 motor vehicles displaying vanity, personalized, or special
8 license plates.
