SYNOPSIS AS INTRODUCED:

625 ILCS 5/3-806 from Ch. 95 1/2, par. 3-806 625 ILCS 5/3-806.7a new

Amends the Illinois Vehicle Code. Provides that beginning with the 2017 registration year, the vehicle registration fee for an honorably discharged veteran who has a specified military license plate on his or her vehicle shall be reduced to \$76. Provides that the vehicle registration fee for an honorably discharged combat veteran who has a specified military license plate on his or her vehicle shall be reduced to \$26.

AN ACT concerning transportation.

Be it enacted by the People of the State of Illinois, 2 represented in the General Assembly: 3

Section 5. The Illinois Vehicle Code is amended by changing 4 5 3-806 and adding Section 3-806.7a as follows:

(625 ILCS 5/3-806) (from Ch. 95 1/2, par. 3-806) 6

7 Sec. 3-806. Registration Fees; Motor Vehicles of the First Division. Every owner of any other motor vehicle of the first 8 9 division, except as provided in Sections 3-804, 3-804.01, 3-804.3, 3-805, 3-806.3, 3-806.7, 3-806.7a, and 3-808, and 10 every second division vehicle weighing 8,000 pounds or less, 11 shall pay the Secretary of State an annual registration fee at 12 13 the following rates:

3 Cycles and Pedalcycles

A \$1 surcharge shall be collected in addition to the above fees for motor vehicles of the first division, autocycles, motorcycles, motor driven cycles, and pedalcycles to be deposited into the State Police Vehicle Fund.

8 All of the proceeds of the additional fees imposed by 9 Public Act 96-34 shall be deposited into the Capital Projects 10 Fund.

A \$2 surcharge shall be collected in addition to the above 11 12 fees for motor vehicles of the first division, autocycles, motorcycles, motor driven cycles, and pedalcycles to be 13 deposited into the Park and Conservation Fund for the 14 Department of Natural Resources to use for conservation 15 16 efforts. The monies deposited into the Park and Conservation 17 Fund under this Section shall not be subject to administrative 18 charges or chargebacks unless otherwise authorized by this Act.
