1 AMENDMENT TO SENATE BILL 575

2 AMENDMENT NO. _____. Amend Senate Bill 575 by replacing
3 everything after the enacting clause with the following:

4 "Section 5. The University of Illinois Act is amended by
5 adding Section 90 as follows:

6 (110 ILCS 305/90 new)

7 Sec. 90. MAP funding; prohibitions. The University may not
8 prohibit a student from registering for classes or refuse to
9 issue a student transcript based solely on the fact that the
10 student was awarded a Monetary Award Program grant under
11 Section 35 of the Higher Education Student Assistance Act for
12 Fiscal Year 2016, but the student did not receive that grant
13 because no funds were appropriated for grant awards. The
14 provisions of this Section, other than this sentence, are
15 inoperative if funds are appropriated from the General Revenue
16 Fund to the Illinois Student Assistance Commission for Fiscal

1 Year 2016 Monetary Award Program grant awards.

2 Section 10. The Southern Illinois University Management
3 Act is amended by adding Section 75 as follows:

4 (110 ILCS 520/75 new)

5 Sec. 75. MAP funding; prohibitions. The University may not
6 prohibit a student from registering for classes or refuse to
7 issue a student transcript based solely on the fact that the
8 student was awarded a Monetary Award Program grant under
9 Section 35 of the Higher Education Student Assistance Act for
10 Fiscal Year 2016, but the student did not receive that grant
11 because no funds were appropriated for grant awards. The
12 provisions of this Section, other than this sentence, are
13 inoperative if funds are appropriated from the General Revenue
14 Fund to the Illinois Student Assistance Commission for Fiscal
15 Year 2016 Monetary Award Program grant awards.

16 Section 15. The Chicago State University Law is amended by
17 adding Section 5-185 as follows:

18 (110 ILCS 660/5-185 new)

19 Sec. 5-185. MAP funding; prohibitions. The University may
20 not prohibit a student from registering for classes or refuse
21 to issue a student transcript based solely on the fact that the
22 student was awarded a Monetary Award Program grant under

1 Section 35 of the Higher Education Student Assistance Act for
2 Fiscal Year 2016, but the student did not receive that grant
3 because no funds were appropriated for grant awards. The
4 provisions of this Section, other than this sentence, are
5 inoperative if funds are appropriated from the General Revenue
6 Fund to the Illinois Student Assistance Commission for Fiscal
7 Year 2016 Monetary Award Program grant awards.

8 Section 20. The Eastern Illinois University Law is amended
9 by adding Section 10-185 as follows:

10 (110 ILCS 665/10-185 new)

11 Sec. 10-185. MAP funding; prohibitions. The University may
12 not prohibit a student from registering for classes or refuse
13 to issue a student transcript based solely on the fact that the
14 student was awarded a Monetary Award Program grant under
15 Section 35 of the Higher Education Student Assistance Act for
16 Fiscal Year 2016, but the student did not receive that grant
17 because no funds were appropriated for grant awards. The
18 provisions of this Section, other than this sentence, are
19 inoperative if funds are appropriated from the General Revenue
20 Fund to the Illinois Student Assistance Commission for Fiscal
21 Year 2016 Monetary Award Program grant awards.

22 Section 25. The Governors State University Law is amended
23 by adding Section 15-185 as follows:

1 (110 ILCS 670/15-185 new)

2 Sec. 15-185. MAP funding; prohibitions. The University may
3 not prohibit a student from registering for classes or refuse
4 to issue a student transcript based solely on the fact that the
5 student was awarded a Monetary Award Program grant under
6 Section 35 of the Higher Education Student Assistance Act for
7 Fiscal Year 2016, but the student did not receive that grant
8 because no funds were appropriated for grant awards. The
9 provisions of this Section, other than this sentence, are
10 inoperative if funds are appropriated from the General Revenue
11 Fund to the Illinois Student Assistance Commission for Fiscal
12 Year 2016 Monetary Award Program grant awards.

13 Section 30. The Illinois State University Law is amended by
14 adding Section 20-190 as follows:

15 (110 ILCS 675/20-190 new)

16 Sec. 20-190. MAP funding; prohibitions. The University may
17 not prohibit a student from registering for classes or refuse
18 to issue a student transcript based solely on the fact that the
19 student was awarded a Monetary Award Program grant under
20 Section 35 of the Higher Education Student Assistance Act for
21 Fiscal Year 2016, but the student did not receive that grant
22 because no funds were appropriated for grant awards. The
23 provisions of this Section, other than this sentence, are

1 inoperative if funds are appropriated from the General Revenue
2 Fund to the Illinois Student Assistance Commission for Fiscal
3 Year 2016 Monetary Award Program grant awards.

4 Section 35. The Northeastern Illinois University Law is
5 amended by adding Section 25-185 as follows:

6 (110 ILCS 680/25-185 new)

7 Sec. 25-185. MAP funding; prohibitions. The University may
8 not prohibit a student from registering for classes or refuse
9 to issue a student transcript based solely on the fact that the
10 student was awarded a Monetary Award Program grant under
11 Section 35 of the Higher Education Student Assistance Act for
12 Fiscal Year 2016, but the student did not receive that grant
13 because no funds were appropriated for grant awards. The
14 provisions of this Section, other than this sentence, are
15 inoperative if funds are appropriated from the General Revenue
16 Fund to the Illinois Student Assistance Commission for Fiscal
17 Year 2016 Monetary Award Program grant awards.

18 Section 40. The Northern Illinois University Law is amended
19 by adding Section 30-195 as follows:

20 (110 ILCS 685/30-195 new)

21 Sec. 30-195. MAP funding; prohibitions. The University may
22 not prohibit a student from registering for classes or refuse

1 to issue a student transcript based solely on the fact that the
2 student was awarded a Monetary Award Program grant under
3 Section 35 of the Higher Education Student Assistance Act for
4 Fiscal Year 2016, but the student did not receive that grant
5 because no funds were appropriated for grant awards. The
6 provisions of this Section, other than this sentence, are
7 inoperative if funds are appropriated from the General Revenue
8 Fund to the Illinois Student Assistance Commission for Fiscal
9 Year 2016 Monetary Award Program grant awards.

10 Section 45. The Western Illinois University Law is amended
11 by adding Section 35-190 as follows:

12 (110 ILCS 690/35-190 new)

13 Sec. 35-190. MAP funding; prohibitions. The University may
14 not prohibit a student from registering for classes or refuse
15 to issue a student transcript based solely on the fact that the
16 student was awarded a Monetary Award Program grant under
17 Section 35 of the Higher Education Student Assistance Act for
18 Fiscal Year 2016, but the student did not receive that grant
19 because no funds were appropriated for grant awards. The
20 provisions of this Section, other than this sentence, are
21 inoperative if funds are appropriated from the General Revenue
22 Fund to the Illinois Student Assistance Commission for Fiscal
23 Year 2016 Monetary Award Program grant awards.

1 Section 50. The Public Community College Act is amended by
2 adding Section 3-29.11 as follows:

3 (110 ILCS 805/3-29.11 new)

4 Sec. 3-29.11. MAP funding; prohibitions. A community
5 college district may not prohibit a student from registering
6 for classes or refuse to issue a student transcript based
7 solely on the fact that the student was awarded a Monetary
8 Award Program grant under Section 35 of the Higher Education
9 Student Assistance Act for Fiscal Year 2016, but the student
10 did not receive that grant because no funds were appropriated
11 for grant awards. The provisions of this Section, other than
12 this sentence, are inoperative if funds are appropriated from
13 the General Revenue Fund to the Illinois Student Assistance
14 Commission for Fiscal Year 2016 Monetary Award Program grant
15 awards.

16 Section 99. Effective date. This Act takes effect upon
17 becoming law."
