8	Sec. 2-3.64c. Assessment Review Task Force. The State
9	Superintendent of Education shall appoint a task force to
10	review standardized assessments. The task force shall consist
11	of all of the following individuals:
12	(1) Two parents.
13	(2) One educator representing a statewide professional
14	teachers' organization.
15	(3) One educator representing a different statewide
16	professional teachers' organization.

1 (4) One educator representing a professional teachers' organization in a city having a population exceeding 2 500,000. 3 (5) One early childhood educator. 4 5 (6) One school district administrator representing an association representing school administrators. 6 (7) One school principal representing an association 7 8 representing school principals. (8) One school district board member representing an 9 10 association representing school board members. 11 (9) One early childhood center administrator. (10) One assessment expert. 12 13 (11) One representative of the State Board of Education. 14 15 (12) One representative of regional superintendents of 16 schools. (13) One representative of a 4-year institution of 17 18 higher education. 19 (14) One representative of a 2-year institution of 20 higher education. (15) One citizen who is a resident of this State. 21 22 (16)One representative from an organization 23 representing high school districts. 24 (17) One bilingual education educator. 25 (18) One school principal representing an association 26 representing school principals in a city having a 09900SB1340ham001

1 population exceeding 500,000. (19) One special education administrator of a school 2 district. 3 4 The task force shall also consist of the following members 5 appointed as follows: (A) One member of the Senate appointed by the President 6 7 of the Senate. 8 (B) One member of the Senate appointed by the Minority 9 Leader of the Senate. 10 (C) One member of the House of Representatives 11 appointed by the Speaker of the House of Representatives. One member of the House of 12 (D) Representatives 13 appointed by the Minority Leader of the House of 14 Representatives. 15 The State Superintendent shall appoint one of the task 16 force members as chairperson of the task force. The task force shall meet at least 4 times to review standardized assessments. 17 18 This review shall include at least 5% of school districts in 19 this State that represent a regionally equal sampling selected 20 from among those counties of this State other than Cook County 21 and the 5 counties contiguous to Cook County and shall include 22 a school district located in a city having a population over 23 500,000. 1 perceptions of the level and intensity of standardized 2 assessments; and any other issues involving standardized 3 assessments identified by the task force. The State Board of 4 Education shall provide administrative support to the task 5 force.

6 The task force shall report its findings to the Governor 7 and General Assembly no later than <u>December</u> May 31, 2015, and, 8 upon filing its report, the task force is dissolved. This 9 Section is repealed on <u>January 1, 2016</u> <del>June 1, 2015</del>.
